## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of RAPT 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RAPT 401(K) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of Plan

The following description of the RAPT (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available for salary deferrals, employer matching, and profit sharing contributions to all employees of the Company who have completed 3 consecutive months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974(ERISA).

Contributions

Participants may contribute up to the maximum allowable amount as determined by the Federal Government each year of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a number of pooled separate accounts as investment options for participants. The Company's contribution to the Plan is discretionary. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors and are allocated to employee accounts based on the annual compensation of participants and is invested in the same manner as employee contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings and (c) profit sharing contributions made at the discretion of the Company's board of directors, and charged with an allocation of administrative expenses. Profit sharing allocations are based on the relationship of the participant's compensation to the total compensation for all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. For the year ended December 31, 2024, the Company's contribution was 100% of participant deferrals up to a maximum of 4%.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon and rollover contributions. Participants are vested immediately in the Company's nonelective profit sharing contributions and matching contributions.

Notes Receivable from Participants

Participants may acquire loans on the vested portion of their account balances. The loan minimum is \$1,000 and cannot exceed the lesser of \$50,000 or 50% of the vested amount. Participants may have no more than 1 outstanding loan at any one time. The maximum loan term is five years, unless the loan is for the purchase of a principal residence. Principal and interest are paid ratably through bi-weekly payroll deductions. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25 to 9.50%, which is commensurate with prevailing rates. Loans are considered delinquent if payments are not made at the end of the first quarter following the quarter in which the payment is due.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's interest in his or her account, or, if permitted under the Plan at the time of distribution, an alternative form of payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service and hardship withdrawals are also allowed as defined in the Plan agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,976 and \$1,949, respectively. These accounts will be used to reduce future employer contributions and pay plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual method of accounting in accordance with generally accepted accounting principles.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when they are incurred. Loans are considered delinquent if payments are not made at the end of the first quarter following the quarter in which the payment is due. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Non-participant Directed Investments

The Plan did not have any non-participant directed investments for the years ended December 31, 2024 and 2023.

Note 4 – Stable Value Option with Insurance Company

In 1998, the Plan entered into a benefit-responsive stable value option with Transamerica Life Insurance Company. Transamerica Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value which is the

same as contract value as reported to the plan by Transamerica Life Insurance Company. Fair Value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the stable value option is fully benefit-responsive, fair value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Fair value, as reported to the plan by Transamerica Life Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against fair value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 was \$98,218. There is no guaranteed minimum or maximum interest rate under contract.

Certain events limit the Plan's ability to transact at fair value with the issuer. Such events include the following: (a) failure by the Plan to provide any information required by Transamerica Life Insurance Company, and such failure is not remedied within 31 days from the date Transamerica Life Insurance Company notified the Plan thereof; (b) amendments of the plan documents that adversely affect Transamerica Life Insurance Company obligations under the contract; (c) failure to amend, change or alter all contracts due to changes in the state or federal laws and regulation; (d) the assets held are less than the amount or number required for the contract to be considered a Group Annuity Contract in the state in which the Contract is used; (e) the Plan is changed such that the organization or entity would no longer be considered an eligible sponsoring organization for this type of contract; (f) the Plan fails to meet the requirements for qualification under the Internal Revenue Code and/or and other applicable state or federal law, or the trust fails to remain tax-exempt under Section 501(c) of the Internal Revenue Code; or (g) if at any time contributions or balances are less than the amount required for the class of business under Transamerica Life Insurance Company's underwriting standards in effect as of the contract effective date. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Note 5 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- i. Quoted prices for similar assets or liabilities in active markets;

- ii. Quoted prices for identical or similar assets or liabilities in inactive markets;
  - iii. Inputs other than quoted prices that are observable for the asset or liability;
  - iv. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

**Stable Value Option:** Fair value is the amount plan participants or plan sponsors would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity (some investments allow withdrawals without penalty for death, disability, termination or retirement).

**Pooled Separate Accounts:** Pooled separate accounts invest in a variety of individual stocks, mutual funds, and short term securities such as commercial paper. The fair value of the pooled separate accounts are based on the fair value of the underlying investment, which are based on publicly quoted pricing inputs or observable pricing inputs including quoted prices for similar assets in active or non-active markets.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 8 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan provides for various investment options in any combination of registered investment companies and common/collective trust funds. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 10 – Custodial Certification

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and 2023, and investment increase for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Life Insurance Company (the custodian of the Plan).
