We have performed an audit of the financial statements of White House Motel Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

General

The following description of the White House Motel Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, including vesting and benefit provisions.

The Plan is a tax-exempt defined contribution plan covering substantially all employees of the White House Motel and certain affiliates (the Companies). The Plan prototype obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to the maximum percentage of compensation and dollar amount permissible under Sections 402(g) and 414(v) of the Code, not to exceed the limits of the Code Sections 401(k), 404, and 415. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are always 100% vested in their salary deferral contributions. Employer contributions are subject to a 6-year graded vesting schedule.

The amount contributed annually by the employer includes:

1. A discretionary employer match. During 2024, the discretionary employer match was 100% of eligible compensation up to \$150.
2. A discretionary amount determined by the employer allocated in the same proportion that each participant's compensation for the year bears to total compensation for all participants.

Contributions are subject to certain limitations.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The Plan has an investment in the Federated Hermes Capital Preservation Fund, a common collective trust. The investment objective of the Federated Hermes Capital Preservation Fund is stability of principal and high current income. Withdrawals from the Federated Hermes Capital Preservation Fund are permitted at any time by participants for benefit payments, transfer of investment elections, and payment of trustee fees. All other participant redemptions are subject to a 12-month advance written notice requirement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Companies. Administrative expenses paid by the Plan totaled \$34,922 and were paid to the Plan recordkeeper and Plan investment advisor, therefore, these transactions qualify as party-in-interest transactions. The Companies paid administrative expenses totaling \$11,285 related to administration of the Plan.

Subsequent Events

Management has considered transactions or events occurring through October 8, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Certified by Trustee

Information included in the financial statements and supplemental schedule relating to investments, investment income, and net appreciation in fair value of investments was obtained by management and agreed to or derived from information submitted to the plan administrator and certified to be complete and accurate by the trustee. 4. Party-in-Interest Transactions

Plan investments include money market funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee and, therefore, these transactions qualify as party-in-interest transactions.

5. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability; and
Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds and money market funds: Valued at the quoted net asset value (NAV) of units held by the Plan at year-end.

Common collective trust: Valued daily based on the established NAV per unit of \$10.00 as a practical expedient. The fund attempts to maintain a stable price per unit of \$10.00; however, there can be no assurance that the value of the units in the fund will not fluctuate. The principal value per unit of the fund is determined at the end of each day by dividing net assets by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
