As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the EGA 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees, except for non-resident aliens, of Evergreen Shipping Agency (America) Corporation (the “Company”) who have completed one year of service, are twenty-one years of age or older and have no other U.S. source income and are not covered by a collective bargaining agreement except those employees represented by Local 1964 ILA AFL-CIO. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 1, 2024, a Plan-to-Plan transfer was carried out in accordance with the recent contract negotiation agreement between the Company and the I.L.W.U. Local 63 Union. Accordingly, \$3,122,689 of Plan assets were transferred out of the Plan during the year ended December 31, 2024.

Contributions

Each year, participants may contribute from 1% to 80% of their pre-tax annual compensation, as defined in the Plan Document, provided that such contributions do not exceed the maximum annual amount permitted under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers one common/collective trust and twenty-six mutual funds as investment options for participants. Effective January 1, 2024, the Plan permits Roth contributions; however, a formal plan amendment to document this change has not yet been executed.

Eligible employees will be automatically enrolled in the Plan at a rate of 5% of their eligible compensation, unless they affirmatively elect otherwise within the reasonable period established by the Plan administrator.

The Company provides a fixed matching contribution of 100% of a participant’s elective deferral not to exceed 5% of eligible base compensation. The Company may also make a discretionary nonelective contribution for participants who were employed on the last day of the Plan year and worked at least 1,000 hours. For the year ended December 31 2024, no discretionary nonelective contributions were made to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (*continued*)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus actual earnings thereon is based on years of continuous service. Participants are vested in their account balances in accordance with a graded schedule and become 100% vested after completing six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, subject to certain limitations, as defined by the Plan Document. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions over the term of the loans, not to exceed 5 years for general purpose loans and 20 years for principal residence loans. A participant may not have more than two outstanding loans from the Plan at any time.

Payment of Benefits

Upon termination of service due to death, disability, termination or retirement, or attaining the age of 59 ½ a participant or designated beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, partial withdrawal, installment payments or in annual installments over a specified period of time, not exceeding the participant's life expectancy or the joint life expectancy of the participant and his or her designated beneficiary. Benefits can also be distributed in the event of the participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,588 and \$324. In 2024, \$9,700 of forfeitures was used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Plan Holding Account

The Plan and Empower Trust Company, LLC (the “trustee”) have entered into a revenue sharing arrangement whereby a portion of the revenue earned by the trustee from certain funds is credited quarterly to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing agreement, and to use this credit to pay Plan expenses, the Company uses a Plan Holding Account. The Plan Holding Account is an asset account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Plan Holding Account totaled \$267,369 and \$182,659 at December 31, 2024 and 2023. During 2024, \$161,218 of Plan expenses were paid from this account.

Basis of Accounting and Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value based on quoted market prices except for the investment in a common/collective trust which is reported at the NAV of units held by the Plan. Shares of mutual funds are reported at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The Putnam Stable Value Fund invests primarily in guaranteed and security-backed investment contracts with life insurance companies, banks, and other financial institutions. Underlying investments of the target date collective trust funds consist of fixed income and mixed-asset equities. The common/collective trust fund provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable event occurs.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The majority of administrative expenses are paid by the Plan. Any administrative expenses not paid with Plan assets are paid by the Company and excluded from the financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in financial statements through the date that the financial statements were available to be issued, which date is September 15, 2025.

5. Common/Collective Trust

The Putnam Stable Value Fund (the "Fund") is a stable value fund that is a common/collective trust. The Fund may invest in fixed interest insurance investment contracts, money market funds, corporate and government bonds, mortgage-backed securities, bond funds, and other fixed income securities. The unit value of this Fund is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. Subject to certain limitations, withdrawals from the Fund are generally permitted daily. At December 31, 2024 and 2023 there were no unfunded commitments.

6. Related Party and Party-in-Interest Transactions

The Plan received a servicing credit of \$394,570 during the year ended December 31, 2024 as part of their revenue sharing agreement between the Company and the trustee of the Plan. This credit represents a return of fees that were above what the Plan administrator and the record-keeper needed to cover Plan expenses. The Plan's administrative expenses are funded by the revenue sharing agreement. These transactions are considered party-in-interest transactions. The Plan's financial consulting service provider, has received payments under this agreement totaling \$308,487 for 2024. These amounts are included in other income and administrative expenses in the statement of changes in net assets available for benefits.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

8. Income Tax Status *(continued)*

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
