Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Retirement Savings 403(b) Plan for Employees of Presbyterian Homes (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Retirement Savings 403(b) Plan for Employees of Presbyterian Homes (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Presbyterian Homes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following participating employers are included under the Plan's provisions: Westminster Place; Presbyterian Homes Manager, LLC; Lake Forest Place, LLC; Ten Twenty Grove, LLC; and The Moorings of Arlington Heights, LLC (collectively, the "Employer").

Eligibility

All employees of the Employer are eligible to make salary deferrals immediately upon employment. Employees become eligible for the Employer's contributions in the first calendar quarter following completion of one year of service, as defined by the Plan, and attainment of age 21.

Contributions

The Plan provides for employee salary 403(b) compensation deferrals up to the maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Effective January 1, 2022, the Plan was amended to remove the previous employer matching contribution of 50 percent of the participant's contribution, not to exceed 3 percent of the employee's compensation, and safe harbor nonelective contributions of 3 percent of the employee's compensation, regardless of whether the employee had an elective deferral. Subsequently, the Plan provides for a safe harbor employer match formula of 100 percent on the first 3 percent of the participant's eligible compensation and 50 percent on the next 2 percent of the participant's eligible compensation.

The Employer may make an annual nonelective discretionary contribution. Participants who are employed on the last day of the plan year will be eligible to receive an allocation of the Employer's nonelective discretionary contribution. Nonelective discretionary contributions for the years ended December 31, 2024 and 2023 totaled \$671,814 and \$840,365, respectively.

All newly eligible employees and active employees with no election on file are automatically enrolled at a pretax deferral contribution of 6 percent unless the employee chooses to elect otherwise. This automatic deferral will increase 1 percent annually (on November 1) until a maximum contribution of 10 percent is reached.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 but may not exceed 50 percent of their vested account balances. Notes receivable are collateralized by the participant's account balance and bear interest at the prime rate plus 1 percent.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and plan earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in their salary deferral and rollover contributions and the Employer's safe harbor nonelective and safe harbor matching contributions plus any income or loss thereon. Effective January 1, 2022, employees are vested in the Employer's nonelective discretionary contribution after three years of service. Prior to January 1, 2022, participants were vested in the Employer's match contribution after three years of service. Participants also become fully vested in the Employer's matching contributions upon reaching normal retirement age, death, or permanent disability.

Benefit Payments

On termination of service due to death, disability, retirement, or termination of employment, a participant or the participant's beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by T. Rowe Price Trust Company (T. Rowe Price) and Lincoln National Life Insurance Company (Lincoln) or its affiliates. T. Rowe Price and Lincoln are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded upon distribution.

Administrative Expenses

Certain administrative expenses of maintaining the Plan may be paid directly by the Employer and are excluded from these financial statements. Record-keeping service fees and fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants' accounts and are included in administrative expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certification of Investment Information

T. Rowe Price holds majority of the Plan's investments and participant notes receivable and executes all related transactions. One of the Plan's investments is held and certified by Lincoln National Life Insurance Company (Lincoln). The investments and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by T. Rowe Price and Lincoln.

Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated August 2, 2017. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

December 31, 2024 and 2023

Note 5 - Fair Value Measurements (Continued)

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs, as described above.

Note 6 - Investment Contract

The Plan has a benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 1 percent. When establishing interest crediting rates for this product, Lincoln considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
