**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of FamilyCare Medical Group, P.C. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### NOTE A--DESCRIPTION OF THE PLAN

The following description of the FamilyCare Medical Group, P.C. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution profit sharing trust with 401(k) provisions covering substantially all eligible employees of FamilyCare Medical Group, P.C., Practice Resources, LLC, and David Barletta (collectively referred to as the Company). Employees of the Company are eligible to participate in the Plan if they have completed one hour of service. An employee is eligible to participate in the elective deferral feature of the Plan on the date the employee meets the eligibility requirement.

To become eligible to participate in Company safe harbor matching contributions (as defined in the Plan agreement), an employee must have made elective deferral contributions to the Plan. To become eligible to participate in the Company's discretionary profit sharing contribution, an employee must be employed on the last day of the Plan year and have completed 1,000 hours of service during the plan year. The Plan is subject to the provisions of ERISA. The Plan's trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions: Participants may contribute tax-deferred and after-tax Roth dollars through payroll deductions, up to the maximum in any calendar year as set forth in the Internal Revenue Code (IRC). Current tax law limits each participant's total pretax and Roth deferrals to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Additionally, if a participant has or is projected to attain age 50 before the end of the Plan year, that participant may make "catch-up" contributions as determined by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct their contributions into various investment options offered by the Plan. Contributions are subject to certain individual account and aggregate Plan limitations as determined by the IRS.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation until changed by the participant. Effective January 1, 2023, for new participants, the participant's default elective contribution shall be increased each plan year by one percentage point, up to a maximum default elective contribution equal to 15% of their compensation.

The Plan requires the Plan sponsor to make a safe harbor matching contribution equal to 100% of an employee's elective deferrals for the year, up to 4% of the employee's eligible compensation. The Company's matching contributions totaled \$1,899,215 and \$1,736,603 for the years ended December 31, 2024 and 2023, respectively.

Contributions--Continued: The Board of Directors may also elect to contribute a discretionary profit sharing contribution for all eligible participants. Furthermore, each separate participating employer and separate profit center of the employers has the right to determine its own rate of profit sharing contributions, if any. In 2024 and 2023, the Company's discretionary profit sharing contribution was \$973,210 and \$957,685, respectively.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of Company contributions and Plan earnings or losses. Earnings and losses are allocated based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their elective deferral and safe harbor matching contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary profit sharing contributions and the earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service (20% vesting annually, starting in the second year of continuous service).

Receivables--Notes from Participants: Active participants may borrow from their vested account balance a minimum of \$1,000 with the maximum amount being the lesser of 50% of the vested account balance or \$50,000 reduced by the highest outstanding loan balance at any time in the preceding 12 months. Terms of the loans require repayment over a period not extending beyond five years from the date of the loan. The loans are secured by the balance in the participant's vested account and bear interest at the prime rate. Principal and interest are paid in equal installments through payroll deductions. Loans will only be granted/allowed in the event of a financial hardship. Participants may only have one loan outstanding at any time and loans may only be requested no more frequently than once each plan year.

Payment of Benefits: Upon termination of service, including termination due to death, disability or retirement, the Plan allows for a lump-sum cash distribution, a direct rollover distribution, or a combination of both equal to the value of the participant's vested interest in his or her account. A participant of at least 59 ½ years of age may also be eligible to receive in-service distributions subject to other requirements. If a participant's vested account balance is between \$1,000 and \$5,000, and the participant fails to make a distribution election, a lump-sum amount will be rolled over to an individual retirement account without their consent. If a participant's vested account balance is \$1,000 or less, and the participant fails to make a distribution election, a lump-sum amount will be paid to the participant without their consent.

Forfeitures: Participants that have terminated employment and who were not fully vested in the employer contributions forfeit the non-vested portion of the employer contribution. Forfeitures are available to reduce subsequent Company profit sharing contributions or to offset Plan administrative expenses. Forfeitures being held to reduce future employer contributions totaled \$-0- in 2024 and 2023.



## NOTE B--SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Interest-bearing cash, shares in registered investment companies, and the stable value fund are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note D for discussion of fair value measurements. The Plan's investments in the insurance company general account are reported at contract value (see Note E).

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments are participant-directed.

Receivables--Notes from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are accrued. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Employer Contributions Receivable: Employer contributions receivable are presented in the statements of net assets available for benefits net of any allowance for credit losses. The Plan Administrator believes that no allowance for credit losses is necessary at December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. The Company can also elect to pay certain administrative fees from forfeited nonvested accounts which are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Events Occurring After Reporting Date: Plan management has evaluated events and transactions that occurred between December 31, 2024 and October 6, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. There were no such events or transactions identified by Plan management.

NOTE C--INFORMATION CERTIFIED AND PROVIDED BY CUSTODIAN (UNAUDITED)

The following is a summary of the Plan's asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the assets below is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, "Fair Value Measurements and Disclosures", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D--FAIR VALUE MEASUREMENTS--Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Interest-bearing cash: The fair value of interest-bearing cash approximates carrying value due to the nature of the instrument.

Shares in registered investment companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares in registered investment companies held by the Plan are deemed to be actively traded.

Stable value fund: Valued at the net asset value (NAV) of units of the stable value fund. The NAV, as provided by the Fund custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the Fund custodian reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE E--INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's investment contract with Voya is fully benefit-responsive. Voya maintains the contributions in a general account which is credited with earnings and losses on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) certain amendments to a plan document (including complete or partial plan termination or merger with another plan), (2) changes to plan prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, has occurred or is probable.

NOTE F--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan has not considered Company contributions to the Plan or benefits paid by the Plan to participants as party in interest transactions. Certain Plan investments are shares held in registered investment companies managed by Voya. Voya is the custodian, as defined by the Plan and, therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules.

The Company directly pays any other substantial fees related to the Plan's operations. Fees for compliance, recordkeeping, and auditing services are paid directly by the Company and also qualify as party in interest transactions.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company discretionary profit sharing contributions, in accordance with IRS guidelines.

NOTE H--TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Scolaro Fetter Grizanti & McGough, P.C. The prototype plan provider has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE I--RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's Statements of Net Assets Available for Benefits.
