Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the EGA Money Purchase Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the EGA Money Purchase Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was established on July 1, 1997 and is a defined contribution plan covering all full-time employees, except for non-resident aliens, of Evergreen Shipping Agency (America) Corporation (the “Company”) who have completed one year of service, are twenty-one years of age or older, and who are not covered by a collective bargaining agreement except those employees represented by Local 1964 ILA AFL-CIO. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Company contributes 10% of eligible employees’ annual eligible compensation, as defined in the Plan Document. In order to receive the Company contribution, the eligible employee must be employed on the last day of the year. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers one common/collective trust and twenty-six mutual funds as investment options for participants.

Participants Accounts

Each participant’s account is credited with the Company’s contributions and earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested in their account balances in accordance with a graded schedule and become 100% vested after completing six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, termination or retirement, a participant or designated beneficiary may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount, partial withdrawal, installment payments or in annual installments over a specified period of time, not exceeding the participant’s life expectancy or the joint life expectancy of the participant and his or her designated beneficiary. In-service distributions are permitted for participants who have attained the age of 65.

1. Description of Plan (*continued*)

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$32,655 and \$5,200. These accounts will be used to reduce future Company contributions. In 2024, \$37,000 of forfeitures was used to reduce employer contributions.

Plan Holding Account

The Plan and Empower Trust Company, LLC (the “trustee”) have entered into a revenue sharing arrangement whereby a portion of the revenue earned by the trustee from certain funds is credited quarterly to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing agreement, and to use this credit to pay Plan expenses, the Company uses a Plan Holding Account. The Plan Holding Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Plan Holding Account totaled \$188,345 and \$129,824 at December 31, 2024 and 2023. Expenses of \$96,700 were paid from this account during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value based on quoted market prices except for the investment in a common/collective trust which is reported at the NAV of units held by the Plan. Shares of mutual funds are reported at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The Putnam Stable Value Fund invests primarily in guaranteed and security-backed investment contracts with life insurance companies, banks, and other financial institutions. Underlying investments of the target date common/collective trust funds consist of fixed income and mixed-asset equities. The common/collective trust funds provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The majority of administrative expenses are paid by the Plan. Any administrative expenses not paid with Plan assets are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in financial statements through the date that the financial statements were available to be issued, which date is September 15, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

5. Common/Collective Trust

The Putnam Stable Value Fund (the "Fund") is a stable value fund that is a common/collective trust. The Fund may invest in fixed interest insurance investment contracts, money market funds, corporate and government bonds, mortgage-backed securities, bond funds, and other fixed income securities. The unit value of this Fund is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. Subject to certain limitations, withdrawals from the Fund are generally permitted daily. As of December 31, 2024 and 2023 there were no unfunded commitments.

6. Related Party and Party-in-Interest Transactions

The Plan received a servicing credit of \$240,044 during the year ended December 31, 2024 as part of their revenue sharing agreement between the Company and the trustee of the Plan. This credit represents a return of fees that were above what the plan administrator and record-keeper required to cover Plan expenses. The Plan's administrative expenses are funded through the revenue sharing agreement. These transactions are considered party-in-interest transactions. The Plan's financial consulting service provider has received payments under this agreement totaling \$177,982 for 2024. These amounts are included in other income and administrative expenses in the statement of changes in net assets available for benefits.

Certain employees of the Company perform administrative services related to the Plan; the Company pays the salaries of these individuals and no amounts are charged to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
