### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed audits of the financial statements of Simpson Electric Company Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of Simpson Electric Company Profit Sharing Plan (the Plan) is provided for general information purposes only in order to assist the reader in reviewing the financial statements of the Plan. Participants should refer to the plan agreement for more complete description of the Plan’s provisions.

**General** - The Plan is a prototype plan of Ascensus. The Plan is a defined contribution plan covering substantially all employees of Simpson Electric Company (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Assets of the Plan are held by Ascensus Trust Company, as trustee. The trustee provides an annual accounting and certification relating to asset balances, asset transactions, and income and expense transactions resulting from cash receipts and disbursements of the Plan, as well as a schedule of investments as required by ERISA. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

**Eligibility** - All Company employees, except union, nonresident aliens, and leased employees, with one year of service, as defined by the Plan, are entitled to participate.

**Contributions** - The Plan allows participants to contribute up to maximum amounts set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment and auto-deferral increase provision whereby all newly eligible employees are automatically enrolled in the Plan and their deferral rates are automatically increased annually unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with 1% annual increases up to 6% maximum and their contributions are invested in a designated target date fund until changed by the participant. The Company contributes to the Plan an amount determined by the Company’s board of directors. The Company currently matches 25% of the first 6% of employees’ compensation contributed to the Plan. Participants direct the investment of Company contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** - Upon enrollment in the Plan, participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their voluntary contributions, Qualified Nonelective Employer Contributions (“QNEC”) made on their behalf, and earnings thereon and any. Vesting in the employers’ contributions plus actual earnings thereon is based on all years of service. A participant is 100% vested after six years of service as follows:

**Payment of Benefits** - On termination of service, a participant with vested benefits in excess of \$1,000 may elect to receive a lump-sum amount equal to the vested interest in his or her account, in accordance with the Plan document. Participants with vested benefits of less than \$1,000 will receive payment of benefits in a single lump sum distribution.

**Forfeitures** - The undistributed, non-vested portion of a terminated participant's account balance will be used to reduce employer's contributions or pay plan administrative expenses. During 2024 employer contributions were reduced by approximately \$0 and administrative expenses were reduced by approximately \$2,186, respectively, from forfeited non-vested accounts. Forfeited nonvested accounts totaled approximately \$1,812 and \$261 at December 31, 2024 and 2023, respectively.

**Funding** - Employee contributions arising from salary reductions are funded as soon as practicable, but no later than the 15<sup>th</sup> day of the month following the month during which such contributions were withheld from the participant's compensation. Employer contributions are funded in a similar manner.

**Accounting Records** - The accounting records for Simpson Electric Company Profit Sharing Plan with respect to investment transactions are maintained by Ascensus, LLC, the Plan's record-keeper. The assets of the plan are held by Ascensus Trust Company, the trustee.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting** - As permitted under the Department of Labor rules and regulations, the plan administrator maintains the accounting records on the basis of cash receipts and disbursements. The accompanying financial statements of the Plan have been converted to the accrual basis in accordance with accounting principles generally accepted in the United States of America, which recognizes revenues and related assets when earned and expenses and related liabilities when incurred, except that benefits paid to plan participants are recorded on the cash basis.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Mutual company management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, these fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

**Contributions** - Contributions from employees are recorded as they are withheld from the participant’s wages. Contributions from the employer are recorded in the period in which the related participant contributions are due.

**Payment of Benefits** - Benefits are recorded when paid. There are no benefits payable to persons who have terminated service due to death, disability, retirement or other reasons, since all continue to participate in the earnings of the Plan until such time as a distribution is made. At December 31, 2024 and 2023 there were no benefits processed and approved for payment but not paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to participant’s account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

**NOTE C - INVESTMENTS (UNAUDITED)**

The Plan’s investments are administered by Ascensus, LLC, the agent of Ascensus Trust Company. Ascensus Trust Company, an affiliate of Ascensus, LLC, is the Plan’s trustee as of December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator by Ascensus, LLC and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company.

**NOTE D - FAIR VALUE MEASUREMENTS**

ASC 820, *Fair Value Measurements and Disclosures*, defines fair value, establishes a framework for measuring fair value under accounting principles generally accepted in the United States, and enhances disclosures about fair value measurements. FASB ASC 820 clarifies that fair value should be based on the assumptions market participants would use when pricing an asset or liability and establishes a fair value hierarchy that prioritizes the information used to develop those assumptions. FASB ASC 820 establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 - Inputs to the valuation methodology include:
  - Quoted market prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There were no assets measured at fair value on a non-recurring basis as of December 31, 2024 or 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Valued based upon published redemption prices of units held by the Plan, which is based on the current fair value of the collective trust funds underlying assets. Unit values are determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The Plan holds the right to liquidate its positions in these collective trust funds at any time, subject to a reasonable notification period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - TRANSACTIONS WITH RELATED PARTIES AND PARTIES-IN-INTEREST**

Ascensus Trust Company is the trustee, as defined by the Plan. Therefore, transactions with Ascensus Trust Company and its affiliates qualify as party-in-interest transactions. Fees paid by the Plan not covered by revenue sharing were approximately \$15,718 for the year ended December 31, 2024. The Plan Sponsor directly pays other fees related to the Plan’s operations.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**NOTE G - TAX STATUS**

The Ascensus LLC Non-Standardized Pre-Approved Profit Sharing Plan With CODA obtained its latest determination letter June 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving this determination letter. The Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
