## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

---

### 1. DESCRIPTION OF PLAN

The following description of the Civil Service Employees Association Employees' Salary Savings Plan ("Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Civil Service Employees Association, Inc, CSEA Employee Benefit Fund, and Civil Service Employee Political Action Fund (collectively, "The Company") who have at least three months of service and are age eighteen or older.

The Plan was established effective June 1, 2024, through the transfer of participant account balances from the AFSCME Employees' Salary Savings Plan, which previously included participants from the Company. The Company's participants were spun off into this newly created Plan, the Civil Service Employees Association Employees' Salary Savings Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Employees can elect to defer up to 100% of their eligible compensation, as defined in the Plan, to their 401(k) accounts, subject to certain legal limitations. In addition, participants have the option to treat deferrals as Roth deferrals rather than pre-tax deferrals. Rollover contributions from other plans and certain IRA's are permitted. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make qualified nonelective contributions and allocate them to certain Non-Highly Compensated Employees to help the Plan pass one or more annually required Internal Revenue Code non-discrimination tests. The amount of any such contributions will be determined in accordance with applicable law and Plan provisions. There were no qualified nonelective contributions for the period ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's qualified nonelective contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in their own contributions, the Company's qualified nonelective contributions, and allocated earnings.

## 1. DESCRIPTION OF PLAN (Continued)

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their vested account balance. Generally, loan terms range from zero to five years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time longer than five but no longer than ten years. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through payroll deductions, which cannot be less frequently than quarterly.

### **Payment of Benefits**

Generally, if a participant terminates employment with all employers participating in the Plan and their related employers, the participant may elect to receive a distribution of their vested account balance from the Plan. Distributions may also be made upon, retirement, death (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), disability, or under prescribed circumstances in the event of financial hardship. Distributions are made in cash in an amount equal to the value of the participant's account in either a lump sum amount or partial withdrawal. Termination distributions of account balances greater than \$7,000 may be deferred to a later date. Participants are permitted to take hardship distributions from pre-tax deferral and Roth accounts only. In-service distributions may be made upon reaching the normal retirement age.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period from June 1, 2024 to December 31, 2024.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Excess Contributions Payable**

Amounts payable to participants totaling \$18,598 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 contributions. The Plan distributed the excess contributions prior to March 15, 2025.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Payment of Benefits**

Benefits to participants are recorded when paid.

### **Administrative Expenses**

The Plan is responsible for administrative expenses related to recordkeeping, administration, and financial advisory services which are allocated to the participant level. The Company is responsible for all other Plan expenses (primarily auditing and other professional services).

### **Financial Instruments Measured at Fair Value**

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds, self-directed brokerage account, and a money market fund.

### Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies assets into a three-level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds and money market fund:* Valued at the net asset value of shares held at year end based on quoted market prices in an active market.

*Self-Directed Brokerage Accounts:* Accounts consist of mutual funds, exchange-traded funds, and corporate stock that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has entered into a group annuity contract with Empower Annuity Insurance Company (Empower). Empower maintains contributions in a pooled account, the Guaranteed Income Fund. The account is credited with interest at a rate which is announced in advance and guaranteed for a specified period of time, as indicated in the contract between the Plan and Empower and charged for participant withdrawals and certain contract fees charged by Empower. The crediting rate is required in the contract to be greater than 1.70%. The contract has no specific underlying assets. It is backed by the general account of Empower. The contract is included in the financial statements at contract value, as reported to the Plan by Empower.

At December 31, 2024, the Plan held \$4,396,755, in the Empower Guaranteed Income Fund and is considered to be a traditional guaranteed interest contract.

The Empower Guaranteed Income Fund provides a rate of return consistent with long-term rates of return available in the general marketplace. There are no events or circumstances that would cause the investment contract to be terminated and settled at an amount different than the contract value; however, there is a restriction in the agreement with Empower that allows the contract value to be paid out over a short period of time instead of in a lump sum if it's determined that this is necessary to keep the Fund stabilized.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan also qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **8. INCOME TAX STATUS**

The Plan is designed from a pre-approved plan offered by FMR, LLC. The IRS has determined and informed FMR, LLC by a letter dated June 30, 2020, that the written form of the underlying plan document is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not applied for its own determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 9. TRANSFERS FROM AFFILIATED PLAN

On June 1, 2024, \$26,920,822 in participant account balances, including investments and participant loan receivables, were transferred into the Plan from the AFSCME Employees' Salary Savings Plan. This transfer was part of the Plan's establishment and is reported as a transfers from affiliated plan in the accompanying financial statements.
