1. Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on February 1, 1998 to provide retirement benefits for employees of Koley Jessen P.C., L.L.O. (the Company).

Employees become eligible to participate in the Plan immediately upon hire. Eligible employees become participants as soon as administratively possible, but no later than the second payroll period following satisfaction of the eligibility requirements.

Contributions

Participants – Participants may contribute up to 100% of their annual eligible compensation through compensation deferrals, either on a pre-tax/after-tax and/or Roth after-tax basis, not to exceed certain Internal Revenue Code (IRC) limitations. New participants who meet eligibility requirements are automatically enrolled with an initial 6% salary deferral contribution which is increased by 1% up to a maximum of 10% on an annual basis. Effective January 1, 2026, all existing participants, except those who have an affirmative election, will be subject to the automatic enrollment provisions. At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under Plan provisions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Company – The Company will contribute a non-elective "safe harbor" contribution in an amount equal to 5% of each participant's eligible compensation. Contributions are subject to certain regulatory requirements. The Company made non-elective "safe harbor" contributions of \$1,706,362 and \$1,545,387 for the years ended December 31, 2024 and 2023, respectively.

In addition to the non-elective safe harbor contribution, the Company may make a discretionary profit-sharing contribution to the Plan. Discretionary profit-sharing contributions are allocated to participants based on an allocation formula at management's discretion. In order to receive an allocation of any discretionary profit-sharing contribution, participants must be actively employed at the end of the Plan year. The Company made discretionary profit-sharing contributions of \$1,061,566 and \$920,627 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's non-elective safe harbor contributions, b) the Company's discretionary profit-sharing contributions and c) Plan earnings or losses. The Company's non-elective safe harbor contributions and discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Investments are maintained in individual member accounts managed by Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, Empower).

Vesting and Forfeitures

Participants are immediately vested in all contributions upon entering the Plan. Since the Plan provides for immediate vesting, there are no forfeitures.

Payment of Benefits

Benefits are payable in a lump sum upon termination of service due to death, disability, retirement, or voluntary separation. The amount paid is equal to the participant's contributions and earnings thereon plus their vested share of the Company's contributions and earnings (losses). Upon attainment of age 59 ½, a participant may withdraw all or a portion of the contributions made to the Plan in which they are 100% vested. Distributions under \$1,000 will be paid to the participant in the event the participant does not elect a payout option. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000, prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution payments are charged directly to the participant's account and are included in administrative expenses. Record-keeping fees are included in administrative expenses. Investment-related expenses are paid by the Plan and included in net appreciation in fair value of investments.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or the greater of (1) 50% of their vested account balance or (2) \$10,000. The notes are secured by the balance in the participant's account and bear interest at 1% over the prime rate as determined and monitored by the Prudential. Interest rates currently range from 4.25% to 9.50%. Principal and interest rates are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 2, 2025. See the "Contributions" section of Note 1 for a description of a subsequent event.

3. Information Certified by Empower

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contracts

The Plan has fully benefit-responsive investment contracts with Empower in 2024 and 2023. Empower maintains contributions in a guaranteed investment contract. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Empower.

As the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Crediting rates are a guaranteed rate determined every six months subject to a minimum crediting rate. For the years ending December 31, 2024 and 2023, the crediting rate was 2.10% and 1.95%, respectively.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions

Certain Plan investments are a guaranteed investment contract managed by Empower. Empower is the trustee and custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Distribution to participants of the account balances would be made as soon as practicable after the termination date.
