### **Opinion**

We have audited the financial statements of the Transitions Group, Inc. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF THE PLAN**

The following description of the Transitions Group, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description (SPD) for a more complete description of the Plan's provisions, which are available from the Plan Administrator. The Board of Trustees is responsible for oversight of the Plan.

General - Transitions Group, Inc. (Company or Sponsor Company) established the Plan effective as of January 1, 2013. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, (IRC) and is subject to the applicable provision of the Employee Retirement Income Security Act of 1974 (ERISA).

On July 2014, the Plan purchased 52,588 shares of treasury stock from the Company for \$745,000, which was provided through contributions to the Plan by the Company. Additionally, the Plan purchased 847,412 shares of treasury stock in exchange for a note payable to the Company in the amount of \$1,740,725, payable in thirty annual installments, including interest at 3.14%, maturing July 31, 2044 (see Note 5). The shares serve as collateral for the note.

Unallocated and Allocated Shares - The borrowing is collateralized by the unallocated shares of the Company. The lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- a) The accounts of employees with vested rights in allocated stock (Allocated)
- b) Stock not yet allocated to employees (Unallocated)

Eligibility - Employees of the Company are eligible to participate in the Plan who are at least 21 years of age and completes one year of service, as defined by 1,000 hours of service during the plan year and are treated as participants on the earlier of January 1 or July 1 following the date on which eligibility requirements are met. Participants who do not have at least 1,000 hours of service during the Plan year are not eligible for an allocation of Company contributions for the year.

Contributions - The Company makes contributions in cash to the Plan which equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan payable. Employee contributions are not permitted.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant account based on the ratio of the participants account balance.

Vesting - Participants vest in the Company contributions and earnings thereon at a rate based upon continuous years of service, becoming fully vested upon completing six years of service. Participants terminating due to normal retirement, death or disability will be 100% vested. Forfeitures are allocated among active participants in accordance with an allocation formula.

Normal Retirement - Normal retirement age is 65 years of age.

Put Option - Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits - Distributions on account of death, disability, or retirement are made in five annual installments commencing in the subsequent plan year (with the exception of vested benefits that do not exceed \$5,000 which may be paid in a lump sum after one plan year).

Distributions for other separations from service commence in the fifth plan year following the separation from service and are made in five annual installments (with the exception of vested benefits that do not exceed \$5,000 which may be paid in a lump sum after one plan year).

Certain other provisions apply if the participant's benefit is in excess of \$1,230,000. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash.

Voting Rights - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and to be notified by the Trustee of the Plan, prior to the time such rights are to be exercised. Other corporate matters are voted, for allocated securities, by the Trustee in accordance with instructions from the Plan Administrator. If the Administrator fails or refuses to give the Trustee timely instructions as to how to vote, the Trustee shall not exercise its power to vote such stock and shall consider the Administrator's failure or refusal as an exercise of the Administrator's rights and a directive to the Trustee not to vote the applicable stock. Pledged securities are voted by the trustee on behalf of the collective best interest of the Plan participants and their beneficiaries.

Forfeitures - Plan forfeitures may be used by the Plan for payment of Plan expenses or allocated to each participant account. Any forfeitures not used by the Plan are added to contributions and are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. Forfeitures are allocated in the year in which the distribution would have otherwise been payable.

Forfeited non-vested accounts allocated to participant accounts during the year ended December 31, 2024 and 2023 were \$11,167 and \$13,751, respectively. There were no remaining forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

Diversification - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution, unless eligible for floor price protection, in which case, shares are distributed. There were \$80,413 of distributions related to diversification for the year ended December 31, 2024.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Allocations - The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition - All investments, including the common shares of the Company, are reported at fair value on December 31, 2024 and 2023. Fair value for the common shares is determined by an annual independent appraisal. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. The Company has historically paid the operating expense for the Plan.

Subsequent Events - These financial statements considered subsequent events through October 3, 2025, the date these financial statements were available to be issued.

**4. FAIR VALUE OF MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The guidance describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Money Market* - This investment is valued using a quoted price in an active market.

*Sponsor Company Common Stock* - Fair value for this investment is the responsibility of the Plan's trustees. The Plan's trustees contract with an independent appraiser to generate fair value estimates on an annual basis. The Plan has engaged an independent trustee who challenges the reasonableness of the assumptions used and reviews the methodology to ensure the estimated fair value complies with accounting principles generally accepted in the United States. The Sponsor Company common shares have a fair value of \$5,571,000 and \$6,975,000 as of December 31, 2024 and 2023, respectively.

Fair Value - \$6.19 and \$7.75 per share at December 31, 2024 and 2023, respectively.

Valuation Techniques - This appraisal was based upon the discounted cash flow method and is consistent with prior years. The appraiser took into account estimated future returns which are discounted to present value at an appropriate rate of return.

Unobservable Inputs - Weighted average cost of capital and discount for lack of marketability.

The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity and market comparables in earnings and revenue.

The valuation process involves the Plan fiduciary's selection of an independent appraiser under a written contract with the right to cancel such contract at any time. Company management accumulates the data for the appraiser from the audited financial statements of the Company and

prepares a preliminary report which Company management, along with the Plan Administrator, reviews in detail, discusses, modifies if appropriate, and ultimately approves.

**5. LOAN PAYABLE**

The Plan purchased 847,412 shares of Company treasury stock in exchange for a note payable to the Company in the amount of \$1,740,725, payable in thirty annual installments, including interest at 3.14%, maturing July 31, 2044. The shares serve as collateral for the note. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments plus all future years' principal and interest payments. This resulted in 31,314 and 31,918 shares being released and allocated for the Plan years ended December 31, 2024 and 2023, respectively.

**6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in Company common stock. The investment transactions are considered related party and party in interest transactions. The Plan also has a number of service providers. Such providers are parties in interest under ERISA. Transactions between these entities and the Plan qualify as party in interest transactions.

**7. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the trust fund will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code (IRC), and the Trustee shall liquidate all assets of the Plan and continue to administer the Plan in accordance with its provisions until all obligations have been satisfied.

**8. TAX STATUS**

The Plan adopted a non-standardized pre-approved ESOP plan (pre-approved plan) designed to qualify under Section 401 of the IRC. The Plan has obtained a copy of a favorable opinion letter for the pre-approved plan dated June 30, 2020, upon which the Plan is relying, that the pre-approved plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

**9. RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Such risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
