We have performed audits of the financial statements of Feed My Starving Children 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
YEARS ENDED DECEMBER 31, 2024 AND 2023

1. Plan description:

The following description of the Feed My Starving Children 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 2015. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and includes salary deferral contributions permitted under Section 401(k) of the Internal Revenue Code (IRC). Feed My Starving Children (the Organization) established the Plan to provide eligible employees with the long-term accumulation of retirement savings through a combination of employee contributions to individual participant accounts and the earnings thereon. In addition, the employer may also contribute to the Plan through match, profit sharing, and any other allowed contributions. The Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan restated their plan document for the Cycle 3 regulatory changes effective January 1, 2022. There were no substantive changes to plan provisions. On April 1, 2022, the Plan changed recordkeepers and restated their plan document. There were no substantive changes to plan provisions.

Effective January 1, 2023, the Plan was amended to change the following plan provisions: the definition of compensation changed to exclude dental and cell phone reimbursements and the service requirement changed for elective deferrals and safe harbor contributions from one month of service to two months of service.

Eligibility:

Employees of the Organization who are 18 years of age or older, are eligible to enroll after two months of service. Seasonal and temporary employees who are scheduled to work less than 1,000 hours are excluded. The Plan has an automatic contribution provision to automatically enroll eligible employees at 1% unless the employee opts out.

Plan contributions:

Participants may elect to reduce their compensation by a specific percentage and have that amount contributed to the Plan as a salary deferral. Under this Plan, salary deferrals generally means both Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Participants may elect to defer up to 90% of their base pay by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Plan's definition of compensation excludes certain fringe benefits.

The employer profit sharing contribution is discretionary. There were no employer profit sharing contributions during 2024 or 2023. The employer safe harbor matching contribution is 100% of the employee salary deferrals that do not exceed 3% of compensation plus 50% of the salary deferrals between 3% and 5% of compensation. The safe harbor matching contribution is 100% vested.

1. Plan description (continued):

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's matching and profit-sharing contribution, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options:

Upon enrollment in the Plan, participants may direct the investment of their contributions into various investment account options offered by the Plan.

Participant investment rollovers:

Participants are allowed to transfer or rollover funds into the Plan from other qualified retirement plans.

Vesting:

Participants are immediately vested in their voluntary contributions, employer matching contributions and earnings thereon. The vested percentage for employer profit sharing contributions is based on vesting periods of service as follows:

Benefits paid to participants:

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participants' vested account in a lump-sum or in installments. During employment, vested employer contributions may be withdrawn from the Plan at age of 59 ½ or later.

Hardship withdrawals:

Hardship withdrawals by participants are permitted for certain situations, as provided by the Plan document.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at Prime plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions.

2. Summary of significant accounting policies:**Use of accounting estimates and basis of accounting:**

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as of the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Contributions:

Contributions from employees are recorded in the period in which the Organization makes the payroll deductions from participant earnings. Related contributions from the employer are calculated and recorded in the same period.

Benefits paid to participants:

Benefits are recorded when paid.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If participants fail to make payments when they are due under the terms of the loan, the loan is considered to be in default. Under certain circumstances, a loan that is in default may be considered a distribution from the Plan and could be considered taxable income to the participant based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Forfeitures:

Forfeitures of non-vested employer profit sharing contributions, revert back to the Plan and are used to reduce the employer's contributions and/or pay reasonable Plan expenses in the year in which the designated forfeitures occur. There were no forfeitures in the Plan year 2024 and 2023.

2. Summary of significant accounting policies (continued):

Administrative fees:

Fees for the Plan's administration may be charged to the Plan unless paid for by the employer. In 2024 and 2023, administrative fees were paid by the employer, except for certain record keeping fees, investment transaction fees and loan administrative fees which were borne by the participants.

Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Concentrations:

At December 31, 2024 and 2023, approximately 64% and 62%, respectively, of investments were held in four mutual funds.

Reclassifications:

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

Subsequent events:

The Plan Administrator has evaluated for subsequent events through October 6, 2025 the date the financial statements were available for issuance.

3. Information certified by Reliance Trust Company:

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to certain investments held as of December 31, 2024 and 2023, as well as, certain investment income for the years ended December 31, 2024 and 2023, as shown below, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Fully benefit-responsive investments, at contract value:

The Standard Stable Asset Fund A is a group annuity contract that offers a full guarantee on principal and interest by the Standard Insurance Company (Issuer). The Reliance MetLife GAC Series 25053 is a common trust fund that offers a full guarantee on principal and interest by Reliance Trust Company (Issuer). These contracts are traditional and fully benefit responsive.

The Great Gray Trust Large Cap Value R1 is a common trust fund that offers a full guarantee on principal and interest by Great Gray Trust (Issuer). The contract is synthetic and fully benefit responsive.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transaction under the terms of the Plan. Contract value, as reported to the Plan by the Issuer, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value. Such events include withdrawals due to Plan Sponsor actions. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The Plan Sponsor does not consider the occurrence of these events probable as of December 31, 2024, and through the date of this report.

6. Tax status:

The Plan document used by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with parties-in-interest:

Certain Plan investments are managed by Reliance Trust Company, the Plan's custodian and by The Standard, the Plan's recordkeeper. Therefore, these transactions qualify as party-in-interest transactions.

Certain administrative fees related to the administration of the Plan are paid by the Plan Sponsor.

8. Plan termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to amend or terminate the Plan, or any part of the Plan at any time subject to the provisions of ERISA. If the Plan were to be terminated, no further contributions will be made to the Plan and participants would become 100% vested in their employer contributions.
