Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AVOX Systems 401(k) Plan for Bargaining Unit Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The following is a brief description of the AVOX Systems 401(k) Plan for Bargaining Unit Employees (the Plan) provided for general informational purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan is funded by participant and employer contributions and covers all employees of AVOX Systems Inc. (the Company or Plan Sponsor) who have attained 18 years of age and are part of a collective bargaining unit. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's assets are maintained by Fidelity Management Trust Company (Fidelity). The Plan document was amended effective November 1, 2024.

Contributions – Participants may elect to contribute up to 60% of their eligible compensation up to the maximum annual limitations as provided by the IRC. The Plan also has a provision for employer matching contributions, whereby the Company will make matching contributions of 25% of participant contributions up to 4% of eligible participant compensation.

Vesting – Participants are immediately vested in their voluntary contributions, rollover contributions, employer matching contributions and earnings thereon, at all times.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable generally have terms ranging from one to five years, unless the note is for the purchase of a principal residence, in which case the term can be extended to ten years. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing interest rates. The notes mature at varying dates through August 2033 and had interest rates ranging from 4.25% and 9.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Participant Accounts – Each participant's account is credited with his or her contributions, the Company's contributions, and actual earnings thereon. Each participant's account is reduced by the actual amount of benefits paid on his or her behalf, investment losses and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

Payment of Benefits – Employees are eligible for retirement at age 55. Benefits are determined by the final value of the participant's account at the time of payment. Various payment options are available upon retirement, including lump-sum cash or minimum distribution installments. Unless a participant elects otherwise, distributions will be made as soon as practical after a participant's normal retirement date or actual retirement date. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and after age 59 ½.

Participants may receive their accumulated benefits upon termination of employment or elect to keep their account in the Plan until the earlier of normal retirement age, death or disability if their account balance exceeds \$5,000. If the participant elects to keep his or her account in the Plan, the account will continue to receive its share of investment gains and losses.

1. PLAN DESCRIPTION (*Continued*)

Administrative Expenses – A portion of the costs of administering the Plan are borne by the Plan Sponsor.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall be entitled to the amount of their accounts at the date of such termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes both realized and unrealized gains and losses incurred during the year.

Contributions – Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

Benefit Payments – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events – The Plan has evaluated events and transactions that occurred between January 1, 2025 and October 1, 2025, which is the date these financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

3. FAIR VALUE MEASUREMENTS (*Continued*)

The three levels of the fair value hierarchy are described as follows:

- *Level 1* – Inputs to the valuation methodology that consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology that include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* – Inputs to the valuation methodology that are unobservable and are significant to the overall fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for Plan assets measured at fair value at December 31, 2024 and 2023:

- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money market fund* – Valued based on the observable underlying money market balances.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31:

4. INCOME TAX STATUS

The Plan is a prototype plan developed by Fidelity Management Research Corporation which received a favorable determination letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the Plan is qualified under the applicable sections of the IRC, and therefore, the related trust net investment income is exempt from taxation. The plan administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust investment income is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed tax positions taken by the Plan and concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include units of mutual funds that are managed by Fidelity Investments, an affiliate of Fidelity, the trustee of the Plan. Consequently, these transactions qualify as party-in-interest transactions. Additionally, the Plan utilizes a number of service providers which also qualify as parties-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. RISKS AND UNCERTAINTIES

The Plan invests in multiple investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

1. PLAN DESCRIPTION

The following is a brief description of the AVOX Systems 401(k) Plan for Bargaining Unit Employees (the Plan) provided for general informational purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan is funded by participant and employer contributions and covers all employees of AVOX Systems Inc. (the Company or Plan Sponsor) who have attained 18 years of age and are part of a collective bargaining unit. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's assets are maintained by Fidelity Management Trust Company (Fidelity). The Plan document was amended effective November 1, 2024.

Contributions – Participants may elect to contribute up to 60% of their eligible compensation up to the maximum annual limitations as provided by the IRC. The Plan also has a provision for employer matching contributions, whereby the Company will make matching contributions of 25% of participant contributions up to 4% of eligible participant compensation.

Vesting – Participants are immediately vested in their voluntary contributions, rollover contributions, employer matching contributions and earnings thereon, at all times.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable generally have terms ranging from one to five years, unless the note is for the purchase of a principal residence, in which case the term can be extended to ten years. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing interest rates. The notes mature at varying dates through August 2033 and had interest rates ranging from 4.25% and 9.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Participant Accounts – Each participant's account is credited with his or her contributions, the Company's contributions, and actual earnings thereon. Each participant's account is reduced by the actual amount of benefits paid on his or her behalf, investment losses and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

Payment of Benefits – Employees are eligible for retirement at age 55. Benefits are determined by the final value of the participant's account at the time of payment. Various payment options are available upon retirement, including lump-sum cash or minimum distribution installments. Unless a participant elects otherwise, distributions will be made as soon as practical after a participant's normal retirement date or actual retirement date. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and after age 59 ½.

Participants may receive their accumulated benefits upon termination of employment or elect to keep their account in the Plan until the earlier of normal retirement age, death or disability if their account balance exceeds \$5,000. If the participant elects to keep his or her account in the Plan, the account will continue to receive its share of investment gains and losses.

1. PLAN DESCRIPTION (*Continued*)

Administrative Expenses – A portion of the costs of administering the Plan are borne by the Plan Sponsor.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall be entitled to the amount of their accounts at the date of such termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes both realized and unrealized gains and losses incurred during the year.

Contributions – Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

Benefit Payments – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events – The Plan has evaluated events and transactions that occurred between January 1, 2025 and October 1, 2025, which is the date these financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- *Level 1* – Inputs to the valuation methodology that consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology that include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* – Inputs to the valuation methodology that are unobservable and are significant to the overall fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for Plan assets measured at fair value at December 31, 2024 and 2023:

- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money market fund* – Valued based on the observable underlying money market balances.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31:

4. INCOME TAX STATUS

The Plan is a prototype plan developed by Fidelity Management Research Corporation which received a favorable determination letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the Plan is qualified under the applicable sections of the IRC, and therefore, the related trust net investment income is exempt from taxation. The plan administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust investment income is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed tax positions taken by the Plan and concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include units of mutual funds that are managed by Fidelity Investments, an affiliate of Fidelity, the trustee of the Plan. Consequently, these transactions qualify as party-in-interest transactions. Additionally, the Plan utilizes a number of service providers which also qualify as parties-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. RISKS AND UNCERTAINTIES

The Plan invests in multiple investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
