***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of FACC Premium Deferred 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of FACC Premium Deferred 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. ### ***Basis for Opinion***

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about FACC Premium Deferred 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures,

including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

<b>NOTE 1: <i>Plan Description</i></b>
--

The following description of the FACC Premium Deferred 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution 401(k) Profit Sharing Plan covering substantially all employees of the Florida Association of Court Clerks and subsidiaries (the Organization) who have attained the age of 18 and have completed three months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Contributions***

Each year, participants may contribute up to 100% of their pretax and post-tax annual compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other plans and certain IRAs. The Organization makes a safe harbor non-elective contribution, based on 3% of eligible compensation, and a 7% fixed non-elective contribution. The Organization may also make discretionary non-elective contributions at its discretion. Participants direct the investment of their contributions and the Organization's contribution into various investment options offered by the Plan. Contributions are subject to certain limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of (a) the Organization's contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Organization currently offers ten mutual funds, thirty collective trust funds, and one stable value fund as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions and the Organization's contributions, plus actual earnings thereon.

<b>NOTE 1: <i>Plan Description (Continued)</i></b>
--

***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50% with terms ranging from one to five years, and up to twenty years if for the purchase of the participant's principal residence. Principal and interest are repaid ratably by payroll deduction.

***Payment of Benefits***

Upon termination of service, retirement, disability, or death, participants may receive a distribution equal to their vested account balance. Distributions may be paid in the form of a lump-sum payment, a rollover distribution to an IRA, a rollover distribution to another qualified plan, or installment payments. The participant's contributions plus earnings may also be withdrawn for certain hardship situations as defined by ERISA.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,625 and \$1,583, respectively. These accounts will be used to reduce future employer contributions.

***Administrative Expenses***

The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Plan Sponsor. Plan administration and investment management fees reduce participants' account balances. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

<b>NOTE 2: <i>Summary of Significant Accounting Policies</i></b>
--

***Basis of Accounting***

The Plan's policy is to prepare its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Revenues are recognized in the period in which they are earned. Expenses are recognized in the period in which they are incurred.

<b>NOTE 2: <i>Summary of Significant Accounting Policies (Continued)</i></b>
--

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events***

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through August 27, 2025, the date the financial statements were available to be issued. There have been no subsequent events requiring recognition or disclosure.

### **NOTE 3: *Income Tax Status***

The Plan adopted a pre-approved plan that obtained a favorable determination letter from the Internal Revenue Service dated June 30, 2020. No individual determination letter has been issued specific to the Plan. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter on the prototype plan, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions for the most recent three years; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.

### **NOTE 4: *Fair Value Measurements***

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan has Level 1 and Level 2 assets only. The levels of the fair value hierarchy under FASB ASC 820 are described below and on the following page.

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

<b>NOTE 4: Fair Value Measurements (Continued)</b>
--

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024, and 2023.

- *Mutual funds*: The fair value of mutual fund investments are determined by obtaining quoted prices on nationally recognized exchanges (level 1 inputs).
- *Common/Collective Trusts*: Valued by computing unit prices based on the market values of the underlying fund assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment earnings for amounts held in mutual, collective trust, and stable value funds reflect a combination of interest income, dividend income, realized gains and losses, and unrealized gains and losses depending on the composition of the underlying investments. Contributions made by the Organization are applied or invested in accordance with participant-directed allocations.

**NOTE 5: Investments – Participant Directed**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified as complete and accurate by Empower Trust Company, LLC for the years ending December 31, 2024 and 2023, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments, as shown in the accompanying statements of net assets available for benefits, are \$21,427,088 and \$18,351,561 as of December 31, 2024 and 2023, respectively.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, is \$2,484,985 for the year ended December 31, 2024.
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 6: *Plan Termination***

Although it has not expressed any intent to do so, the Organization has the right under the Plan to permanently discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 7: *Transactions with Party-in-Interest Transactions***

Empower Trust Company, LLC is the trustee of Plan assets and derives fees based on the asset values, which are netted against the net appreciation in fair value of investments. Empower Retirement refers to products and services offered in the retirement markets by Empower Trust Company, LLC. Fiduciary First, LLC provides investment advisory services to the Plan and derives fees related to investment advisory services, which are included in administrative expenses.

**NOTE 8: *Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
