SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the FiscalNote, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of FiscalNote, Inc., Congressional Quarterly, Inc., CQ Roll Call, Inc., Oxford Analytica, Fireside, Board.org LLC, Predata, Inc., Curate Solutions, Inc., Forge.AI, Inc., and Frontier Strategy Group LLC (collectively referred to as the Company). During the year ended December 31, 2024, the Company sold Board.org LLC (Board) to a third-party buyer. Following the transaction, the plan assets related to participating employees of Board were transferred to another plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to contribute to the Plan upon the completion of three months of service. An employee's entry date will be the first day of the month after or coinciding with the date eligibility requirements are met.

Contributions

Participants may elect to defer up to the maximum amount of pretax annual compensation, as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC). Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions on elective deferrals or discretionary profit-sharing contributions as determined by the Company. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, any Company contributions, and an allocation of any Company profit-sharing contributions. Participants' accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to

which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to various investment options offered by the Plan.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan terms may not exceed five years unless the proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through semi-monthly payroll deductions.

Vesting

Participants are immediately vested in their voluntary, Company matching, profit-sharing, and rollover contributions, plus actual earnings thereon.

Payment of Benefits

Upon termination of service, a participant may elect to receive installments, a single lump-sum distribution of a portion of the participant's vested account balance, or a lump-sum amount equal to the value of the participant's entire vested interest in the participant's account. Hardship distributions are permitted if certain conditions are met. In-service withdrawals are also permitted for participants who are 59½ years old. If the total value of an inactive participant's vested account balance is \$1,000 or less, the Plan Administrator may require a distribution of the entire account balance in a lump sum. If the total value of an inactive participant's account is \$1,001 to \$5,000, the Plan Administrator may require the balance to be rolled over to an individual retirement plan designated by the Plan Administrator. These methods and options are described in the Summary Plan Description.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or Company as provided by the Summary Plan Description.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts are used to offset Company contributions and administrative expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Valuation of Investments

Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Summary Plan Description.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 1, 2025, the date the financial statements were available to be issued.

NOTE 3 **INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan's investments were held by the Trustee, Fidelity Personal Trust Company, at December 31, 2024 and 2023. Financial information related to investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. The information was not audited by the Plan's independent auditors. As of December 31, 2024 and 2023, certified investment information consisted of the following:

NOTE 4 **VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trust: Valued using NAV per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at the NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

NOTE 6 TAX STATUS

The Plan adopted a volume submitter plan developed by Sentinel Benefits Group. The volume submitter plan obtained its latest determination letter on November 30, 2020 wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with Section 401 of the IRC. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions as of December 31, 2024.

NOTE 7 PARTIES IN INTEREST

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and custodial fees to parties in interest. These fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
