Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Intellectual Ventures Management 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) salary deferral and profit sharing plan, established January 1, 2010, covering all eligible employees of Intellectual Ventures Management LLC ("IVM or "the Company") and related entities as listed in the Plan document (collectively, the "Companies"). IVM is the Plan's sponsor and serves as the Plan Administrator. The Plan provides for contributions pursuant to Section 401(a) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility to Participate

Employees are eligible to participate in the Plan as long as they are not: (1) union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining; (2) nonresident aliens who have not earned income from sources within the U.S.; or (3) leased employees and interns.

Contributions

Participant contributions - Participants may elect to contribute up to 96% of eligible compensation, including bonuses, up to the maximum amount allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Matching contributions - During the 2024 and 2023 Plan years, the Companies matched 100% of participant contributions up to 3% of eligible compensation, and 50% of contributions above 3%, to a maximum of 5% annually, up to a maximum matching contribution on an annual basis of \$13,800 and \$13,200 in 2024 and 2023, respectively.

Nonelective employer contributions - The Companies may elect to make additional discretionary contributions to the Plan. The Companies did not elect to make any additional discretionary contributions during 2024 and 2023.

Contributions are subject to regulatory limitations.

Investment Options

Participants may select one or more predetermined investment options for the investing of contributions and allocated earnings. Contributions are deposited directly into the participant-elected investment vehicles.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and proportional allocations of earnings from the Plan's investments, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

All matching and nonelective employer contributions are immediately vested. Participants are immediately vested in their voluntary contributions including salary deferrals and rollover contributions and the actual earnings thereon.

Notes Receivable from Participants

A participant may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of 1) 50% of their interest in the Plan; or 2) \$50,000, reduced by the excess of the highest outstanding note balance during the one-year period, over the outstanding note balance on the date on which the current note is made. Two outstanding loans are permitted at any one time. Notes are secured by the balance of the participant's account and bear interest based on prevailing interest rates for notes, as determined by the Plan administrator. The maximum note term is five years unless the note term is used for the purchase of the borrower's primary residence, in which case the term of the loan may not exceed 10 years. Principal and interest are generally paid through payroll deductions. Payments must be made at least quarterly. Interest rates for participant loans are set by the Plan administrator based on prevailing interest rates and remain fixed throughout the duration of the loan. As of December 31, 2024, the rates of interest on outstanding notes ranged from 4.25%-9.50% with maturity dates ranging through December 2029. As of December 31, 2023, the rates of interest on outstanding notes ranged from 4.25%-9.50% with maturity dates ranging through December 2028.

Distribution of Benefits

Upon retirement, disability, hardship or termination, a participant may elect to take a distribution up to the balance of the participant's account or roll over the balance into another qualified plan. The actual retirement benefit payment is not made until the employee has reached the normal retirement date. Participant account balances greater than a stated threshold can be distributed to the participant via lump-sum payments. During the year ended December 31, 2023, terminated participants' accounts with balances of less than \$5,000 were automatically distributed to the participants. Effective January 1, 2024, the threshold for automatic distribution increased to \$7,000.

Distributions due to disability, upon verification of the disability claim balances, are distributed in a manner similar to the retirement process. Upon death, the participant's account balance shall be paid to the designated beneficiary. Participant's contributions may be withdrawn earlier, subject to certain hardship withdrawal provisions for the Plan.

Administrative Expenses

Administrative expenses are paid out of the Plan assets; however, the Plan sponsor may elect to pay certain expenses. In 2024 and 2023, audit and legal fees were paid for by the Plan sponsor. Additionally, certain transaction fees, such as loan fees and redemption fees, are paid by the participant.

The Company has retained the services of a third-party administrator to perform certain administrative functions. These expenses are paid to the third-party by the Plan.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are accrued as earned. Net appreciation or depreciation in fair value is the net gain or loss on disposition of investments plus the net unrealized increase or decrease in fair value during the year of investments held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance including accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan provides for various investment fund options, which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

NOTE C - CERTIFIED INVESTMENT INFORMATION

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, as of and for the years ended December 31, 2024 and 2023, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investment assets and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment income, and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Information included on the supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - PLAN TERMINATION

While the Company intends to continue the Plan, the right to change or discontinue the Plan subject to the provisions of ERISA has been reserved by the Company. In the event of termination of the Plan, the Company may direct the distribution of the assets to participants according to the Plan document.

NOTE E - TAX STATUS

Effective May 10, 2021, the Plan was amended and restated using a prototype non-standardized profit-sharing plan document, which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which stated the plan is acceptable for use under IRC Section 401. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, notes receivable from participants qualify as party-in-interest transactions.

NOTE G - FAIR VALUE MEASUREMENT

The Plan measures the fair value of its assets based upon certain valuation techniques that include observable or unobservable inputs and assumptions that market participants would use in pricing these assets under a fair value hierarchy.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value and is described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 or Level 2 inputs as components of the overall fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Valued at cost plus any accrued interest. This investment is classified within Level 1 of the fair value hierarchy.

Common Collective Trust: The stable value fund is a collective trust fund, which is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
