## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Gypsum Systems Management 401(k) Plan  
Elma, New York

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gypsum Systems Management 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. PLAN DESCRIPTION

The following is a brief description of the Gypsum Systems Management 401(k) Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee and employer contributions and covers all full-time non-union employees of Gypsum Systems Management and affiliated entities (collectively the “Company” or “Plan Sponsor”) who have attained 18 years of age and one year of service. Employees are automatically enrolled on a quarterly basis after completion of age and service requirements, with a 2% pre-tax deferral amount. The Plan features an automatic escalation of the pre-tax deferral of 1% annually, not to exceed 4% of Plan compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Participants are able to defer up to 100% of their compensation to the Plan on a pre or post-tax basis up to the IRC dollar limitations. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount allowed by law. Participants may also contribute rollover amounts representing distributions from other defined contribution plans and certain IRAs. The Company may make discretionary matching and profit sharing contributions to the Plan. Participants are immediately eligible for employer discretionary matching contributions. Participants are eligible for profit sharing contributions upon completion of 1,000 hours of service. For the year ended December 31, 2024, the Company elected to make matching contributions to the Plan equal to 25% of participant contributions. The discretionary match is remitted to the Plan subsequent to the Plan year-end and is recorded as employer contributions receivable in the accompanying statement of net assets available for benefits as of December 31, 2024. Employer contributions receivable were \$177,958 and \$149,228 as of December 31, 2024 and 2023, respectively. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions received from participants for 2023 are net of obligations of \$2,810 to certain active participants to return excess contributions to satisfy the relevant nondiscrimination provisions of the Plan. This amount is included in the accompanying 2023 statement of net assets available for benefits as excess contributions payable and were returned to participants in 2024. There were no excess contributions payable as of December 31, 2024.

**Vesting** – Participants are immediately vested in their voluntary contributions and earnings thereon. Vesting in the Company’s discretionary matching and profit sharing contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and vests an additional 20% for each additional year of credited service. A participant is 100% vested after six years of credited service. Regardless of years of service, participants are fully vested upon death or disability.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and an allocation of the employers’ discretionary contributions and Plan earnings (losses). Allocations of Plan earnings (losses) are based on participant account balance and investment selections.

## 1. PLAN DESCRIPTION (continued)

**Forfeitures** – Participants not fully vested in employers’ contributions upon separation from the Company, as defined in the Plan document, forfeit their non-vested balances. Forfeitures may be used to pay Plan administrative expenses, or to reduce future employer contributions. During the year ended December 31, 2024, no forfeitures were utilized. Forfeitures available amounted to \$7,482 and \$5,625 at December 31, 2024 and 2023, respectively.

At December 31, 2024, the employer contributions receivable of \$177,958, is presented net of \$7,482, of forfeitures applied to reduce the 2024 employer contributions.

**Notes Receivable from Participants** – Loans are not permitted by the Plan, however, participants with outstanding loan balances from a previous plan were permitted to transfer the loans to the Plan. Note terms range from one to five years and are secured by the balance in the respective participant’s account. The notes bear interest of 4.25% at December 31, 2024, and mature through October 2026. Principal and interest are paid ratably through regular payroll deductions.

**Plan Termination** – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall become 100% vested in their accounts at the date of such termination.

**Payment of Benefits** – A participant will be eligible for payment of benefits upon attaining normal retirement age, age 59 1/2, financial hardship, disability, or death, prior to termination or severance date. Upon termination of service, a participant may receive a lump sum or installment amounts equal to the vested value of his or her account.

**Administrative Expenses** – Administrative expenses are paid by both the Plan Sponsor and the participants.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan determines the fair value of assets and liabilities, which are subject to reporting at fair value based on standards established within accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets, which are not actively traded, or market prices of similar assets or liabilities, which are actively traded on an exchange.

Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Following is a description of the valuation methodology used for investments measured at fair value as of December 31, 2024 and 2023:

*Mutual funds:* Valued based on the quoted market prices available on an active market, which represents net asset values (“NAV”) of the shares held by the Plan at year-end.

*Stable value fund:* The fund primarily holds guaranteed and other similar investment contracts, which are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan at year-end using NAV contract value, and generally has no redemption restrictions or unfunded capital commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis.

*Payment of Plan Benefits* – Benefits are recorded when paid.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

*Risks and Uncertainties* – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Subsequent Events* – Management has evaluated the effects of all subsequent events through September 10, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

### 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures. For additional information on how the Plan measures fair value, refer to Note 2 – Summary of Significant Accounting Policies. The following table sets forth, by level within the fair value hierarchy, the Plan’s assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the stable value fund, which is measured at fair value using the NAV practical expedient. The fair value for the stable value fund is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

### 4. INCOME TAX STATUS

The Plan has adopted the Actuarial Consulting Services Inc. Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA (the “Pre-approved Plan”). The Pre-approved Plan received an Opinion Letter from the IRS dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Code for use by employers for the benefit of their employees. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.
