### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Antero Resources Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Antero Resources Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established on January 1, 2003 and most recently amended on January 1, 2022. The Plan is available to all full-time employees of Antero Resources Corporation (the "Company") who are age 21 or older. The entry date for eligible participants is the first day of each calendar month coinciding with or following the date on which an employee meets the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the administrator of the Plan. T. Rowe Price Trust Company (T. Rowe Price or the "Custodian") functions as the custodian and recordkeeper. IMA Wealth serves as the 3(38) fiduciary and investment advisor. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

#### **Contributions**

Participants may make before-tax and after-tax Roth contributions up to 75 percent of their annual eligible compensation, as limited by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions.

The Plan is operating pursuant to the safe harbor provisions of Internal Revenue Code Section 401(k)(12). For the year ended December 31, 2024, the Company's safe harbor matching contributions were 100 percent of elective deferrals up to 6 percent of eligible compensation. The Company has the right to designate all or a portion of the matching safe harbor contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. The Company may also make discretionary nonelective contributions. Nonelective contributions will be allocated to all eligible employees based on a uniform percentage. No nonelective contributions were made during 2024.

#### **Participant Accounts**

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, plan earnings or losses, and forfeitures and charged with an allocation of administrative expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in their voluntary, rollover, and qualified safe harbor matching contributions and allocated earnings or losses thereon.

**Note 1 - Plan Description (Continued)**

Any employer nonelective contributions and nonqualified safe harbor employer contributions (including forfeitures) and the earnings or losses thereon not fully vested when contributed will vest as follows:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of one loan outstanding at any given time. The notes receivable are secured by the balance in the participant's account; bear interest at rates that range from 4.25 to 9.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination; and mature at various dates through April 2039. Loans have a maximum term of 5 years unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 15 years from the date of the loan origination. Principal and interest are paid ratably through monthly payroll deductions, and employees may make direct payments to the Custodian. Participant loans are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest).

Deemed distributions are defined by the Plan as outstanding loans from terminated employees, which cannot be repaid through payroll deductions; therefore, they are treated as distributions to the participants and are removed from the outstanding loan balances. Loans in the amount of \$2,098 were deemed a distribution in the current year.

***Benefit Payments***

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump sum or installment payments in the amount equal to the participant's vested account balance.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Participants who are granted a hardship withdrawal are not allowed to make contributions for the six months following such withdrawal. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay plan expenses or reduce employer contributions or shall be allocated to participants in the same manner as the employer's contribution.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by T. Rowe Price or its affiliates. T. Rowe Price is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 1 - Plan Description (Continued)

T. Rowe Price provides certain administrative services to the Plan pursuant to a plan record-keeping agreement (PRA) between the Company and T. Rowe Price. T. Rowe Price receives revenue from mutual fund service providers for services T. Rowe Price provides to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan.

If the revenue received by T. Rowe Price from such mutual fund providers exceeds the amount owed under the PRA, T. Rowe Price remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2023, there were no excess amounts. The Plan or plan sponsor may make a payment to T. Rowe Price for administrative expenses not covered by revenue sharing.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

Investments are recorded at fair value, as reported to the Plan by the Custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) committee determines the Plan's valuation policy utilizing information provided by the investment advisors, including the appointment of investment managers and the monitoring of the performance of the Plan's investment funds

Investments in mutual funds and the money market fund are reported at the last reported sale price at the end of the respective periods using quoted market values.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 11, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

T. Rowe Price holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by T. Rowe Price.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
