INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Paramark Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Paramark Corp. 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees (union and non-resident alien employees are not eligible) of Paramark Corp. (the Company). The Plan became effective January 1, 2018. The Plan was last amended and restated effective January 1, 2024. The Plan has been periodically updated to comply with the various regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration – The Plan is administered by the Company and advised by an external third-party consultant. The Custodian of the Plan's assets is Alerus Financial, N.A. (the Custodian). The Custodian executes transactions based upon direction from the Plan's administrator and the Plan's participants.

Participation – To be eligible for the Plan, employees must be age twenty-one or older and have completed six months of consecutive service following the date of hire to begin deferring salary reduction contributions. Entry dates begin on the first day of the month following the completion of the initial requirements.

Contributions – Contributions to the Plan include pre-tax and post-tax (Roth) salary reduction contributions, rollover contributions, catch-up contributions, and the Company's discretionary nonelective and/or matching contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

Participant salary reduction contributions are initially set up through an automatic contribution arrangement. The automatic contribution arrangement begins with salary reduction contributions of 5% with auto escalation of the deferral percentage by 1% annually up to a maximum of 10%, absent an election for a different deferral percentage by the participant. Participants are allowed to make an election to "opt out" of the automatic contribution arrangement if they prefer to set up their own contribution arrangement. Participant salary reduction contributions are allowed up to the limits prescribed by law.

Requirements to receive an allocation of employer discretionary matching and/or non-elective contributions are the same as those for an employee to be eligible to make salary reduction contributions. Employer discretionary matching contributions for 2024 and 2023 were \$118,510 and \$114,237, respectively. There were no discretionary non-elective employer contributions for 2024 or 2023.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Participant Accounts - Each participant's account is updated to include the participant's contributions and distributions, if any, and an allocation of (a) the Company's contribution, (b) plan earnings (losses), and (c) plan expenses, as applicable. The Plan uses a daily valuation system for each participant's individually directed account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participants' funds are invested in various mutual funds held by the Custodian.

Vesting – Employer discretionary matching and non-elective contributions are fully vested after five years of service. A participant is also 100% vested upon death, becoming disabled, or reaching normal retirement age. Participants are fully vested at all times in all other contribution types. Participants vest as follows:

Benefit Payments – On termination of service, disability, death, retirement, reaching normal retirement age, or reaching age 59 ½, participants or their beneficiaries, as applicable, are eligible to receive a distribution in an amount equal to the participant's vested account balance. If the participants' vested account balance is less than \$1,000, the Plan will distribute the vested account balance in a lump-sum payment with or without the participant's authorization. If the participant's balance is greater than \$1,000 but less than \$5,000, the Plan will, absent an election otherwise from the participant, roll the participant's balance over to an individual retirement account (IRA) set up for the benefit of the participant. If the participant's vested account balance exceeds \$5,000, the participant may elect to take a lump-sum distribution or leave their vested account balance in the Plan. Participants are also able to take a hardship distribution from their vested account balance in an amount not to exceed the participant's financial hardship, as defined by the Plan document.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Basis of Accounting

The financial statements are prepared on the accrual basis from the financial records supplied by Alerus Financial, N.A., the Custodian.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Benefit Payment

Benefit payments are recorded upon distribution to participants.

Notes Receivable from Participants

The plan does not allow for participants to borrow from their fund accounts.

Expenses

Expenses of maintaining the Plan are paid by the Plan and the Plan Sponsor. Administrative expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Forfeitures

Forfeited, nonvested amounts may be used to pay plan expenses, allocated as an additional discretionary nonelective contribution, allocated as an additional discretionary matching contribution, used to reduce any nonelective contribution, or used to reduce any matching contributions. Forfeited accounts totaled \$24,490 and \$12,976 during 2024 and 2023, respectively. Forfeitures in the amount of \$19,740 and \$9,209 were used to reduce plan expenses during December 31, 2024 and 2023, respectively. There were \$11,838 and \$6,393 of unallocated forfeitures to be used for the purposes noted above as of December 31, 2024 and 2023, respectively.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Financial Information Certified by the Custodian

Alerus Financial, N.A. (the Custodian) has provided the Plan Administrator with certifications as to the completeness and accuracy of total cash and investments of the Plan held by the Custodian aggregating \$1,764,108 and \$1,458,124, as of December 31, 2024 and 2023, respectively, and the related investment income of \$200,466 and \$191,823 for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedules based upon certifications from the Custodian.

Under the terms of the custodial agreement, the Custodian has non-discretionary authority over Plan assets and maintains investment funds on behalf of the Plan. The Custodian has been granted authority to make purchases and sales of investments at the direction of the Company and plan participants and maintains records of all participant and Plan transactions and accounts.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobserved inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds: The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Certain plan investments include mutual funds that are managed by Alerus Financial, N.A. (the Custodian); and therefore, these transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Certain employees of the Company provide accounting and administrative services for the Plan for which no fees are charged. These transactions are also permitted under ERISA regulations.

5. Tax Status

The prototype plan document utilized by the Plan has obtained an IRS opinion letter, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

6. Risks and Uncertainties

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect amounts reported in the statements of net assets available for benefits and participant accounts.

7. Other Matters

In 2024, it was determined that \$71,317, of employee deferral contributions were not remitted to the Plan within the time period prescribed in the Code of Federal Regulations (CFR). Lost earnings have been paid into the plan during 2024 for the late remittances.

8. Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 29, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.
