Our opinion has not been modified with respect to this matter.

Note 1 - Plan Description

The following description of thyssenkrupp 401(k) Plan North America (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by thyssenkrupp North America, LLC (the "Company") covering all eligible employees of the Company and its U.S. affiliates. Effective January 1, 2021, employees are eligible to participate in the Plan after completing 90 days of service and reaching 18 years of age. Previously, employees were subject to eligibility requirements defined by legacy plan documents.

The Plan's investments are managed by the trustee, Fidelity Management Trust Company (Fidelity), and disbursed to specific investment option offerings in proportions directed by each participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Subsequent to year end and effective January 1, 2025, an addendum to the existing plan document was adopted, which outlines the plan provisions, including the vesting schedule and normal retirement age, applicable to participants who merged or transferred into the Plan on December 31, 2024, as outlined in Note 3.

Contributions

Employee contributions represent a percentage of each eligible participant's pretax or after-tax earnings, as defined in the plan agreement, and are subject to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible employees not enrolling in the Plan within 30 days are automatically enrolled in the Plan at a pretax contribution amount of 3 percent of eligible compensation. All participants with a deferral rate greater than 0 percent are subject to automatic deferral increases at a rate of 1 percent annually until a deferral rate of 10 percent is reached. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Eligible nonunion employees receive safe harbor matching contributions equal to 100 percent of the first 3 percent of the participant's eligible contribution and 50 percent of the next 4 percent of the participant's eligible contribution. Additional participant contributions beyond 7 percent are not matched by the Company for these participants.

Eligible union employees receive matching contributions in various amounts determined under applicable collective bargaining agreements. The Plan also provides that the Company and its U.S. affiliates may make annual discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of company matching contributions and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in their elective deferrals and rollover contributions plus actual earnings thereon.

Participants vest in the Company's safe harbor matching contribution at 50 percent after one year of service and are fully vested after two years of service. Discretionary employer contributions vest 25 percent after two years of service and are fully vested after five years of service.

Note 1 - Plan Description (Continued)

In addition, participants who were eligible for the Plan prior to January 1, 2021 are fully vested in all pre-2021 safe harbor matching contributions.

For certain union matching contributions, employer contributions will vest 40 percent after one year of service and another 20 percent per year thereafter until becoming fully vested after four years of service. Effective April 1, 2023, certain union matching contributions vest at 50 percent after one year of service and are fully vested after two years of service.

In 2006, the Plan was considered partially terminated due to a substantial reduction in the number of plan participants. Accordingly, all participants affected by the partial termination became 100 percent vested in their entire account balances during 2006.

Effective December 31, 2024, for participants who merged into the Plan, as outlined in Note 3, all employer contributions are immediately 100 percent vested, with the exception of certain union employees in which the company match vests 100 percent after three years of service.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan agreement.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trustee shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Certain administrative expenses of the Plan are paid by the Company and qualify as party-in-interest transactions.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. The stable value common/collective trust fund has certain limitations on withdrawals and exchanges as follows:

Participant directed: Withdrawals made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

Non-participant directed: Withdrawals directed by a plan sponsor must be preceded by a 12-month written notice to Fidelity Management Trust Company. However, Fidelity may, at its discretion, complete any plan-level withdrawal before the expiration of such 12-month period. No such notice has been given to Fidelity.

There are no unfunded commitments or other redemption notice requirements with this class.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Additionally, the Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities and short-term cash. All other investments are valued based on quoted market prices. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

December 31, 2024 and 2023

Note 3 - Plan Merger and Transfers

Effective December 31, 2024, ThyssenKrupp System Engineering, Inc. 401(k) Plan, a plan sponsored by an affiliate of the Company, merged into the Plan. Accordingly, assets of approximately \$59 million were transferred into the Plan on this date.

In addition, effective December 31, 2024, thyssenkrupp Uhde USA, LLC was added as a participating employer in the Plan. Concurrently, all participant accounts of thyssenkrupp Uhde USA, LLC were transferred from thyssenkrupp Polysius North America, Inc. 401(k) Plan, a plan sponsored by an affiliate of the Company, to the Plan. Accordingly, assets of approximately \$9 million were transferred into the Plan on this date.

Note 4 - Certified Information

Fidelity (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements require judgment and consider factors specific to each asset.
