## INDEPENDENT AUDITORS' REPORT

To the Administrator of  
The Wrench Group Retirement Plan  
Marietta, Georgia

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Wrench Group Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Wrench Group Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520-103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Wrench Group Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Wrench Group Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but it is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Description of plan:

The following description of The Wrench Group Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was created on January 1, 2018 and is a defined contribution plan covering substantially all employees of The Wrench Group and its subsidiaries: New Abacus, LLC d/b/a Abacus Plumbing and Air Conditioning, B.S.&S. Services, Inc. d/b/a Berkeys Air Conditioning & Plumbing, Baker Brothers Rotovision, Inc., Coolray Heating & Cooling, Inc., N&M Cooling and Heating, Inc., Donovan Heat and Air, LLC, Ragsdale Heating and Air, LLC, Plumblin Services, Inc., Environmental Conditioning, Inc., On Time Air Conditioning and Heating, Inc. d/b/a Service Champions, All About Family Home Services, LLC, Williams Comfort Air, LLC, Boothe's Heating-Air Conditioning-Plumbing, LLC, Morris Jenkins, LLC, Red Cap Plumbing & Air, LLC, Nexgen Air Conditioning & Heating, Inc., Coolray Heating & Cooling, LLC, and Mountain Air Conditioning and Heating, LLC. See amendment below for additional subsidiary added in 2024. All entities are collectively referred to as the Company, the Plan Sponsor, or the Plan administrator.

The Plan's eligibility requirements are as follows: eligible employees must be at least 18 years of age and complete one month of service to enter the Plan. Eligible participants may enter the Plan on the first day of the month following attainment of eligibility requirements. All employees of the Company are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan amendment

During the year ended December 31, 2024, the Plan was amended to add Lindstrom Air Conditioning, Inc. as a participating employer.

#### Contributions

Employees are automatically enrolled in the Plan after attaining eligibility unless they elect otherwise. Automatically enrolled employees are enrolled at a 3% deferral rate unless they elect another deferral rate. Participants may elect to contribute up to 100% of eligible pre-tax or post-tax compensation, up to current Internal Revenue Service (IRS) limitations through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch up contributions. The Company may make a discretionary matching contribution. Participants who have met the criteria to participate in the Plan become eligible for discretionary matching contributions on the first day of the month following the completion of 1,000 hours of service. For the year ended December 31, 2024, the Company matched 30% of the participant's deferrals up to the first 6% of eligible compensation, as defined. The Company also has the option to provide discretionary employer profit-sharing contributions, which are allocated to all eligible participants in accordance with the Plan document. The Company made no discretionary profit-sharing contribution for the 2024 Plan year.

The Plan also has a Roth contribution provision which gives participants the option of also contributing amounts to their individual Roth accounts which are maintained separately from pre-tax contributions. Roth contributions are matched at the same rate as pre-tax contributions as noted above.

Participants may direct both employee and employer contributions to any of the Plan's fund options. Participants may change their investment options daily and their deferral elections each pay period.

#### Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, if any, Plan expenses, and Plan earnings.

Allocations of profit-sharing contributions are based on eligible compensation as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$75,511 and \$55,896, respectively, and are included in the Key Guaranteed Portfolio Fund. Forfeited non-vested accounts may be used to pay Plan expenses or reduce employer matching contributions. During the year ended December 31, 2024, \$23,500 of forfeitures were used to pay Plan expenses and \$254,382 of forfeitures were used to reduce employer contributions to the Plan.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The Company's matching and/or profit sharing contributions, plus actual earnings thereon, become vested in accordance with the following schedule:

1	20%
2	40%
3	100%

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company.

#### Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Participants are required to take distributions as lump-sum payments, with the exception of required minimum distributions. In-service withdrawals of a participant's account are permitted at age 59 1/2 and in cases of proven financial hardship. If a participant's account balance is \$5,000 or less upon termination of service, a distribution of the participant's account will be made automatically in a single lump-sum cash distribution.

#### Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to 30 years for the purchase of a primary residence. Participants may only have one note outstanding at any given time. Notes are secured by the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may prepay their notes at any time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Administrative expenses

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan Sponsor. The Company pays a portion of administrative expenses of the Plan. Fees charged for processing notes receivable from participants, as well as other account transaction fees, are charged directly to the accounts of applicable participants. Total administrative fees paid by the Plan during the year ended December 31, 2024 totaled \$1,451,875.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Guaranteed investment contract

The Plan has a guaranteed investment contract with Empower Annuity Insurance Company of America (EAIC) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the

contract, and prevailing market conditions. The crediting interest rate may not be less than 0%. The interest crediting rate is reset quarterly. The actual average yield earned by the Plan in 2024 was 1.41%. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

EAIC may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. Generally, a 90 day notice is required by either party to discontinue the contract. EAIC may elect to defer payment of the contract for up to 12 months after the contract is discontinued.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options, 3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or 4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, and 4) a material amendment to the agreements without the consent of the contract issuer.

### Investment valuation and income recognition

The Plan's mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Investment valuation and income recognition - continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Shares of registered investment company funds (mutual funds) are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Collective trust fund is valued at the net asset value (NAV) of units in the individual collective trust investment. The NAV is used as a practical expedient to estimate fair value, where the NAV is based on the underlying assets owned by the trust, less liabilities, divided by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### Payment of benefits

Benefits are recorded when paid.

##### Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Investments and information certified by the custodians:

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodians, Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

#### Note 4 - Party-in-interest transactions:

The custodians and their affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan also has a third party administrator. The Plan pays a portion of administrative expenses while the Plan Sponsor pays the remainder of administrative expense. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

The Plan has a services agreement with the custodians of the Plan whereby the Plan received revenue from contract asset charge fees related to investments of the Plan which was placed into a Plan Expense Reduction Account (PERA). The funds in the PERA could either be allocated to participants or used to offset amounts owed to the Plan's service providers for administrative and other services provided to the Plan. During the year ended December 31, 2024, the Plan received \$311,686 of PERA credits associated with the services agreement which are included in other income on the statement of changes in net assets available for benefits. During the year ended December 31, 2024, the Plan paid expenses totaling \$311,686 out of the PERA.

As of December 31, 2024 and 2023, the Plan had available \$0 of these monies for payment of future expenses.

#### Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

#### Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 1, 2021 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC.

#### Note 6 - Tax status - continued:

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

#### Note 7 - Prohibited transactions:

During the Plan years ended December 31, 2024, 2023, and 2022, the plan sponsor inadvertently failed to deposit \$46,223, \$381,248, and \$123,285, respectively, of participant deferrals and loan repayments on notes receivable from participants within the required timeframe as stated by the Employee Retirement Income Security Act of 1974 (ERISA). These deferrals and loan repayments on notes receivable from participants were deposited beyond the earliest expected date on which assets could be segregated from the employer's assets. The U.S. Department of Labor considers late deposits to be prohibited transactions. The plan sponsor has fully self-corrected the 2023 deposits and partially self-corrected the 2022 and 2024 deposits by calculating lost earnings on deferrals and loan payments on notes receivable from participants and deposited the lost earnings in 2024. Lost earnings on the remaining deferrals and loan repayments on notes receivable from participants of \$4,966 for the year ended December 31, 2022, and \$11,960 for the year ended December 31, 2024, respectively, will be calculated and deposited at a later date.

Additionally, operational errors regarding enrollment of new participants into the Plan and processing of deferral changes were discovered. The plan sponsor is working with its third party administrator to correct these errors.
