1. Description of Plan

The following brief description of the Evereve 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

Eligibility

The Plan is a defined contribution 401(k) plan covering all employees of Evereve Incorporated (the "Company") who have one year of service, worked 1,000 hours, and are age 21 or older. Beginning in January 1, 2022, the Plan was amended to also cover all employees who have 500 hours of service in their first 6 months of employment, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of pre-tax and post-tax (Roth) annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan matches 100% of the first 5% of compensation that a participant contributes to the Plan under a safe harbor matching contribution, on a per pay period basis. Additional profit sharing amounts may also be contributed at the discretion of the Plan Sponsor. For 2024, the Plan made safe harbor matching contributions of approximately \$1,027,000. There were no discretionary profit sharing contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan's discretionary matching contributions, and allocations of (a) the Plan's discretionary non-elective contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are 100% immediately vested in their employer safe harbor matching contributions. Employer profit sharing contributions are fully vested after 3 years of service.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future employer contributions to the Plan. There were no forfeited amounts that were used to reduce employer contributions to the Plan during 2024. At December 31, 2024 and 2023, there were \$295 and \$-, respectively, of forfeited nonvested account totals in the Plan.

1. Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the vested portion of the participant's account does not exceed \$5,000, the account balance may be paid out in a lump sum, rolled into an IRA or another qualified plan, or any combination of these when requested by the participant. However, when a request is not received, accounts with balances of less than \$1,000 will be automatically distributed and accounts with balances between \$1,000 and \$5,000 will be automatically rolled over into an IRA. If the vested portion of the participant's account exceeds \$5,000, the distribution will be made after the participant or beneficiary gives consent. The Plan allows participants to make hardship withdrawals, provided certain conditions are met. Hardship withdrawals are limited to the amount in the participant's elective deferrals account. In-service distributions are allowed for participants who are 100% vested and 59-1/2 years old.

2. Summary of Significant Accounting Policies

The following significant accounting policies were used to prepare the financial statements in conformity with accounting principles generally accepted in the United States of America.

Basis of Accounting - GAAP

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid.

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates and the difference could be material. The most significant estimate relates to the valuation of investments. It is at least reasonably possible that these estimates may change in the near term.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open end mutual funds that are registered with the U. S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of the units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair values of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through September 26, 2025, the date which the financial statements were available to be issued.

5. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and common/collective trust fund managed by Reliance Trust Company, an affiliate of T. Rowe Price Retirement Plan Services, Inc., the third party administrator. Reliance Trust Company is the custodian of the Plan; therefore, these are party-in-interest transactions. Fees paid by the Plan for investment management services amounted to approximately \$61,000 for the year ended December 31, 2024.

6. Tax Status

The Plan has adopted the DWC volume submitter plan. The volume submitter plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the prototype basic Plan document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan has adopted certain amendments. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

9. Secure 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. Most of the provisions of SECURE 2.0 will become effective in 2024 and beyond. Effective January 1, 2024 the Plan adopted following provision:

- Long-Term Part-Time (LTPT) Eligibility: Employees who have worked at least 500 hours per year for three consecutive years (from 2021 through 2023) are eligible and must be given the opportunity to participate in the Plan.
