NOTE 1 - DESCRIPTION OF PLAN

The following description of the M.I. Industries, Incorporated 401(k) Profit Sharing Plan (the Plan) provides only general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was established January 1, 2004 and was amended and restated August 1, 2023 to change the legal name of the Plan to M.I. Industries, Incorporated 401(k) Profit Sharing Plan. The Plan provides eligible employees of M.I. Industries, Incorporated and subsidiaries (the Corporation or Employer) the opportunity to make regular and systematic contributions through salary reductions. The Plan is subject to Section 401(k) of the Internal Revenue Code and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation and Contributions: All employees of the Corporation, except residents of Puerto Rico, who have at least 1 month length of employment can participate in the Plan. The Plan entry date is the first date of each month. The auto deferral rate begins at 6%. Each eligible employee who elects to participate in the Plan may contribute any whole percentage of their compensation per payroll period. In addition, the Plan allows "catch-up" elective deferral contributions under Code Section 414(v) for those participants who have obtained age 50 by close of the Plan year. Participants may also contribute amounts from other qualified defined benefit or defined contribution plans. The Employer may make matching contributions to the Plan at the discretion of the Plan Administrator and Trustees. The Plan contributes a safe harbor matching contribution equal to 100% of the first 4% of contributed compensation for the year ended December 31, 2024. Employer matching contributions are allocated to the participants' accounts each payroll period based on the employee voluntary deferrals.

Participant Accounts: Each participant's account is credited with the participant's contribution, employer matching contributions, and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. All amounts credited to a participant's account are invested by the custodian based on the investment direction of the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their own contributions and any employer safe harbor matching contributions. Participants are vested in other employer contributions based on a 6-year graded vesting schedule.

Withdrawals: Withdrawals are not permitted before the age of 59-1/2, except in the event of death, disability, financial hardship or termination of employment.

Payments of Benefits: Benefits are payable in either a lump-sum amount up to the value of a participant's vested interest in their account balance or annual installments.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear varying rates of interest, which are commensurate with local prevailing rates as determined by the plan administrator.

Investment Options: Each participant can direct their contributions into any of the investment options available under the Plan.

Forfeitures: Forfeitures of non-vested employer contributions are used to pay Plan expenses and reduce future employer contributions. Forfeitures of \$6,095 were used to pay Plan expenses in 2024. The Plan had unallocated forfeitures of \$25,370 and \$36,005 at December 31, 2024 and 2023, respectively.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Corporation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of the significant accounting policies followed in the preparation of the Plan's financial statements:

Accounting Method: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The investment contract with the insurance company is reported at contract value. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from participants are recorded in the period the Employer withholds payroll deductions from Plan participants. Employer contributions are recorded as determined by the Plan Administrator and Trustees.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Benefit Payments: Benefit payments are recorded when paid.

Use of Estimates in the Preparation of Financial Statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan provides for various investment options. The underlying investments are exposed to various risks, such as interest rate, market, liquidity, credit, and global events. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events: Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosure within the financial statements. Management has performed their analysis through October 7, 2025, which is the date that the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ameritas Life Insurance Corp.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The net asset values of the subaccounts are updated daily based upon the investment performance of the underlying mutual fund they invest in less a deduction for charges. The Ameritas Life Insurance Corp. Separate Account D is comprised of numerous subaccounts with each investing in a single mutual fund managed either by an affiliate of Ameritas Life Insurance Corp. or by an independent third party. Participants direct their investments to certain of the underlying "subaccounts" of the Ameritas Life Insurance Corp. Separate Account D available to them under the Plan. Each subaccount provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a traditional fully benefit-responsive investment contract (FBRIC) with Ameritas Life Insurance Corp. (Ameritas) which is the Guaranteed Investment Account. The FBRIC is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Ameritas maintains the contributions in its general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of Ameritas or otherwise.

NOTE 5 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Corporation, and certain other Corporation-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which Ameritas may terminate the contract. Examples of circumstances that would allow Ameritas to terminate the contract include the Plan's loss of its qualified status or material and adverse changes to the provisions of the Plan. If one of these events were to occur, Ameritas could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intention to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS AND REPORTING

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest include any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. The Plan holds units of pooled separate accounts managed by Ameritas and a fully benefit responsive investment contract with Ameritas. Ameritas is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Ameritas qualify as party-in-interest transactions. The Corporation provides certain administrative services and pays for certain professional services to the Plan for which it receives no compensation. Investment management fees are paid by the Plan to investment managers and these expenses are reflected in the financial statements as a reduction of the return on the Plan's investments. The Plan had notes receivable from participants which are considered party-in-interest transactions.
