NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of Plan

The following description of the Southeast Unloading, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description and the adoption agreement for a more complete description of the Plan's provisions.

General

The Plan, originally effective August 1, 2008, and most recently amended January 1, 2023, is a defined contribution plan covering all employees of Southeast Unloading, LLC (the Company) and participating employers who have completed 120 days of service and are age 18 or older. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees participating in the Plan may elect to contribute either pre-tax or Roth after-tax deferrals up to the maximum of \$23,000 allowed under the Internal Revenue Service (IRS) limitation for calendar year 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 to the Plan in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts. Upon completion of eligibility requirements, the Plan provides for an automatic participant deferral of 6% of the participant's compensation, as defined, unless the participant makes a contrary election. The deferral percentage will automatically increase by 1% on January 1 of each Plan year, up to a maximum of 10%.

Prior to January 1, 2023, the Plan allowed for the Company to make a discretionary matching contribution equal to a uniform percentage, as determined annually, of each participant's elective deferrals. The Company could also elect to make an additional discretionary contribution each year to the Plan, subject to certain eligibility criteria, as defined.

Effective January 1, 2023, the Plan was amended to convert to a 401(k) Safe Harbor Plan, under which the Company will provide a safe harbor matching contribution equal to 100% of a participant's elective deferrals, up to 4% of eligible compensation.

Qualified Non-Elective Contribution (QNEC)

The Plan recorded QNECs totaling \$201,320 during the years ended December 31, 2023 and 2022, for certain participants who were not provided the opportunity to contribute their elected deferrals or did not receive the appropriate Company matching contribution due to certain administrative errors. Participants are immediately 100% vested in the QNECs. The contributions were made in accordance with IRS regulations and do not affect the tax status of the Plan. The QNECs were included in employer qualified non-elective contributions receivable in the accompanying statements of net assets available for benefits as of December 31, 2023 and were remitted to the Plan during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings, and charged with benefit payments and an allocation of the Plan's losses and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vested rights to Company contributions made prior to January 1, 2023, accrue at a rate of 20% per year beginning with the participant's second year of service with full vesting accruing after six years of service. Upon attaining normal or early retirement age, death, or permanent disability, Company contributions vest immediately.

Payment of Benefits

Upon termination of employment, retirement, disability, or death, if the participant's vested account balance does not exceed \$5,000, the participant may elect to receive the vested account balance in a single lump-sum payment. If the vested account balance is more than \$1,000 and the participant does not make an election, the Plan automatically will roll over the distribution to an individual retirement account. If the vested balance exceeds \$5,000, the participant may elect to receive a distribution in a single lump-sum payment or in a series of installments over time. Hardship withdrawals may be requested from employee deferrals and are paid in one lump-sum upon approval. In-service distributions from a participant's vested account balance may be made provided the participant has reached the age of 59 ½. One such distribution can be made in any 12-month period.

Forfeited Accounts

Any non-vested amounts remaining after the distribution of a terminated participant's account balance are forfeited. Forfeitures may be used to pay Plan expenses and reduce Company contributions. There were \$420 of unallocated forfeitures at December 31, 2024. There were no unallocated forfeitures at December 31, 2023. During the year ended December 31, 2024, \$6 of forfeitures were used to pay administrative expenses of the Plan and \$20,970 of forfeitures were used to reduce the Company's contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements, in accordance with U.S. generally accepted account principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Plan Expenses

The Company has elected to pay certain administrative expenses of the Plan. Expenses paid by the Company are excluded from the financial statements. Administrative expenses paid by the Plan include investment management and recordkeeping fees. Certain transaction fees for distributions are charged directly to the accounts of the participants who incur those fees. Certain investment-related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Any costs associated with the investment of a participant's account are charged to that participant.

Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024, as of October 1, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

Note 3 - Information Certified by Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company

The following is a summary of the Plan's financial information and data included in the Plan's financial statements and supplemental schedule of assets (held at end of year), which was certified by Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, as complete and accurate, as permitted by 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements

The Plan measures and reports its financial assets and liabilities using a three-tier hierarchy, which prioritizes the inputs used in measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts—The Plan holds units of participation in the separate accounts, which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the net asset values of the underlying funds, which are generally quoted in active markets, and the contract's separate account charges. The pooled separate accounts allow one transfer per 30-day period. Contributions into the investment option are not impacted. There are no unfunded commitments on these investments.

Mutual Funds—Valued as determined by quoted market price, which represents the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts—The Plan invests in certain Principal LifeTime Hybrid Collective Investment Trust funds maintained by Principal Global Investors Trust Company. These investments are valued at the net asset value of the units held by the Plan as determined by the issuer of the trusts based on the fair value of the underlying investments less liabilities. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments on these investments.

The Plan also invests in the Principal Stable Value Z Fund, which is a collective investment fund established, operated, and maintained by Principal Global Investors Trust Company. The Principal Stable Value Z Fund invests solely in the Morley Stable Value Fund, which invests in conventional, synthetic, and separate account investment contracts. The fund is valued at the net asset value of the units of the respective collective trust. The net asset value, as provided by the issuer of the fund, is used as a practical expedient to estimate fair value. The net asset value of shares held by the Plan at year-end are based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

Principal Global Investors Trust Company files a U.S. Department of Labor Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity for the Principal Stable Value Z Fund collective investment trust. Accordingly, certain disclosure requirements under the Financial Accounting Standards Board Accounting Standards Update 2015-12, with respect to investment strategies for investments measured using the net asset value practical expedient, are not required in this report.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 6 - Tax Status

The Plan sponsor has adopted a non-standardized pre-approved profit-sharing plan, which received a favorable opinion letter dated June 30, 2020, in which the IRS states that the pre-approved plan is in compliance with the requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain of the Plan’s investments were held and managed by Principal Life Insurance Company and Principal Global Investors Trust Company as of December 31, 2024 and 2023. Transactions in these investments qualify as party-in-interest transactions. Administrative fees paid to Principal Life Insurance Company totaled \$81,461 for the year ended December 31, 2024.

Note 8 - Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Non-Exempt Transactions

During the Plan years ended December 31, 2021 and 2023, the Company did not remit certain employee deferrals within the appropriate time period prescribed by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company has corrected certain of these late remittances and is in the process of correcting the remainder of them including depositing lost earnings into the Plan.
