## **INDEPENDENT AUDITORS' REPORT**

To the 401(k) Plan Administrative Committee  
Los Altos Golf & Country Club 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Los Altos Golf & Country Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Los Altos Golf & Country Club 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, adoption agreement, and amendments for a more complete description of the Plan's provisions.

General: The Plan, a defined contribution plan qualified under Section 401(k) and related provisions of the Internal Revenue Code, was established November 1, 1981, and was restated effective July 21, 2021. The Plan was designed to provide participants with a means to defer a portion of their compensation for retirement funds and to provide benefits in the event of disability, death or financial hardship. The Plan's 401(k) Plan Administrative Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Any employee who is not considered an excluded employee may participate in the Plan once certain requirements have been fulfilled. Excluded employees are: (1) union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless such agreement expressly provides for participation in the Plan and (2) leased employees. The requirements to participate consist of the employee being 21 years of age or older and has worked at least 1,000 hours during a one-year period from date of employment. Long-term part-time employees who have 3 consecutive years of service beginning after December 31, 2020 with at least 500 hours of service in each are also eligible to participate in the Plan. The entry dates for both employee and employer matching contributions are January 1 or July 1 of the plan year following the date the eligibility requirements are met.

Contributions: Under the Plan, participants may elect to make pre-tax and/or Roth 401(k) post-tax contributions annually up to 100% of their annual compensation up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Pretax contributions to a qualified plan are tax deferred and therefore are not included in a participant's compensation for federal income tax purposes until distributed to the participant. Roth contributions are made post-tax but Roth distributions are tax-free. The maximum contribution is normally adjusted annually by an inflation index. Eligible participants age 50 or older are permitted to make catch-up contributions. The maximum catch-up contribution was \$7,500 in 2024 and 2023.

The Club makes Nonelective Safe Harbor matching contributions equal to 100% of the employee salary deferrals, but not to exceed 6% of employee compensation. This matching contribution is fully vested under the safe harbor provisions. The Club contributed \$296,558 to the Plan in 2024.

Participants can make an In-Plan Roth Transfer. An In-Plan Roth Transfer allows a participant to transfer amounts from the vested portion of a pre-tax account to a Roth account. If a participant elects to make such a transfer, the amount transferred is included in income in the year the election is made. There were no In-Plan Roth Transfers in the Plan in 2024.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (continued): Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Club's safe harbor matching contributions and an allocation of the Plan earnings and administrative expenses based on the ratio of the participant's balance to all participants' account balances. Each participant directs how contributions made to the Plan are to be invested among the investment options available under the Plan.

Notes Receivable from Participants: The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance (reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date on which such loan is made, over the participant's outstanding balance of loans from the Plan as of the date such loan is made). The loans are secured by the balance in the participant's account. The term of the loan shall not exceed five years except in the case of a loan for the purpose of purchasing a principal residence. Repayment of loans must be made through payroll deductions of both principal and interest. The interest rate is based on prime rate as published in The Wall Street Journal plus 2% for the second business day of any given month for any loan the participant receives. The interest rates range from 5.25% to 10.50% as of December 31, 2024.

Vesting: Participants are immediately vested in their voluntary contributions, rollover contributions and employer matching contributions plus actual earnings thereon. Prior to November 1, 2004, the Plan had a vesting schedule for employer matching contributions. In November 2004, the Plan added a Nonelective Safe Harbor provision and removed the Discretionary Profit-Sharing Provision. The Nonelective Safe Harbor contributions are 100% vested.

Distributions to Participants: Distributions from the Plan are available upon any of the following situations: termination of employment at the Club, retirement, total disability, death, employee's reaching age 59-1/2 or qualified "financial hardship" or required minimum distributions. Following termination of employment, if a participant's vested account balance does not exceed \$5,000, a distribution of the participant's vested account balance will be made as soon as administratively feasible following termination, regardless of participant consent. If the automatic distribution is greater than \$1,000, and the participant does not elect to receive or roll over the distribution, the distribution will be automatically rolled over into an Individual Retirement Account (IRA).

Forfeitures: Forfeitures are created when participants terminate employment before they become 100% vested. Forfeitures can be applied to reduce the employer's matching contribution or administrative expenses payable under the Plan. Amounts forfeited by participants are related to contributions made to the Plan prior to November 1, 2004 when the Plan was converted to a Safe Harbor plan. There were \$250 in forfeitures as of December 31, 2024. The balance of forfeitures available was \$391 and \$137 as of December 31, 2024 and 2023, respectively.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value, except for the investment contract with an insurance company which is stated at contract value. For more information on valuation methods and inputs, please refer to Note G - Fair Value Measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. The Plan's investments are held in a trust administered by Empower Trust Company, LLC.

Contributions: Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from amounts paid. Matching contributions are recognized upon authorization as the underlying compensation is recognized. All participant and employer contributions are participant directed.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the Plan Administrator deems the notes receivable from participants to be in default, the notes receivable from participants' balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses are paid by the Plan, including loan setup and maintenance fees, which are deducted from participant accounts, if applicable.

Subsequent Events: Accounting Standards Codification (ASC) 855-10 *Subsequent Events* requires additional disclosure for events or transactions that occur after the statement of net assets available for benefits date. There were no subsequent events as of October 6, 2025, which is the date the financial statements were available to be issued.

#### **NOTE C - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a group annuity investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company maintains the contributions in a general account, Guaranteed Portfolio Fund. The contract is included in the financial statements at contract value as reported to the Plan by Empower Annuity Insurance Company. Contract value represents contributions made under the contract, plus earnings and transfers, less participant withdrawals, transfers, and administrative expenses. The group annuity investment contract is not considered fully benefit responsive.

#### **NOTE D - INCOME TAX STATUS**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan sponsor believes that the Plan is designed, and is currently being operating, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE E - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Plan has an investment contract with an insurance company managed by Empower Annuity Insurance Company of America. Empower Trust Company, LLC is the trustee as defined by the Plan and is affiliated with Empower Annuity Insurance Company of America, therefore, these transactions qualify as party-in-interest transactions.

In addition, notes receivable from participants are party-in-interest transactions.

#### **NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer contributions.

#### NOTE G - FAIR VALUE MEASUREMENTS

ASC 820-10, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) terms, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts*: Value of the pooled separate accounts are based on the net asset value provided by the fund manager and are calculated as the value of the underlying mutual funds owned by the funds, minus the liabilities, divided by the number of units outstanding. The net asset value includes some additional fees not included in the quoted price on active markets. As a result, the funds are classified as Level 2 inputs.

**NOTE G - FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
