1. DESCRIPTION OF THE PLAN

The following description of Scientific Drilling International Employee Saving and Investment Plan (the “Plan”) provides only general information. Participants should refer to the legal Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a qualified retirement plan generally covering employees of Scientific Drilling International, Inc. and affiliates (collectively, the “Company”). The Plan was originally effective on May 1, 1988, and was most recently amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

Vanguard Fiduciary Trust Company (the “Trustee”) is the trustee of the Plan. The duties of the trustee are to receive contributions and to invest and reinvest the trust assets of the Plan.

Eligibility

Employees, excluding those covered by a collective bargaining agreement, who complete one month of service are eligible to participate in the Plan on the first day of each respective payroll period following their date of eligibility.

Contributions

The Plan is a defined contribution plan to which participants may make pre-tax contributions from 1% to 100% of their compensation, as defined, during each year they are Plan participants, subject to certain limitations. Participants who have attained age 50 by December 31st of the calendar year are eligible to make catch-up contributions. Eligible employees are automatically enrolled in the Plan on a pre-tax basis at 3% of compensation, as defined. Participants are notified of the automatic enrollment and are given the opportunity to change their deferral rate or opt out of participation. On the first day of each subsequent Plan year, the deferral rate for participants that were automatically enrolled into the Plan will increase by 1% up to a maximum of 10%.

The Company may make discretionary employer matching contributions on behalf of all contributing participants regardless of service during the year or employment status. During 2024, the discretionary employer match matching contribution equal to 50% of the participant's salary deferrals up to a maximum of 6% of eligible compensation.

Additionally, the Company may make discretionary nonelective profit sharing contributions to eligible participants who are employed on the last day of the Plan year and who have completed three consecutive months of service during the Plan year, regardless of whether the participant is deferring a percentage of their own compensation. The profit sharing contributions are allocated to eligible participants in proportion of their base salary to total eligible participants' base salaries. The Company did not make any profit sharing contributions for the Plan year 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative Plan expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants become fully vested in the Company's contributions upon attainment of age 65, attainment of age 55 with two years of vested service, death, or disability. Vesting in the Company's contributions for all others is based on years of vesting service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 years or more	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The terms of the note are generally for up to five years, unless for the purchase of a principal residence which may be repaid over a longer period. The note is secured by the balance in the participant's account and bears interest at a commercially reasonable rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant may elect to withdraw funds from his or her account during his or her employment, subject to certain conditions. Upon termination of service, death or retirement, a participant may elect to receive a lump-sum payment equal to the entire vested portion of his or her account or a portion thereof. Installment payments are permitted for required minimum distributions. Upon termination, participants with a vested account balance of \$1,000 or less shall receive an automatic lump-sum distribution from the Plan equal to the entire vested portion of the account. For participants who terminate with a vested account balance of more than \$1,000 but less than \$7,000, the Plan Administrator shall make a direct rollover into an individual retirement account. Upon withdrawal from the Plan or termination of employment, participants may be subject to income taxes on contributions and income earned.

Forfeited Accounts

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. The Company may use forfeitures to pay Plan expenses or be used to reduce employer contributions.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$97,290 and \$61,468, respectively. For the year ended December 31, 2024, \$55,826 in forfeitures were utilized to pay the Plan's administrative expenses.

Plan Termination

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their accounts and no further contributions will be made to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events requiring disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends from investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by the Trustee.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust - Valued at the NAV of units held. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund.

Vanguard Retirement Savings Trust III is a collective investment trust fund that invests solely in the Vanguard Retirement Savings Master Trust (the “Master Trust”). There are no redemption restrictions upon which the participant may redeem investments in the trust. The underlying investments of the Master Trust are primarily in pools of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality bonds, bond and securities trusts and mutual funds. These investments have no unfunded commitments. The investments of the Master Trust are valued based on the aggregate market values of the applicable bonds, bond and securities trusts, and other investments. Total interest and dividends earned by the Plan in this fund for 2024 was \$237,066. The Plan's total interest in the Master Trust was 0.05% and 0.04% at December 31, 2024 and 2023, respectively.

5. TAX STATUS

The prototype plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the prototype plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (the “IRC”). The Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments include shares in mutual funds and a collective trust fund are managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
