Independent Auditor's Report

To the Administrative Committee of the
Society Hill Anesthesia Consultants, P.C. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Society Hill Anesthesia Consultants, P.C. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Empower Trust Company, LLC, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note A – Description of Plan

The following description of the Society Hill Anesthesia Consultants, P.C. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General. The plan is a profit-sharing plan with a “cash or deferred arrangement” authorized under Section 401(k) of the Internal Revenue Code, covering all employees of the Company who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to the maximum percentage allowable not to exceed the limits of Code Section 401(k). For 2024, the maximum deferral amount is \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. Each year, on a discretionary basis, the Company has the option of making matching contributions to be allocated in that proportion which an employee’s salary deferral bears to the total of all participants’ salary deferrals. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings or losses, and (c) forfeitures of terminated participants’ nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon as well as the company’s contributions, if any.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant shall receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$719 and \$694, respectively. These accounts will be reallocated to participants in the same manner as employer contributions.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees of the Plan include certain fees charged directly to individual participants, related directly to transactions or events associated with individual participant accounts. Expenses of administering the Plan are paid directly by the Plan Sponsor.

ERISA Spending Account. The Plan maintains an ERISA Spending Account that is funded from revenue sharing amounts received from investment providers. These funds may be used to pay eligible plan expenses as permitted under the Plan and applicable Department of Labor regulations.

ERISA Spending Account (continued). During the year ended December 31, 2024, revenue sharing credits of approximately \$5,399 were allocated to the ERISA Spending Account. No amounts were used during the year. The balance of the ERISA Spending Account totaled \$14,272 and \$8,463 as of December 31, 2024 and 2023, respectively. The ERISA Spending Account is held as a separate account within the forfeiture account and remains available for future use in accordance with the Plan's provisions.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/Collective trusts: The Plan's investment in the Putnam Stable Value Fund is held in common/collective trusts and valued at the net asset value ("NAV") per unit as a practical expedient, in accordance with ASC 820. The NAV is determined by the trustee based on the fair value of the trusts' underlying investments. The Putnam Stable Value Fund's NAV reflects the fair value of its underlying fully benefit-responsive investment contracts, adjusted to contract value for participant transactions. Investments valued at NAV as a practical expedient are not classified in the fair value hierarchy.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Self-directed accounts: The fair values of the mutual funds, stocks and bonds within the self-directed brokerage accounts are based on quoted market prices (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statement of Net Assets Available for Benefits.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Note E – Putnam Stable Value Fund

The Plan invests in the Putnam Stable Value Fund, which is a collective trust fund designed to provide preservation of capital and a stable credited rate of return. The Fund primarily invests in fully benefit-responsive investment contracts issued by insurance companies and other financial institutions, as well as in fixed-income securities and related investments.

Fully benefit-responsive investment contracts are reported at contract value, which represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Participants may initiate permitted transactions with the Fund at contract value. There are no restrictions on participant-initiated withdrawals from the Fund, and no events occurred during the year that would limit the Fund's ability to transact at contract value.

The credited interest rate and average yield earned by the Fund for the year ended December 31, 2024 was 3.89%. There were no restrictions on participant-initiated transactions with the Fund, and no events occurred during the year that would limit the Fund's ability to transact at contract value.

The adjustment from fair value to contract value reflects the net difference between the Fund's fair value of underlying assets and the contract value promised to participants, which will be amortized over the duration of the underlying contracts.

Note F – Related Party and Party in Interest Transactions

The plan invests in self-directed accounts managed by Empower Trust Company LLC. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules. Participant loans also qualify as party-in-interest transactions. Fees paid by the plan for the investment management services amounted to \$95,751 for the year ended December 31, 2024.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note H – Tax Status

The Internal Revenue Service has determined and informed Heritage Administrative Services LLC by a letter dated March 22, 2021 that their prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and is exempt from federal income tax. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note I – Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note J – ERISA Bond Requirement

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets, and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the plan's sponsor maintained bond coverage in the amount of \$2,000,000.
