INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Synergy Medical Systems Retirement Plan
Eugene, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Synergy Medical Systems Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Synergy Medical Systems Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Synergy Medical Systems Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Synergy Medical Systems Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Plan Description

The following description of Synergy Medical Systems Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan administrator oversees the governance of the Plan.

General

The Plan is a 401(k) profit sharing plan, effective on March 1, 2008, covering most full-time employees of Synergy Medical Systems, AMC Billing Services, and Team Makena (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees covered by a collective bargaining agreement and nonresident aliens are excluded from Plan eligibility. Employees are eligible to participate after reaching age 21 and attaining 3 months of consecutive service with 360 hours. Entry dates occur monthly on the first of the month. The Plan's most recent restatement was effective October 1, 2021.

Contributions

Participants may contribute up to 100 percent of annual compensation, as defined in the Plan, not to exceed statutory limits. Pre-tax and after-tax Roth deferrals are allowed. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan automatically enrolls new participants into the Plan at 3 percent increasing 1 percent per year up to 6 percent. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain limitations.

The Employer may also make a discretionary profit sharing contribution to eligible participants who are employed on the last day of the Plan year with 1,000 hours of service during the Plan year. The Employer did not make profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant account is credited with the participant's contribution and allocations of the Employer's contributions, Plan earnings (losses), and charged with an allocation of administrative expenses, when applicable. Allocations are based on participant earnings or account balances, as defined by the Plan documents. Participants may direct the investment of their accounts into various investments offered through the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions and actual earnings thereon. Participants shall become 100 percent vested upon attainment of normal retirement age, death, or permanent disablement. Vesting in Employer profit sharing contributions is based on the number of years of credited service. To earn a year of service, participants must be credited with 1,000 hours during a Plan year. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. A participant may not have more than two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the "prime rate" plus two percent which remains in effect for the duration of the loan. Loans have fixed rates for the term of the loan, not to exceed five years unless the loan is used for the purchase of a principal residence. Principal and interest may be paid through payroll deductions or by check.

Payment of Benefits

On termination of service due to death, disability, or early retirement, a participant (or their designated beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's account, installments, or annuity contracts. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or roll it over to another qualified plan. The Plan allows hardship distributions of elective deferrals and fully vested funds, subject to the Plan's rules governing hardship distributions. In-service withdrawals are permitted on fully vested funds once the participant has reached 59½ years of age.

Forfeited Accounts

Amounts that are not fully vested when participants terminate from the Plan are forfeited. These amounts are used to pay Plan administrative expenses or offset future Employer contributions. During the years ended December 31, 2024 and 2023, \$2,470 and \$2,195, respectively, was forfeited from participant accounts. During the years ended December 31, 2024 and 2023, forfeitures of \$4,128 and \$895, respectively, were used to pay Plan expenses. At December 31, 2024 and 2023, unused forfeited accounts were \$-0- and \$1,658, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Contributions

Participant contributions are recorded in the year in which they are withheld from compensation.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan, including third-party administration and audit fees, are paid by the Employer and are therefore excluded from these financial statements. Administrative expenses may be paid from participant accounts at the Employer's election. Fees for certain distributions and participant loans are included in administrative expenses and charged directly to the participant's account.

Excess Contributions Payable

At December 31, 2024 and 2023, a liability of \$24,494 and \$20,272, respectively, was recorded for amounts refundable by the Plan to participants for deferral contributions deposited in excess of elected or allowable amounts, including as a result of required compliance testing. This amount is included as excess contributions payable, with a corresponding corrective distribution on the accompanying financial statements.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employee contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations of Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

4. Tax Status

The Plan adopted a prototype non-standardized pre-approved profit sharing plan with CODA sponsored by Ascensus LLC that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated the prototype adopted by the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their accounts.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards of Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

7. Fair Value Measurements, continued

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. All mutual funds held by the Plan are open-ended funds registered with the SEC and are deemed to be actively traded and have a readily determinable fair value. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common/collective trust: Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used to estimate fair value, and are considered to be valued at Level 2 within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are managed by an affiliate of the trustee of the Plan, and therefore these transactions qualify as party-in-interest transactions. Administrative fees paid directly to The Vanguard Group, Inc. from Plan assets totaled \$8,745 and \$8,182 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
