## INDEPENDENT AUDITORS' REPORT

To the Participants, Advisory Committee, and Plan Administrator of the  
Better Being Co. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Better Being Co. Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

## NOTES TO FINANCIAL STATEMENTS

### (1) Description of the Plan

The following description of the Better Being Co. Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

- A. **General** – The Plan, which commenced on October 1, 1989, is a defined contribution plan covering all eligible employees of Nutraceutical Corporation (dba Better Being Co.) and its subsidiaries (the "Company" or "Plan sponsor"), as defined in the Plan document. The Plan is designed to qualify under Sections 401(a) and 401(k) of the Internal Revenue Code (the "IRC") as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Advisory Committee is responsible for oversight of the Plan. The Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan has arranged for Fidelity Management Trust Company ("Fidelity" or "Trustee") to serve as Trustee, and Fidelity Workplace Services, LLC (the "recordkeeper"), to provide record keeping services for the Plan.

Plan Change – Under the provisions of the SECURE 2.0 act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

- B. **Contributions** – Eligible employees may participate in the Plan upon completing one month of service and may elect to contribute up to 75% of their annual eligible earnings on a pre-tax basis or Roth contributions, plus catch-up contributions, subject to the maximum amount allowable by the Internal Revenue Service ("IRS") (\$23,000 for participants to age 50 and \$30,500 for participants over 50 years of age for the year ended December 31, 2024). Entrance to the Plan occurs on the first day of each month. Participants may also contribute amounts representing distributions from other tax qualified retirement plans.

Safe harbor employer matching contributions are made annually by the Company if the employee has participated in the Plan during the year. The amount is contributed each pay period based on a match of 100% of the participant's elective deferral for the pay period up to 4% of the participant's eligible earnings. A true-up contribution is made at year-end based upon the employees' annual deferrals. In addition, the Company may make discretionary nonelective contributions to the Plan each year in amounts determined by the Company. There were no discretionary nonelective contributions made during the year ended December 31, 2024.

- C. **Participant investment accounts** – The Plan currently offers various mutual funds, common collective trust, and a money market account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.
- D. **Participant accounts** – Each participant's account is credited with the participant's contributions, an allocation of the Company's safe harbor employer matching contribution, discretionary nonelective contributions, and the Plan's earnings and losses, which include administrative expenses. Allocations are based on participants' earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. **Vesting** – Participants are immediately vested in their voluntary contributions, earnings thereon, and rollover contributions. Participants also immediately vest in the Company's safe harbor matching contributions and discretionary nonelective contributions.

## NOTES TO FINANCIAL STATEMENTS

### (1) Description of the Plan (continued)

- F. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance with terms from 1 year up to 5 years. Loans related to the purchase of a primary residence are allowed to have terms up to 10 years. The loans are secured by the balance in the participant's account and bear interest at the prevailing market rate. Interest rates on outstanding loans currently range from 4.25% to 9.50%. Principal and interest are paid ratably through semimonthly payroll deductions and loan payoffs may be made directly by the participant without penalty.
- G. **Payment of benefits** – Participants may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Benefit payments are made in a lump sum distribution or rollover contributions to another plan. Participants terminating employment with account balances of less than \$1,000 may receive a force-out lump sum distribution from the Plan upon termination. Participants terminating employment with a balance between \$1,000 and \$7,000 may have their account balance rolled by the Plan into an Individual Retirement Account upon termination. Participants who terminate with a balance of greater than \$5,000 are not subject to these automatic distribution provisions.
- H. **Forfeited accounts** – As of December 31, 2024 and 2023, forfeited non-vested accounts in the Plan totaled \$0. Forfeited non-vested accounts primarily represent corrections of account balances or excess employer contributions. During the year ended December 31, 2024, no forfeited non-vested amounts were used to offset safe harbor employer matching contributions or administrative expenses.

### (2) Summary of significant accounting policies

**Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of estimates** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Advisory Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** – Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Safe harbor employer matching contributions and discretionary nonelective contributions, if any, are recorded in the year in which the associated participant compensation was earned.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred.

### (2) Summary of significant accounting policies (continued)

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Certain expenses for maintaining the Plan are paid directly by the Company and are not included in the statement of changes in net assets available for benefits. Expenses related to investment advisory services, management fees, maintenance of participant accounts, Plan audits, and Plan administration are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### (3) Information prepared and certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments and notes receivable from participants:

- Investments at fair value
- Notes receivable from participants
- Interest income from notes receivable from participants
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### (4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Money market account:* Valued at the daily closing price as reported by the account. The money market account held by the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. This account is required to publish its daily NAV and to transact at that price. The money market account held by the Plan is deemed to be actively traded.

The collective investment trust account listed in the above tables is redeemed on a daily basis and does not have any redemption restrictions. Additionally, there are no unfunded commitments.

### (5) Party-in-interest transactions

Certain investments of the Plan are managed by Fidelity Management Trust Company. Fidelity is the Plan's Trustee and recordkeeper, and therefore, the transactions are considered exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. As described in Note 2, certain other administrative expenses are paid from Plan assets and qualify as party-in-interest transactions. Administrative expenses paid from Plan assets directly to parties-in-interest totaled \$105,864 for the year ended December 31, 2024.

### (6) Plan termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### (7) Tax status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirement of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (8) Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(8) Risks, uncertainties, and concentrations (continued)**

As of December 31, 2024, one of the Plan's investments represented approximately 20% of the Plan's total investments. As of December 31, 2023, one of the Plan's investment represented approximately 18% of the Plan's total investments.

**(9) Delinquent participant contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended December 31, 2024, employee contributions and participant loan repayments totaling \$201,636 for 2023 and \$16,030 in 2024 respectively, were not remitted to the Plan until after the required time period. Lost earnings were remitted to the Plan in January, February, March, and October 2025 to correct these delinquent participant contributions.

**(10) Subsequent events**

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.
