Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Beldon Roofing & Remodeling Co. NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of Beldon Roofing & Remodeling Co. Employees 401(k) Plan (the Plan) are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participants' Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus accrued interest. Interest income is recognized on the accrual basis. No allowance has been recorded at either year end.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report, the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

NOTE B – PLAN DESCRIPTION

The following description provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Beldon Roofing & Remodeling Co. Employees 401(k) Plan is a defined contribution plan covering substantially all employees of Beldon Roofing and Remodeling Co. and its subsidiaries and affiliates (Plan Sponsor) who have 90 days of service and are age 18 or older. The Plan is for the exclusive benefit of participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain 100% vested in their accounts.

Contributions: Participants may contribute from 2% to 100% of their eligible compensation, subject to certain limitations of the Internal Revenue Code. The employer may contribute to the Plan each year a discretionary amount, which is allocated to all employees who participated in the Plan. The Plan Sponsor elected not to make matching contributions to the Plan in 2024 and 2023. Participants may also contribute amounts representing distributions ("rollovers") from other qualified plans. The Plan has an automatic enrollment provision (2% salary deferral) whereby employees must elect out of the Plan if they do not wish to participate.

Participant Accounts: Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants vest immediately in their contributions and actual earnings thereon. Vesting in the Sponsors' contribution is based on years of continuous service and have a graded vesting schedule increasing 20% each year following 2 full years of service, reaching 100% vesting after 6 years of service.

Investment Options: Upon enrollment in the Plan, a participant may change their investment option daily and direct their investments in increments as allowed by the Plan.

Participants' Notes Receivable: Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest rates are established by the Plan Sponsor based on local prevailing rates. Principal and interest is repaid by payroll deductions and are secured by the balance in the participant's account.

Payment of Benefits: Upon death, disability, termination, or retirement, vested benefits are paid to the participant or designated beneficiary. If the total vested account balance is less than \$5,000, the participant will receive a single lump sum payment. If the vested account balance is equal to or greater than \$5,000, various payment options are available and are described more fully in the Plan agreement. For distributions made after December 31, 2023, this threshold increased to \$7,000 pursuant to the provisions of the Secure 2.0 Act. Hardship withdrawals are also available subject to certain limitations.

Forfeitures: Forfeited non-vested accounts totaled \$22 at December 31, 2024 and \$497 at December 31, 2023. Forfeitures are retained by the Plan and may be used to reduce the Employer's matching contribution or to pay administrative expenses. The Plan used forfeitures of approximately \$698 in 2024 and \$5,077 in 2023 towards administrative expenses.

Plan Termination: The Plan Sponsor holds the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to provisions of ERISA.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by 29 CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and 2023 and the related investment earnings and interest on participants' notes receivable for the years then ended, were certified and held by Ascensus Trust Company, the Custodian of the plan and were not audited by the independent auditor.

NOTE D – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets in liquidation available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE E – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds: Valued based on quoted prices for identical assets in an active market.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F – INCOME TAX STATUS

The Plan is a standardized volume submitter plan. The volume submitter plan has received a favorable opinion letter from the Internal Revenue Service. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan (and the related trust) is qualified for tax exempt status. The Plan is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

NOTE H – RISKS AND UNCERTAINTIES

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

On April 15, 2025, the Plan Sponsor, completed a sale of its business to a third-party. On July 15, 2025, the business was sold again to a different third-party. As part of these transactions, the Plan was not terminated and is expected to continue to operate under its existing structure.
