### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Stewart & Tate Employees Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **Note 1 - Description of Plan**

The following description of the Stewart & Tate Employees Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution plan with both contributory and non-contributory features, covering employees of Stewart & Tate, Inc. (the Company), as defined in the plan agreement, who are age 18 or older and have at least three months of credited service. Certain employees are excluded, specifically union workers. Participants who are not employed on the last day of the plan year generally are not eligible for a profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration of Plan Assets**

There are two groups of assets. Charles Schwab Bank, the current custodian of the Plan, and The Glenmede Trust Company, N.A., the former custodian of the Plan, manages the profit sharing assets (nonparticipant directed) and executes all related transactions. Empower Life & Annuity Insurance Company and Empower Trust Company, LLC, the issuer of the group annuity contract and the current trustee of the Plan, manages the 401(k) assets (participant directed) and executes all related transactions.

Certain investments, which constitute approximately 4% of Plan assets, continue to be held with Glenmede, the former custodian of the Plan, due to specific investment restrictions. These assets are expected to remain under Glenmede's custody for the foreseeable future until the assets can be liquidated. The organization regularly monitors these investments to ensure compliance with its investment policies and objectives.

#### **Contributions**

Participants may elect to defer any portion of their eligible pre-tax compensation up to the maximum amounts allowed by law. Participants age 50 or older before the end of the plan year may elect to defer additional catch-up contributions, subject to annual limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Company profit-sharing contributions to the Plan are discretionary, as determined annually by the Board of Directors. The profit-sharing contribution was 7% of a participant's eligible compensation for each of the years ended December 31, 2024 and 2023. Discretionary employer matching contributions are permitted, but none were made in 2024 or 2023. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, and an allocation of (a) the Company's profit-sharing contribution, (b) plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants are able to select from three investment portfolio options that are designed to accommodate those employees with differing time horizons until retirement for their profit sharing allocation. One portfolio is focused on investment growth (Core Portfolio), another seeks moderate growth with preservation of capital (Moderate Portfolio), and a third portfolio focuses on more aggressive investment growth (Growth Portfolio).

Participants direct their employee deferral investments by choosing from a variety of asset allocation models, including target date retirement funds, which are managed by professional investment management firms.

#### Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in Company contributions and actual earnings thereon is based on years of credited service. Participants become fully vested after six years of credited service based on the following vesting schedule:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case, the loan may be for up to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Payment of benefits upon death, disability, retirement, or termination of employment will be made in a lump-sum, in partial payments, or in installments over a period not in excess of the assumed life expectancy of the participant and/or beneficiaries. Employees who continue working after reaching the normal retirement age of 65 are considered fully vested and will receive their benefits when they actually retire. A participant is eligible for early retirement at age 55 upon the completion of 6 years of service. In certain hardship situations defined by the Plan, an active participant may receive a limited distribution from their fully vested benefits.

#### **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts are added to any employer discretionary contribution and allocated among eligible participants. Forfeitures of nonvested account balances allocated to remaining participants at December 31, 2024 and 2023 amounted to \$197,425 and \$4,814, respectively.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants during the years ended December 31, 2025 and 2024, respectively.

#### **Payment of Benefits**

Payments are recorded when paid.

#### **Administrative Expenses**

Administrative expenses, including investment management fees and recordkeeping fees, are generally paid by the Plan, unless otherwise paid by the Company. Fees that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan has a Plan Expense Account (PEA) with Empower, which may be used to pay plan expenses. Asset-based payments are calculated based upon an average daily balance of the investments for the month. During the years ended December 31, 2024 and 2023, the Plan received and utilized \$7,488 and \$6,837, respectively, from the PEA to pay certain plan expenses.

### **Note 3 - Information Certified and Provided by the Custodian and the Issuer and the Trustee**

Certain information related to investments, cash, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, cash, notes receivable from participants, and due to broker held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Charles Schwab Bank, the current custodian of the Plan, The Glenmede Trust Company, N.A., the former custodian of the Plan, and Empower Life & Annuity Insurance Company and Empower Trust Company, LLC (collectively, Empower), the issuer and the trustee of the Plan, respectively.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks and real estate investment trusts: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds and notes and asset-backed debt securities: Valued using yields available for comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar securities, other valuation processes are used that incorporate benchmark yields, broker-dealer quotes, and/or other unobservable inputs such as credit and liquidity risks.

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Alternative investments: The Plan owns various alternative investments that include a hedge fund, a fund of funds, and a private equity fund. The Glenmede Trust Company, N.A., as investment manager, determines a NAV based on information provided by the investment managers of the underlying investments within each fund. Since these investments are not publicly traded and are often illiquid, estimated fair values are determined using a variety of factors, including present value and other subjective valuation techniques. The investment pools within each fund are valued monthly using unaudited data supplied by third-party fund managers. Due to the delay in obtaining financial information from the underlying funds, there is a valuation lag in obtaining fair values, which is usually one month for hedge funds and quarterly for the private equity fund. The NAV per share for each fund at December 31 is not adjusted for any time lag in updating valuation data.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The private equity funds seek long-term compounded returns comparable to those historically associated with private equity managers who invest in private equity investments and real estate. The funds may invest in limited partnerships and other pooled investment vehicles, either new or existing, that are managed by private equity managers who generally invest in non-public companies. Investments are allocated to companies with certain characteristics, such as buyouts, distressed, venture capital, natural resources, and real estate. This Delaware limited liability company is illiquid as members are not allowed to demand cash withdrawals. Distributions from the funds will only be made at the discretion of the investment manager and only after the funds have received a distribution from an underlying investment.
- (b) The fund of funds seeks long-term capital appreciation by investing in five to ten investment funds with favorable long-term risk-adjusted returns that are professionally managed and that use leveraged or short-sale positions to take advantage of perceived inefficiencies in global capital markets. This Delaware limited liability company permits members to withdraw all or a portion of their capital account that is attributable to specific capital contributions on the last day of the calendar quarter that occurs at least 12 months after the date such contribution was deemed effective, provided written notice is supplied 75 days in advance. Total withdrawals from the capital account are based on 90% of the estimated capital balance with the residual paid upon completion of the annual fund audit.
- (c) The hedge fund is an offshore limited liability fund that seeks long-term capital appreciation by investing in investment funds managed by third-party investment managers who employ a variety of alternative investment strategies. There is a one-year lockup on each investment subscription or tranche of invested capital; thereafter, semi-annual redemptions are allowed with 90 days written notice. In complete redemption of the fund, only 90% of the estimated fair value is paid promptly with the remaining 10% paid upon completion of the annual fund audit.

#### Note 6 - Investment Contract with Insurance Company

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The Plan owns the contract itself and is designed to accrue interest based on crediting rates established by the contract issuers.

### **Note 6 - Investment Contract with Insurance Company (continued)**

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- A. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- B. Premature termination of the contracts.
- C. Plan termination or merger.
- D. Changes to the Plan's prohibition on competing investment options.
- E. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- A. An uncured violation of the Plan's investment guidelines.
- B. A breach of material obligation under the contract.
- C. A material misrepresentation.
- D. A material amendment to the agreements without the consent of the issuer.

### **Note 7 - Tax Status**

The Company has adopted a pre-approved plan document that was sponsored by Conrad M. Siegel, Inc. The pre-approved plan document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### **Note 7 - Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### **Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 10 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of alternative investments that are sponsored and managed by The Glenmede Trust Company, N.A. and Charles Schwab Bank, the former and current custodian, respectively, as defined by the Plan. These transactions qualify as party-in-interest transactions. The Glenmede Trust Company, N.A. and Charles Schwab Bank also receive certain investment management and custodial fees from the Plan based on the total value of investments under management. Fees paid to the custodian for such services are immaterial.

Empower, the issuer and trustee, provide recordkeeping, administrative, and trust services to the Plan and have the responsibility for selecting and maintaining suitable investment options within the risk-based asset allocation portfolios managed for the participants, as well as investments that are directed by participants. Fees paid to the current trustees for such services have been contractually negotiated and are paid by the Plan and are immaterial. These transactions qualify as party-in-interest transactions.
