Notes to Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of Doosan Turbomachinery Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan’s provisions.

General

The Plan is a qualified retirement plan covering substantially all employees of Doosan Turbomachinery Services, Inc. (“Company”). The Plan was originally effective January 1, 2012, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The amended and restated provisions of the Plan became effective January 1, 2022, to conform the Plan to new tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

The Plan allows participation upon employment to all employees after the eligibility requirement of 60 days of service is met. Participants may participate on the first of the month coinciding with or next following the date the employee satisfies the eligibility requirement. Union employees and certain nonresident aliens are excluded.

Contributions

Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a pre-tax or Roth 401(k) deferral. Total deferrals in any taxable year may not exceed a dollar limit, which is set by law. Participants at least age 50 or who will attain age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions. The Plan includes an automatic salary deferral feature in which 3% of a participant’s compensation will be automatically contributed to the Plan as a pre-tax contribution unless the participant elects an alternative deferral amount or elects not to defer. Participants may make modifications to or revoke their salary deferral elections at any time during the plan year.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a safe harbor matching contribution equal to 100% of a participant’s salary deferrals that do not exceed 3% of their compensation plus 50% of their salary deferrals between 3% and 5% of their compensation. The Company may also make a discretionary matching contribution to the Plan that will not exceed 4% of a participant’s compensation. There were no discretionary matching contributions made during 2024.

Participants are also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their entire interest in the Plan in any of several investment securities. Participants can change their investment allocation among the various investment securities either through direct transfers from one option to another or by changing the percentage allocation of future contributions.

Notes Receivable from Participants

Loans are available to participants on a reasonably equivalent basis. Participants may borrow from their accounts no amount less than \$1,000 up to a maximum equal to the lesser of one-half of their vested interest in the Plan or \$50,000 reduced by the participant's highest outstanding balance of loans from the Plan during the prior one-year period. A participant may have only one note outstanding at any one time. All loans are adequately secured and bear an interest rate of 2% above the prime rate. All notes require that repayment be amortized in level payments, not less than quarterly, over a period not exceeding five years unless the loan is for the purchase of a principal residence, in which case the loan repayment period may be longer.

Vesting

Participants are always 100% vested in their contributions, safe harbor matching contributions, and rollovers plus actual earnings thereon. Vesting in discretionary matching contributions and earnings thereon is based on periods of service. A participant is 100% vested after three credited periods of service.

Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay administrative expenses or reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,220 and \$30,718, respectively, of which \$7,220 was applied to reduce 2024 employer contributions funded during 2025.

Payment of Benefits

Participants may receive a distribution of the vested portion of some or all of their account in the Plan for termination of employment, normal retirement, disability, or death. Benefits under the Plan will generally be paid in cash only. If the participant's vested account balance does not exceed \$5,000, then the vested account balance may only be distributed to the participant in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000, the participant must consent to any distribution before it may be made and elect to receive the distribution as a single lump-sum payment, installments, or partial withdrawals.

Participants may be entitled to receive an in-service distribution. Generally, participants may also receive a distribution from the Plan from certain accounts prior to their termination of employment if they have attained age 59½ or incurred a financial hardship.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A), a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at net asset value (“NAV”) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liability. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

7. TAX STATUS

The Company adopted a pre-approved plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and was tax-exempt as of December 31, 2024 and 2023.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, there was one investment that represents a concentration of greater than 10% of the Plan's net assets available for benefits.
