As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTES TO FINANCIAL STATEMENTS****The Louise S. McGehee School 403(b) TDA Plan**

December 31, 2024 and 2023

**Note 1 - PLAN DESCRIPTION**

The following description of The Louise S. McGehee School 403(b) TDA Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**a. General**

The Louise S. McGehee School (the “School”) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the School, as defined in accordance with the universal availability standards, may enroll upon their date of hire. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**b. Plan Contributions**

Each year, participants may contribute by salary reduction, pursuant to Section 403(b) of the Internal Revenue Code (the “Code”), up to 100% of pretax annual compensation, less payroll tax deductions, as defined by the Plan, not to exceed statutory limits. Participants who have attained the age of 50 before the end of the plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

In any plan year, at its discretion, the School may match a percentage or elective deferrals, in an amount not to exceed statutory limits. All School employees with at least one year of service and age 21 will be eligible to receive the School’s matching contribution. For the year ended December 31, 2024, the School made contributions of \$275,468.

**c. Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and the School’s contributions into various annuity options offered by the Plan. The annuity options represent several different alternatives to investing with different risk and return characteristics. Participants may change their investments as frequently as permitted under the Plan.

**Note 1 - PLAN DESCRIPTION (Continued)**

**d. Vesting**

Participants are immediately and fully vested in their accounts.

**e. Loan Agreements**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable terms range from one to ten years. The notes receivable are secured by the balance in the participant's account and bear interest at the Federal Reserve Prime Rate plus 1% (8.5% and 9.5% as of December 31, 2024 and 2023, respectively). The interest rate charged on these notes receivable ranged from 4.25% to 9.5%. Principal and interest is paid ratably through payroll deductions.

**f. Payment of Benefits**

Upon retirement, death, or disability, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. The participant may also apply their individual account balance toward the purchase of an annuity contract. Upon termination, other than by retirement, death, or disability, a participant becomes eligible to receive the current value of the participant's account in a lump-sum. Participants may also receive in-service withdrawals from their account balances upon reaching the age of 59½. Hardship withdrawals are permitted from the Plan. Participants with a vested interest of \$5,000 or less are subject to the mandatory cash out provisions of the Plan.

Effective January 1, 2023, the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") increased the required minimum distribution (RMD) age from 72 to 73. Terminated participants may elect to have the Plan's trustee hold their accounts for distribution to them at a date not later than April 1 of the calendar year after which they attain the RMD age. In this event, terminated participants continue to share in the income, expenses, gains, and losses of the Plan until their accounts are distributed. Effective January 1, 2033, the SECURE 2.0 Act increases the RMD age from 73 to 75. The SECURE 2.0 Act is discussed further on under "*SECURE 2.0 Act of 2022*" in Note 2h.

**g. Participant Investment Rollovers**

Participants are allowed to transfer or roll over funds into the Plan from other qualified or 403(b) plans.

**Note 1 - PLAN DESCRIPTION (Continued)**

**h. Forfeited Accounts**

As of both December 31, 2024 and 2023, forfeited excess mandatory contributions totaled \$2. Forfeitures are used to reduce employer contributions. There were no amounts allocated to eligible participant accounts to reduce the employer contributions during the year ended December 31, 2024.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**a. Basis of Accounting**

The accompanying financial statements are prepared using the accrual method of accounting.

**b. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**c. Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the contracts with insurance companies, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned, and dividends are recorded as of the ex-dividend date. The net appreciation in value of investments includes realized and unrealized gains and losses on the value of investments held by the Plan.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**d. Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make repayments on the note receivable and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**e. Contributions**

Contributions from employees and the School are recorded in the period in which the School makes the payroll deductions from participant earnings.

**f. Payment of Benefits**

Benefits are recorded when paid.

**g. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**h. SECURE 2.0 Act of 2022**

On December 29, 2022, the SECURE 2.0 Act was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates.

Significant provisions were as follows:

- The RMD age was increased from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- The excise tax for failure to take RMDs was reduced from 50 percent to 25 percent of the RMD amount that was not taken, beginning January 1, 2023; and
- All catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) are required to be designated as Roth 401(k) contributions beginning after December 31, 2023. However, in August 2023, the Internal Revenue Service (IRS) announced an administrative transition period that delays this requirement until taxable years beginning after December 31, 2025.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**h. SECURE 2.0 Act of 2022 (Continued)**

The Plan will incorporate changes in its plan document and administration to the extent required by the “*SECURE 2.0 Act*”.

**i. Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS**

As of December 31, 2024 and 2023 and for the year ended December 31, 2024, the Plan’s investments were held by TIAA and Voya/ReliaStar Life Insurance Company, the Plan’s custodians. The information presented in Note 4 summarizes the Plan’s investment information that is included in the financial statements based on the information certified by the custodians as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employment Retirement Income Security Act of 1974. Information for investments has been certified by TIAA and Voya/ReliaStar Life Insurance Company, as follows:

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Note 4 - FAIR VALUE MEASUREMENTS (Continued)**

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered Investment Companies/Fixed Annuity Contracts:*

CREF Accounts invest in equity securities, fixed income investments, and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost.

TIAA Access Annuity is a variable annuity product that is funded through a TIAA separate account that invests in proprietary and nonproprietary mutual funds through various subaccounts. Subaccount unit values are calculated daily. The underlying investments are generally valued using market quotations obtained from independent pricing services.

**Note 4 - FAIR VALUE MEASUREMENTS (Continued)**

*Registered Investment Companies/Fixed Annuity Contracts: (Continued)*

Registered investment company assets in the Plan are reported at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. NAV, calculated daily, is applied to daily purchase and sale transactions in addition to being used to determine ending market values. The registered investment company accounts are classified as a Level 2 investments.

*Pooled Separate Account:*

TIAA Real Estate Account is held in an insurance company separate account and invests primarily in real estate and real estate related investments. The value is principally derived from the market value of the underlying real estate holdings or other real estate related investments as well as such liquid-fixed income investments. The account provides a liquidity guarantee to meet participant redemption, transfer, or cash withdrawal requests that can be executed at any time at the closing daily accumulation value as listed on Nasdaq. Redemptions out of the investment are limited to one per calendar quarter. This account is reported at the quoted market price, which represents the accumulated unit value at NAV held by the Plan at year end.

*Annuity Insurance Contract:*

TIAA Traditional Non-Benefit Responsive Annuity Contract is non benefit-responsive and not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable, and the investments are valued using unobservable inputs (Level 3). While transactions involving the purchases/sales of individual TIAA Traditional Annuity contracts are not observable in a public marketplace, these contracts are valued at contract value which approximates fair value.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

There were no transfers in and/or out of Level 3 investments during the years ended December 31, 2024 and 2023.

**Note 5 - CONTRACTS WITH INSURANCE COMPANIES**

Plan assets are invested in fixed and variable annuity contracts with TIAA. TIAA maintains the assets of the fixed annuity contracts in a general account. The general account is reported at contract value. The contract value of the general account equals the accumulated cash contributions and is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the plan participant.

The TIAA Traditional Benefit Responsive fixed annuity contract is a fully benefit-responsive investment contract. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value less a minimal transaction fee.

**Note 5 - CONTRACTS WITH INSURANCE COMPANIES (Continued)**

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are set annually by the TIAA Board of Trustees. The average yields, based on actual earnings, and on the interest, rate credited to participants, approximated 3.79% for 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer including, among other matters, amendments to plan documents including complete or partial plan termination. At this time, the plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

Plan assets are also invested in annuity contracts with Voya/Reliastar Life Insurance Company. The assets are maintained in a general account. The annuity contract may have the potential to restrict certain transfers and withdrawals. The earnings on the assets were approximately 3.00% for 2024.

**Note 6 - RISK AND UNCERTAINTIES**

The Plan's investments are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**Note 8 - TAX STATUS**

The School has adopted the ERISA 403(b) Volume Submitter Plan. The Plan was initially effective January 1, 1997, and was restated effective January 1, 2010. The Volume Submitter 403(b) prototype plan document adopted by the Plan, effective January 1, 2010, received a favorable opinion letter from the Internal Revenue Service dated August 7, 2017, which stated that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the plan management believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the financial statements of the Plan.

**Note 8 - TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

**Note 9 - TRANSACTIONS WITH PARTIES IN INTEREST**

The Plan invests in annuities sponsored by the Plan's custodians, as defined by the Plan, and therefore, these transactions qualify as party in interest transactions.
