Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Central Dermatology Center PA 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements December 31, 2024

1. Description of Plan

The following description of the Central Dermatology Center PA 401(k) Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor plan under Section 401(k) of the Internal Revenue Code covering substantially all employees of Central Dermatology Center PA and Central Dermatology Management Group LLC ("the Company") except for union employees; leased employees; and non-resident aliens, as defined by the Plan. Employees who have reached the age of twenty-one and completed one year of service in which they have worked at least 1,000 hours are eligible to make deferrals to the Plan and receive the Company's non-elective safe harbor contribution. Participants must be employed on the last day of the plan year to be eligible for any discretionary non-elective contributions. Under the SECURE Act of 2019, any employees who are age 21 and complete 500-999 hours in three consecutive 12-month periods, become eligible to make employee deferrals effective January 1, 2024. Secure 2.0 Act of 2022 shortens that period to two consecutive 12-month periods effective January 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company provides a 3% safe harbor non-elective contribution to all eligible employees each pay period with a true-up at year-end. Additional non-elective contributions may be made each Plan year at the discretion of the Company for employees. There were no additional discretionary non-elective contributions made for the 2024 Plan year. Contributions are limited to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently holds a pooled separate account that does not file as a direct filing entity; therefore, the underlying investments are reported on the Form 5500. Participants may select from various registered separate accounts and a fixed account as investment options for participants.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of their accounts is based on years of continuous service. A participant vests 20% after 2 years, 50% after 3 years, and is 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 2%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in her or her account in a lump sum. In-service distributions are permitted at age 59 ½ from fully vested accounts. Distributions from a participant's rollover contribution account are available at any time. Involuntary distributions may be made by the Plan Sponsor for terminated participants with account balances less than \$1,000.

Forfeited Accounts

At December 31, 2024 and 2023 there were \$7,856 and \$1,508 in forfeited non-vested accounts. Forfeitures may be used to reduce future Company contributions or pay for plan expenses. No forfeitures were used during 2024.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan directly. Investment related expenses are included in net appreciation in the fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Loans totaling \$5,351 defaulted in 2024 and were included in distributions.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fixed account which is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for the fair value of the Plan's assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

3. Unaudited Information

For the 2024 and 2023 Plan years, the Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company ("VRIAC") has certified that the following data included in the accompanying financial statements is complete and accurate.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Account: The Plan holds a pooled separate account that invests in a fixed account and registered investments, which are the unit of account for the participants. The fair values of participation units held in the registered separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the registered separate accounts invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these registered separate accounts are consistent with each of the mutual funds identified in the name of the fund. Each of the registered separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit. The pooled separate account does not file as a direct filing entity, and therefore reports the underlying investments on the Form 5500.

Self Directed Brokerage Accounts: The self directed brokerage accounts primarily hold mutual funds, common stock, corporate bonds, and money market funds. These investments are traded on an exchange and are primarily valued at their net asset values as their readily determinable fair values.

6. Insurance Contract

The Plan entered into a fully benefit responsive insurance contract with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate to the Plan. The account has a guaranteed interest rate set by the insurance company.

Because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. The contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract has a crediting interest rate based on a formula agreed upon with the issuer and has a guaranteed rate.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of the equity wash provisions in place, (3) bankruptcy of the Plan sponsor or other significant Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in any un-vested employer contributions.

8. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan may be amended periodically; however, the plan administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

9. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Related Party and Party-in-Interest Transactions

Certain plan investments are units of separate accounts and an insurance contract managed by VRIAC. Certain other investments are self-directed brokerage accounts managed by LPL Financial and Morgan Stanley. Transactions with these parties qualify as party-in-interest transactions.

11. Non-Exempt Transactions

During the Plan year ended December 31, 2023, employee withholdings amounting to \$26,099 were not remitted within the appropriate time by the Company. These transactions constitute prohibited transactions, as defined by ERISA. The Company remitted these contributions during the respective Plan year and remitted lost earnings to the Plan in March 2024.

12. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
