Independent Auditor's Report

To the Trustees and Administrative Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have audited the accompanying financial statements of Brean Capital, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the Plan year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brean Capital, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of the Plan

The following description of the Brean Capital, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan under Internal Revenue Code (“IRC”) Section 401(k) effective December 1, 2000, and subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all eligible employees, except union employees, nonresident aliens and residents of Puerto Rico, as defined by the Plan document, of Brean Capital, LLC, Brean Asset Management, LLC, and Brean Strategic Advisors, LLC, collectively, the Plan sponsor (or the “Company”). Eligible employees include those who have completed three months of service and are age 21 or older. The Board of Trustees is responsible for the oversight of the Plan, and determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan was amended and most recently restated effective January 1, 2022.

Contributions - Each year, participants may contribute up to one hundred percent (100%) of pre-tax annual compensation up to the Internal Revenue Service (“IRS”) limitations and as defined in the Plan, up to \$23,000 for 2024 and up to \$22,500 for 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in the amounts of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant’s elective deferrals. The Plan also allows for discretionary profit-sharing contributions, provided the participant completed at least 1,000 hours of service during the year and is employed by the Company on the last day of the Plan year, as well as qualified non-elective contributions from the Company. During the Plan year ended December 31, 2024, the Company did not make any matching contributions, profit sharing contributions, or qualified non-elective contributions (“QNEC”) into the Plan.

Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company discretionary profit-sharing contributions and QNEC’s, if any, and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon, and if applicable, any amounts rolled over into their accounts. Vesting in the Company’s discretionary matching and profit-sharing portions of their accounts is based on years of service. Upon completion of each year of service, a participant is 20 percent vested cumulatively, and 100 percent vested after five years of credited service. A participant may become fully vested upon attainment of normal retirement age while an employee, death of any employee or suffering a disability while an employee.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates that are determined quarterly by the Plan Administrator and set at 1 percent above the prime rate. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years unless the purpose of the loan is for the purchase of the principal residence of the participant, in which case the repayment period cannot exceed ten years. Participant notes are valued at their outstanding balance plus accrued and unpaid interest.

Note 1 - Description of the Plan (continued)

Payment of benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or roll the balance into an individual retirement account or another qualified plan. Participants may apply for hardship withdrawals as defined by the IRC to meet excessive medical or educational expenses, to cover expenses to purchase a new principal residence, or to prevent eviction from a principal residence.

Forfeiture accounts – Any amount to which the participant is not vested is subject to forfeiture in accordance with the provisions of the Plan. Forfeitures, generally held in suspense accounts by the Plan, may be used to pay administrative expenses or reduce future employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested amounts held in suspense accounts by the Plan. For the years ended December 31, 2024 and 2023, there were no allocations of forfeitures from non-vested accounts to reduce Plan expenses.

Recent legislation - On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, including the package of retirement provisions referred to as “SECURE 2.0”. These provisions address additional issues related to retirement and savings and build upon provisions of the SECURE Act of 2019. The SECURE 2.0 Act introduced new requirements and considerations for plan sponsors intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in the SECURE 2.0 Act has its own effective date ranging from the date of enactment to 2028 and beyond, with certain provisions taking effect in 2024. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan and its participants, and will determine which of the optional provisions to elect.

Although the Company has not yet formally amended the Plan, the Department of Labor (“DOL”) and IRS have issued joint rulings that allow the Company to act in good faith and administer the Plan in accordance with the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act in addition to the SECURE Acts, so long as the Plan is formally amended by December 31, 2026.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Company prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determine the Plan's valuation policies utilizing information provided by its investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

A note receivable is considered to be in default, after any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Participant contributions, established by participant election, are recorded in the year in which the participant contributions are withheld from amounts paid. Employer contributions made by the Company are recorded when authorized by the Company's Board of Directors. All contributions are participant directed.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

We have been informed by the Plan Administrator that Reliance Trust Company held the majority of the Plan’s investment assets at December 31, 2024 and executed the majority of investment transactions for the Plan years ended December 31, 2024 and 2023. The investments held by Reliance Trust Company have been certified as noted above. A portion of the Plan’s investment assets during the year were held, and the related executed investment transactions executed, within self-directed brokerage accounts for which the related balances and activity are not included in the above amounts.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: These accounts may include mutual funds, common stock, exchange-traded funds and money market funds, all of which are valued at the closing price reported in the active market in which securities are traded.

The following table sets forth the Plan’s level 1 assets, with the exception of certain investments for which fair value is measured using NAV per share as the practical expedient, at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based upon the lowest level of any input that is significant to the fair value measurement. There were no level 2 or 3 assets held by the Plan at December 31, 2024 and 2023.

Note 5 - Related-Party Transactions and Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Any transactions involving funds managed by the Company, trustees and recordkeeper are considered party-in-interest transactions. However, these transactions are based on customary and reasonable rates, and are not considered prohibited transactions under Section 408(b) of ERISA and the regulations promulgated thereunder.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included as a reduction of the return earned on each collective investment fund. Recordkeeping and investment advisory fees are charged separately on a quarterly basis and paid for by the Plan. These transactions also qualify as exempt party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all amounts credited to their individual participant accounts.

Note 7 - Tax Status

The Plan has adopted a volume submitter profit sharing plan sponsored by the Company. The volume submitter plan has most recently received an opinion letter from the IRS dated June 30, 2020 stating that the volume submitter plan is acceptable under the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and related trust is tax-exempt.

Note 7 - Tax Status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

Note 8 – Risks and Uncertainties

The Plan invests in a variety of investment securities, which are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, coupled with the recent economic events, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

Note 9 - Subsequent Events

Plan management has evaluated subsequent events occurring after the financial statement date through October 6, 2025 which is the date the financial statements were available to be issued and has determined that no subsequent events have occurred which require recognition or disclosure in the financial statements.
