Keystone Powdered Metal Company Retirement Plan for Non-Bargaining Employees:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

**1. Description of the Plan**

The following is a brief description of Keystone Powdered Metal Company Retirement Plan for Non-Bargaining Employees (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan document, related adoption agreement and individual statements provided for a more complete description of the Plan’s provisions.

**General**

The Plan is a qualified defined contribution pension plan covering eligible employees of Keystone Powdered Metal Company (the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). On April 1, 2022, Empower Annuity Insurance Company of America (“EAICA”) acquired the full-service retirement business which includes Prudential Bank & Trust, F.S.B., the trustee and record-keeper of the Plan and renamed it to Empower Annuity Insurance Company. Empower Trust Company, LLC., is the trustee of the Plan (the “Trustee”). Empower Annuity Insurance Company is the record-keeper of the Plan (the “Record-keeper”). The Trustee and Record-keeper are qualified institutions in accordance with 29 CFR 2520.103-5 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Trustee, Record-keeper and the Plan administrator are appointed by the Company.

During 2024, there were transfers into the Plan amounting to \$307,107 and transfers out of the Plan amounting to \$194,190 between the Keystone Powdered Metal Company Retirement plan for Bargaining Employees and the Plan. These transfers were in conjunction with participants being transferred into different job classifications.

During 2024, there were transfers from the Plan to the Sumitomo Electric Group 401(K) Plan (“Sumitomo Plan”) amounting to \$52,967,648. The Plan liquidated once it merged with the Sumitomo Plan.

**Eligibility**

The Plan covers all non-bargaining employees of the Company. There are no minimum service or age requirements for participation. The Plan excludes those employees who are: (1) Leased employees, (2) Nonresident aliens (3) Employees covered by a collective bargaining agreement and (4) Reclassified employees. College students is an employee classification that is excluded for all contributions on and after July 16, 2017. Entrance in the Plan is the employee’s date of hire.

**1. Description of the Plan**

**Participant Contributions**

The employees make voluntary contributions, on a before-tax or after-tax basis, between 0% and 90% of compensation, up to the maximum contributions allowed under the Internal Revenue Service Code (“IRC”), as discussed below, to be placed into a trust fund for their benefit. The Plan includes an automatic enrollment feature and contribution arrangement.

The automatic deferral amount is 3% for employees who are hired prior to January 1, 2020, and 4% for those hired on or after January 1, 2020, of their eligible compensation unless the participants opt-out of the Plan or change the deferral percentage. Compensation per the Plan document means wages, tips, and other compensation on Form W-2. Compensation is adjusted to exclude fringe benefits, expense reimbursements, moving expenses, deferred compensation, and welfare benefits. Roth 401(k) contributions are permitted.

The maximum amount of compensation that may be considered for deferral purposes by participants and employer contributions is \$345,000 for 2024. Total participant contributions are limited to a maximum of \$23,000 for 2024. Additionally, individuals who are at least 50 years of age can make a “catch-up” contribution not to exceed \$7,500 for 2024. The maximum annual addition for 2024 that may be contributed or allocated to a participant’s account under the Plan shall not exceed the lesser of 100% of a participant’s compensation or \$69,000 for employees under age 50 and \$76,500 for employees over the age of 50.

**Employer Contributions**

The Company makes a matching contribution equal to 100% of participant’s elective deferrals not to exceed 4% of eligible compensation. There is also a match for catch-up contributions.

**Rollover Contributions**

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan.

In the event of death, disability, or termination of the Plan, participants become fully vested in their account balance. Frozen money purchase contributions are subject to the same 5-year graded vesting schedule. Upon attainment of early retirement (age 55), 100% vesting applies to all employer contributions.

**Participant Accounts**

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company contributions, and Plan earnings and expenses. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Each participant may borrow up to the lesser of: (1) 50% of the present value of the participant's vested interest in the account or (2) \$50,000, less currently outstanding notes receivable. The notes are secured by the vested balance in the participant's account. No note shall be less than \$1,000 and only one note at a time is allowed. The notes shall bear interest as determined by the Plan administrator at the rate of prime plus 1% per annum. At December 31, 2024, there were no outstanding notes receivable from participants.

**1. Description of the Plan**

**Notes Receivable from Participants**

An outstanding note is repayable, with interest, in full at any time or in monthly installments by means of a payroll deduction from the participant's salary over a term not to exceed five years, unless the note is for the purchase of a principal residence for which the repayment period may not exceed beyond 15 years. A note becomes immediately due and payable upon a participant's termination of employment, death, or disability.

**Forfeitures**

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to reduce future Company contributions or to pay the administrative expenses of the Plan. Forfeitures are restored to the participant's account if the participant is reemployed before incurring five consecutive one-year breaks and the full amount of any distribution is repaid before the end of the five-year period that begins upon reemployment. At December 31, 2024, and 2023, forfeited non-vested accounts were \$0 and \$131,521, respectively. During the year ended December 31, 2024, \$313 of forfeitures were used to reduce employer contributions.

**ERISA Budget Account**

The Trustee, through its revenue sharing arrangements ("Shared Revenue") with investment companies, shares a portion of the Shared Revenue with retirement plans which it services. The ERISA Budgeted Account can be used to either reduce Plan expenses or be reallocated to participant accounts. At December 31, 2024, and 2023, the remaining portion of the Shared Revenue, referred to as the ERISA Budget Account in the aggregate amount of \$0 and \$101,342, respectively, is included in the investment balance on the Statements of Net Assets Available for Benefits.

**Retirement**

The normal retirement age is defined as when the participant reaches the age of 65. At the normal retirement date, the participant is entitled to 100% of their account balance. The Plan does not allow early retirement. The participant can elect late retirement after the age of 65; however, benefits must begin by age 73. A participant, who becomes disabled, as defined in the Plan document, is eligible for a disability retirement.

**1. Description of the Plan**

**Distribution of Benefits**

An active participant, or a designated beneficiary, is entitled to withdraw the entire vested amount (or in some cases, a portion thereof) in the event of normal retirement, death, disability, termination of employment, termination of the Plan, attainment of age 59 ½ or under hardship circumstances, as defined in the Plan document. The minimum amount for an in-service distribution is \$5,000. Distributions are made in the form of a lump sum distribution or installment payments. Terminated employees whose vested balance exceeds \$5,000 at termination may elect to leave their account balances in the Plan. Participants must begin receiving Required Minimum Distributions, under Internal Revenue Service (“IRS”) guidelines, upon reaching the age of 73.

**Administrative Expenses**

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan’s trust funds and allocated to all participants on a pro rate basis. The Company incurred certain administrative expenses relating to and without charge to the Plan during 2024.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates and Assumptions**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the unallocated insurance account which is valued at contract value as discussed below. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. Investment contracts held by a defined-contribution plan are required to be reported at fair value.

**2. Summary of Significant Accounting Policies**

**Investment Valuation and Income Recognition**

However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment in the unallocated insurance contract account is a group annuity contract with the Trustee that is fully benefit-responsive so that the Statements in Net Assets Available for Benefits present this investment at contract value. See further details in Note 7.

Investment earnings are automatically reinvested into the investment from which they are derived. Purchases and sales of securities are recorded as of the trade date. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation of the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

**Payment of Benefits**

Benefit payments to participants or beneficiaries are recorded when paid.

**Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks including, but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**2. Summary of Significant Accounting Policies**

**Income Tax Status**

The Company adopted a volume submitter plan document that received an Internal Revenue Service (“IRS”) Opinion Letter dated September 16, 2022, in which the IRS stated that this volume submitter document, as then designed, was compliant with the applicable requirements of the IRC. An employer adopting this prototype plan is considered to have a plan qualified under section 401(a) of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator and the Plan’s tax counsel believe that the Plan is currently being operated in conformity with the applicable requirement of the IRC and therefore believes the Plan is qualified and the trust established under the Plan is tax exempt. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and/or the Department of Labor (“DOL”). The Plan administrator has analyzed the tax positions taken by the Plan and had concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and/or the DOL. There are currently no other audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

**3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

**4. Investments**

For the year ended December 31, 2024, the Plan's investments appreciated (including gains and losses on investments bought and sold, as well as held during the year) in value by \$3,821,648.

**5. Fair Value Measurements**

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**5. Fair Value Measurements**

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023:

**Mutual funds** are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fair Value Measurements**

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the year ended December 31, 2024, there were no purchases, issuances, transfers in, or transfers out of Level 3.

**6. Related Party and Party-in-Interest Transactions**

All the Plan's investments are managed by the Trustee. The investment in the Guaranteed Income Fund is with the Trustee. Certain payments to the Trustee are included within administrative expenses. Transactions with the Trustee qualify as party-in-interest transactions. Loans to Plan participants also qualify as party-in-interest transactions. The above transactions are not, however, considered prohibited transactions under CFR 408 (b) of the ERISA regulations.

**7. Unallocated Investment Contract with an Insurance Company**

The Company entered a group annuity insurance contract with the record-keeper, whose balance was \$0 and \$11,286,645 as of December 31, 2024, and 2023, respectively. The record-keeper maintains the contributions in its Guaranteed Income Fund within its general account which it added interest at a predetermined rate of 1.75% for 2024. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable timeframes. The account is also charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as discussed in Note 2. Contract value represents the amount of contributions deposited, plus interest credited daily as determined by the contract, less any participant withdrawals and administrative expenses. The contract is affected directly between the trustee and their issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. It is at least reasonably possible that changes in the value of the investment will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

If the Plan were to initiate a full redemption of this investment contract, the Trustee reserves the right to temporarily delay withdrawal from this contract to ensure that the liquidation will be carried out in an orderly business manner.

**8. Unaudited Information Certified by the Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information, which was certified by the Trustee, as complete and accurate, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule as follows:
