Note 1: Description of The Plan

The following description of Unico Technologies Group 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan became effective on January 1, 2019, and is a defined contribution plan covering substantially all employees in the group after meeting certain requirements. The group (the “Employer”) includes Unico, LLC, Benschaw Inc., and Excel Industrial Electronics. Employees are immediately eligible to participate in the Plan on the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may defer any amount of their Plan compensation which is defined as W-2 wages excluding certain adjustments as defined by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, with a default deferral rate set at 6% of eligible compensation, unless they affirmatively elect an alternative deferral rate or to not participate. The Employer contribution matches 100% of each participant’s elective deferrals up to 1% of the respective participant’s compensation and 50% of each participant’s elective deferrals between 1% and 6% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution and (b) Plan earnings and charged with an allocation of certain administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Expenses are allocated equally to all participants or pro rata based on participant’s individual account balances.

Vesting

Participants’ contributions, plus actual earnings thereon, are immediately vested. Vesting in the Employer’s contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service or upon reaching the normal retirement age of 65 years old. Participants are 100% vested when they have met two years of credited service or normal retirement age.

Notes Receivable from Participants

The notes bear interest at a rate based on rates available for similar loans from commercial lending institutions. The Loan Administrator periodically examines the rates such lenders are using. Once the interest rate has been established for a loan it will be fixed for the life of the loan. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in some or all of his or her accounts. The Plan allows for in-service distributions of certain accounts if a participant reaches age 59 ½ or incurs a hardship or disability, subject to Plan provisions.

If a participant terminates employment and the participant's vested account balance does not exceed \$7,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's vested account exceeds \$7,000, consent is required to distribute the account before normal retirement age is reached. Amounts in the participant's rollover account will not be considered as part of the benefit in determining whether the threshold has been exceeded.

Forfeitures

Forfeitures of non-vested Employer contributions are used to reduce future Employer contributions. During 2024, \$204,078 of forfeited participant accounts were used to reduce Employer contributions. At December 31, 2024, there was \$201 of forfeitures that had not yet been applied to reduce the Employer contributions.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Employer.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participant loans receivable are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Date of Management's Review

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3: Information Certified by The Trustee (Unaudited)

The plan document is a Principal Financial Group pre-approved plan document. At December 31, 2024 and 2023, the Plan's investments were held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), a member of the Principal Financial Group (the Trustee). The Trustee certified all investment information as reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024 as complete and accurate in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value funds: Valued at net asset value per unit, which is obtained based on audited information reported by the issuer of the stable value fund and is used as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the report date.

- The investment in the stable value fund is measured at fair value using the net asset value per share as a practical expedient and has not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts present in the Statements of Net Assets Available for Benefits.

The Plan may redeem shares of the stable value fund on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by the Plan. The Plan is required to provide the stable value fund with a 12 month notice prior to redeeming its investment in the stable value fund.

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Internal Revenue Service (IRS) has determined through a determination letter dated June 30, 2020, that the prototype plan of the trustee and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 8: Party-in-Interest Transactions

The Plan has service providers that provide certain administrative services including recordkeeping and audit. Such providers are parties in interest under ERISA. Certain fees incurred in the administration of the Plan are paid by the Employer.
