We have performed audits of the financial statements of PeopleService, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Plan Description

---

The following brief description of the PeopleService, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of PeopleService, Inc. (the Company).

Employees are eligible to make salary deferral contributions and receive discretionary matching contributions upon reaching 18 years of age. Eligible employees may enroll immediately once the age requirement has been satisfied. Participants are eligible to receive discretionary profit-sharing contributions only if they complete 1,000 hours of service during the Plan year and are employed on the last day of the Plan year.

#### ***Contributions***

Participants may make voluntary pre-tax or Roth after-tax salary deferral contributions up to 100% of their annual eligible compensation as defined by the Plan, up to the maximum dollar limits allowable by law. New participants who meet eligibility requirements are automatically enrolled with an initial 2% salary deferral contribution. At any time, participants can elect not to contribute or may increase or decrease the deferral rate to any rate allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans. The Company made discretionary matching contributions equal to 50% of participant's elective deferral up to 6% during the years ended December 31, 2024 and 2023. The Company made a lump sum discretionary profit-sharing contribution totaling \$175,000 for the year ended December 31, 2024. The Company made no discretionary profit-sharing contributions for the year ended December 31, 2023. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's discretionary matching contributions and discretionary profit-sharing contributions and b) Plan earnings or losses. The Company's discretionary matching contributions are allocated among participants based upon each contributing participant's elective deferrals. The Company's discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant.

Effective October 11, 2024, investments are maintained in individual member accounts by John Hancock Life Insurance Company (John Hancock). For the period from January 1, 2024 to October 11, 2024, investments were maintained in individual member accounts managed by Matrix Trust Company (Matrix). Prior to January 1, 2024, investments were maintained in individual member accounts managed by United of Omaha Life Insurance Company (United of Omaha).

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions credited to participants' accounts is based on years of continuous service. A participant is 20% vested after the first year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates.

### ***Payment of Benefits***

Upon retirement, termination, disability, or death, the participant or beneficiary may elect to receive either a lump sum, partial payments, or installment payments equal to the value of the vested funds allocated to the participant's account. Effective January 1, 2024, The Plan requires that distribution payments between \$1 and \$7,000 be directly rolled over to an individual retirement account designated by the plan administrator. Prior to January 1, 2024, distributions under \$1,000 were paid out to the participant and distributions between \$1,000 and \$5,000 were rolled over into an individual retirement account unless the participant elected otherwise. Benefits are recorded when paid.

### ***Deposits with Insurance Company***

The guaranteed investment accounts, which are part of the investment contract with John Hancock (effective October 11, 2024) and United of Omaha (prior to October 11, 2024), credit interest daily. The crediting interest rate with John Hancock at December 31, 2024, for the contract was 2.25%. The crediting interest rates with United of Omaha at December 31, 2023, for the contracts ranged from .66% to 5.20%. The crediting interest are reset upon the maturity of the contracts.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses or to reduce future Company contributions. During 2024 and 2023, discretionary matching contributions were reduced by \$14,234 and \$18,443, respectively. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,351 and \$4,703, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, except for fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through guaranteed interest accounts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Expenses*

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of payment of benefits and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Reclassifications*

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 3, 2025, noting no items for disclosure.

### 3. Information Certified by John Hancock, Matrix, and United of Omaha

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, the current custodian, and Matrix and United of Omaha, the former custodians, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023, except for applying the net asset value (NAV) practical expedient to 2024 and 2023 balances.

*Pooled Separate Accounts:* Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these accounts meet those requirements. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock.

The Plan had an investment contract with United of Omaha, the former custodian. United of Omaha maintained the contributions in pooled separate accounts and a guaranteed interest account. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by United of Omaha.

The pooled separate accounts, as reported to the Plan by John Hancock and United of Omaha, are included in the financial statements at December 31, 2024 and 2023 at fair value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

As the guaranteed interest accounts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by John Hancock and United of Omaha, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### 6. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

#### 8. Related Party Transactions

---

Certain Plan assets at December 31, 2024, include cash held by John Hancock and investments in pooled separate accounts and a guaranteed interest account managed by John Hancock. John Hancock is the current custodian of the Plan, therefore these transactions qualify as party-in-interest transactions.

#### 9. Change in Trustee and Recordkeeper

---

Effective October 11, 2024, John Hancock was appointed as the new trustee and record-keeper of the Plan. The Plan's net assets transferred to John Hancock were placed in new funds based on each participant's date of birth if not elected differently by the participant. The conversion initiated a "Black Out" period beginning October 3, 2024, and continued through October 10, 2024. During this period, employee contributions continued to be made through payroll deductions and the contributions were wired to John Hancock and invested according to participant investment choices.
