Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Stephen Joseph, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1: Plan Description

The following description of the Stephen Joseph, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a contributory, defined contribution plan covering substantially all employees of Stephen Joseph, Inc. (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility. Employees are eligible to participate in the Plan when they are hired. Employees become eligible to receive employer contributions after attaining the age of 21 and completing one year of service. Plan entry dates are the first January 1st or July 1st coinciding with or next following satisfaction of the eligibility requirements.

Contributions. Under the Plan, both participants and the Sponsor are allowed to make contributions. Participant contributions may consist of pre-tax 401(k) deferrals, after-tax Roth 401(k) deferrals, or rollover contributions. Participant contributions are subject to certain annual limitations under provisions of the Internal Revenue Code (the Code). Participants can revoke their salary deferral elections at any time, and changes to salary reductions are permitted at least once per year.

The Sponsor may make discretionary matching contributions to the Plan, as determined annually, up to 4% of each participant's compensation. The Sponsor may also make discretionary profit-sharing contributions to the Plan, as determined annually. In order to receive matching contributions, the participant must be employed on the last day of the Plan year. The Sponsor did not make any matching or profit-sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

Participant Accounts. Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions, as well as the investment earnings or losses thereon, and allocations of any administrative expenses. Sponsor profit-sharing contributions, if any, are allocated pro rata based on participant compensation.

Vesting. Participants are always fully vested in their contributions and earnings thereon. Participants vest in the Sponsor contribution portions of their accounts (if any, including the related earnings) based on a 6-year graded vesting schedule.

Forfeitures. Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. As permitted by the Plan, forfeitures may be used to pay Plan expenses or reduce certain employer contributions. There were no unallocated forfeitures at December 31, 2024 and 2023.

Payment of Benefits. On termination of service due to death, disability, retirement, or for other reasons, the participant or their beneficiary may elect to receive: (a) a lump-sum amount equal to the value of the participant's vested interest in their account, (b) installments over a period of time not more than their life expectancy, or (c) partial withdrawals of at least \$1,000 each, with certain exceptions. Terminated participants with vested account balances of \$5,000 or less are eligible to receive distributions in a single lump sum only. The Plan also permits in-service withdrawals under certain circumstances. Participant loans are not permitted by the Plan.

Plan Termination. Although they have no intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would automatically become fully vested.

Note 2: Summary of Significant Accounting Policies

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), including specialized industry practices as specified in the American Institute of Certified Public Accountants audit and accounting guide titled *Audits of Employee Benefit Plans*.

Use of Estimates. Financial statements prepared in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Values. Investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Dividends are recorded on the ex-dividend date.

Payment of Benefits. Benefits are recorded when paid.

Administrative Expenses. Certain administrative services and the use of office fixtures and equipment are provided to the Plan by the Sponsor, with no provision for these costs included in the accompanying financial statements. These costs were not significant for the years ended December 31, 2024 and 2023. All other administrative expenses are recognized when incurred.

Prohibited Transactions. A "party-in-interest" is a fiduciary or employee of the Plan, any person who provides services to the Plan, the Sponsor or an employee association whose members are covered by the Plan, a person who owns 50 percent or more of the Sponsor or such employee association or relatives of such person just listed. Under ERISA, a Plan fiduciary is prohibited from causing the Plan to engage in the following transactions with a party-in-interest, with certain conditional exemptions provided by ERISA:

- A sale, exchange, or lease of property;
- A loan or other extension of credit;
- The furnishing of goods, services, or facilities;
- A transfer of plan assets to a party-in-interest for the use or benefit of a party-in-interest; or
- An acquisition of employer securities or real property.

A fiduciary is also generally prohibited from using the Plan's assets for his or her own interest or account, acting in any Plan transactions on behalf of a party whose interests are adverse to those of the Plan or its participants and receiving consideration for his or her own account from a party dealing with the Plan in connection with a transaction involving the Plan's assets.

The Plan did not engage in any prohibited transactions for the years ended December 31, 2024 and 2023.

Tax Status. The Internal Revenue Service (IRS) has issued an opinion letter determining that the prototype non-standardized plan is acceptable under Section 401(a) of the Code. It is not a ruling or determination as to whether the Plan itself is qualified; however, an employer adopting this plan will be considered to have a qualified plan. In addition, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. There are currently no audits for any tax periods in progress. Generally, the Plan's tax returns are subject to examination for three years after they are filed.

Note 3: Data Prepared and Certified by Custodians

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Principal Trust Company (Principal) and Matrix Trust Company (Matrix), the custodians of the Plan. Principal held the Plan's investment assets and executed investment transactions for the period from November 15, 2024 to December 31, 2024, and Matrix held the Plan's investment transactions for the period from January 1, 2023 to November 14, 2024.

For the year ended December 31, 2024, Principal and Matrix have also certified the completeness and accuracy of the net appreciation in fair value of the Plan's investments totaling \$271,820, and interest and dividend income totaling \$8,010. For the year ended December 31, 2023, Matrix has also certified the completeness and accuracy of the net appreciation in fair value of the Plan's investments totaling \$372,396, and interest and dividend income totaling \$61,665.

Certain investments are shares of mutual funds managed by Principal. Principal is the custodian as defined by the Plan, therefore these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with such securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6: Reconciliation of Financial Statements to Form 5500

The Form 5500 is a joint-agency form, developed by the IRS, the U.S. Department of Labor, and the Pension Benefit Guaranty Corporation, which may be used to satisfy the annual reporting requirements of the Code and Titles I and IV of ERISA. The Plan is required to file a Form 5500 annually, with audited financial statements enclosed. There were no reconciling items between the Form 5500 and the accompanying financial statements as of and for the years ended December 31, 2024 and 2023.

Note 7: Subsequent Events Evaluation

Management has evaluated subsequent events through September 30, 2025 the date which the financial statements were available to be issued. No material subsequent events have occurred during this time which would require recognition in the financial statements or footnotes as of and for the year ended December 31, 2024.
