Notes to Financial Statements

Note 1: Description of Plan

The following description of the Pana Community Hospital Employees' Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Pana Community Hospital (the "Sponsor") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Eligibility

Employees become eligible to participate in the Plan immediately upon employment. To be eligible for the purpose of receiving matching sponsor contributions, employees must complete three months of service and must be 18 years of age or older. Eligible employees begin receiving sponsor contributions the first day of the month following the attainment of these requirements.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan also includes auto-enrollment provisions whereby all new employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contribution invested in a designated balanced fund until changed by participant. The Plan currently offers an insurance investment contract and various mutual funds as investment options for participants.

Employer Match

The Sponsor matches 50% of the first 8% of a participant's annual compensation that a participant contributes to the Plan.

Employer Match (Continued)

For the plan years ended December 31, 2024 and 2023, an additional employer matching contribution was approved by the Sponsor in the amount equal to the following percentages:

Years of Service	Matching Percentage
Less than 10 years	0%
10 to 19 years	100%
20 or more years	200%

The additional matching contribution only applies to the eighth percent of compensation deferred and does not apply to any elective deferral contributions that are over or under the 8% deferral rate. In addition, the additional matching contribution is calculated based on elective deferral contributions and compensation for the payroll period and made for active participants at any time during that payroll period.

Participant Accounts

Each participants' account is credited with the participant's and Sponsor's contributions and allocations of plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and actual earnings/losses thereon. Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months. Vesting in the Sponsor's matching contributions is based on years of service in accordance with the following vesting schedule:

Years of Service	Vesting Percentage
2 years	20%
3 years	40%
4 years	60%
5 years	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined by the plan administrator. The term of the note may not exceed five years, unless the loan proceeds will be used to acquire the principal residence of the participant, then the term cannot exceed thirty years. Principal and interest is paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum or other form of payment equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for in-service distributions upon attaining age 59 ½.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. If the participant is reemployed and fulfills certain requirements, the forfeitures can be restored. Forfeitures remain in the Plan and are used to reduce the Sponsor's contributions or to reduce the Sponsor's administrative expenses. At December 31, 2024 and 2023, respectively, there was \$0 and \$7,777 of unallocated forfeitures from nonvested accounts.

For the years ended December 31, 2024 and 2023, Sponsor contributions were reduced by \$29,625 and \$14,128 respectively, from forfeited nonvested accounts. For the years ended December 31, 2024 and 2023, the Sponsor used forfeited nonvested accounts to pay administrative expenses of \$3,079 and \$14,264, respectively.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive investment contracts are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account against the investment option for which the loan was originally charged. Investment advisory and management fees are allocated proportionately to participants based on their respective account balances. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Notes to Financial Statements

Note 3: Fair Value Measurements (Continued)

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 4: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair values of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended were obtained or derived from information certified as complete and accurate by Delaware Charter and Trust Company d/b/a Principal Trust Company (Principal), the custodian of the Plan for the period.

Note 5: Guaranteed Investment Account

The Plan entered into a fully benefit-responsive investment contract with Principal who maintains the contributions in a general account. The fixed accounts are credited with a fixed rate of interest and charged for participant withdrawals and administrative expenses. Principal guarantees that the interest will be credited at the higher of the rate guaranteed in the group annuity contract or the declared current rate. As of December 31, 2024 and 2023, the crediting interest rate was 4.85% and 6.05%, respectively.

The annuity contracts are stated at contract value. Contract value is equal to the principal invested in the contract plus interest earned. There is no liquid market value because the contracts are not tradable or assignable and there are no defined maturities of the cash flows.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity was provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan, or (4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Additionally, the contract does not allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor matching contributions.

Note 7: Tax Status

The Plan adopted a nonstandard prototype plan with an IRS determination letter dated March 31, 2017, which states the prototype plan was in compliance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-In-Interest Transactions

Certain plan investments are managed by the custodian and an affiliate of the custodian, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan to Principal for administrative services amounted to \$69,347 and \$63,470 for the years ended December 31, 2024 and 2023, respectively.
