### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Beacon Retirement Savings 403(b) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Note 1. Description of the Plan**

The following description of the Beacon Retirement Savings 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan is a defined contribution plan sponsored by Beacon Health System, Inc. (Company) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Company. Participants who have met certain eligibility requirements are also eligible for employer matching contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

The Plan uses Transamerica Financial Life Insurance Company, Inc. (TFLIC), Transamerica Life Insurance Company, Inc. (TLIC), and State Street Bank and Trust Company (SSBT) as custodians and Transamerica Retirement Solutions (Transamerica) as the recordkeeper.

**Contributions**

Each year, participants may voluntarily contribute the maximum amount allowed by law of pretax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Code limit. Catch-up and rollover contributions are allowed by the Plan Document. Employees are automatically enrolled upon hiring. A participant's deferral rate is set at 3% of eligible compensation, unless changed by the participant. The Plan includes an auto escalation of employee contribution deferral percentage which increases by 1% per year up to a maximum of 10%.

The Plan includes multiple employers of the Company who, depending on the employer, make matching contributions ranging from 50-100% on the first 4% of base compensation that a participant contributes to the Plan, up to a maximum of 2% or 4% of annual compensation. The Plan also allows for a discretionary match.

Participants may also contribute amounts representing distributions from other qualified plans.

**Participant Investment Account Options**

Upon enrollment, a participant may direct the Company's contributions to any of the fund options offered by the Plan. Participants may change their investment options at any time.

**Participant Accounts**

Each participant's account is credited with the participant's rollover contributions, participant's contributions, Company contributions, and allocations of the Plan's earnings (losses) and administrative expenses and charged with benefit payments. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account plus earnings thereon is based on years of continuous service and varies based on the election of each employer. Nonvested contributions and accrued earnings are forfeited upon termination of service.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$160,807 and \$20,287, respectively. These accounts will be used to reduce future employer contributions or pay certain Plan expenses. Employer contributions were reduced \$2,762 and \$555,973 from forfeited nonvested accounts in 2024 and 2023, respectively.

***Notes Receivable From Participants***

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan terms generally range from one to five years, except for loans used to acquire a principal residence, which have terms to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates in effect at the time of the disbursement of the loan. Participants are limited to one loan at a time and the minimum loan amount is \$1,000. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, retirement, death, or disability, a participant may receive a lump-sum payment equal to the value of his or her account. In-service and hardship withdrawals are also available as described in the Plan Document.

If the Plan Administrator is unable to locate any person to whom an account balance under the Plan is required to be distributed under the Plan or by law, the Plan Administrator shall dispose of such person's account balance. The Plan Administrator shall deposit such person's vested account balance into a federally insured, interest-bearing bank account per the method chosen by and for the benefit of such person.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend, modify or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments.

***Mutual Funds and Self-Directed Brokerage Accounts***

Mutual funds and self-directed brokerage accounts are publicly-traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Variable Annuity Accounts***

Participants purchase accumulation units in variable annuity contracts and their value is calculated daily. Variable annuity accounts are recorded at fair value, which is based upon the underlying value of the assets. The amortized cost of an instrument is determined by valuing it at its original cost and, thereafter, amortizing any discount or premium from its face value at a constant rate until maturity.

***Guaranteed Investment Contracts***

The Guaranteed Investment Contracts (GIC) are valued at contract value. Contract value, as reported to the Plan by the insurance companies, represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. The investment contract contains liquidity restrictions as defined in the investment agreements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

***Plan Tax Status***

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service only recently began providing that service for individual 403(b) plans. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Substantially all expenses incurred in connection with the administration of the Plan are paid by the Company.

**Note 3. Certification by Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TFLIC, TLIC and SSBT, the qualified institutions serving as custodians, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.

Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employee association or relatives of such person.

The Plan holds investments managed by entities related to Transamerica, the record keeper of the Plan. These transactions qualified as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

The Plan paid \$854,137 and \$766,745 of recordkeeping fees to Transamerica during the years ended December 31, 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties in interest aggregated \$45,761 and \$106,430 during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Recurring Measurements**

***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no investments classified at Level 3. See Note 2 for definition of inputs utilized to determine fair value.

**Note 6. Investment Contract with Insurance Company**

The Plan invests in fully benefit-responsive GICs. The issuers maintain the contributions in their general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by the issuers, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.2% for the TFLIC Fixed Funds and 1% for the Standard Stable Asset Fund I. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date. The investment contracts are traditional investment contracts.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Plan Merger**

Effective January 1, 2023, the Three Rivers Health System, Inc. Employee Savings Plan merged into the Plan. The Plan was amended to incorporate certain provisions of the merged plan as described in Note 1. All employer matching and nonelective contributions accrued in the merged plan became 100% vested to participants as of the effective date of the merger.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.

Subsequent to year end, there were amendments made to the Plan related to eligible compensation as well as employer match provisions for certain groups of employees. These amendments are not expected to have a significant effect on the Plan.
