Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Van Wyk/Link Manufacturing/Maintainer Corporation 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Alerus Financial, N.A. (Alerus) as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF PLAN

The following description of Van Wyk/Link Manufacturing/Maintainer Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Link Mfg., Ltd., Van Wyk, Inc., Maintainer Corporation of Iowa, Inc., and Combined Resources, Inc. (the Companies) who are at least 18 years old; and for Van Wyk, Inc. and Combined Resources, Inc., have completed one year of service; and for Link Mfg., Ltd. and Maintainer Corporation of Iowa, Inc., have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations, and contributions can be designated as a pretax or Roth contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan's investment options currently include more than 15 mutual funds and an investment contract. The Companies fund the participants' contributions on a per pay period basis. The Companies' matching contributions are calculated as follows:

Link Mfg., Ltd. and Maintainer Corporation of Iowa, Inc.

The Companies match 50% of participant contributions up to a maximum of 2% of compensation.

Van Wyk, Inc. and Combined Resources, Inc.

The Companies match 200 percent of the first \$150 the participant contributes and 40 percent of the next \$500 up to a maximum of \$500 per year.

The Plan document allows the Companies to make discretionary profit-sharing contributions. Link Mfg., Ltd made profit sharing contributions for 2024 and 2023, which are paid in lump sums before the Company files its federal income tax return.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Companies' matching and discretionary profit-sharing contributions, and an allocation of the Plan's earnings or losses and is charged with an allocation of administrative expenses. Allocations to the participants' accounts are based on the ratio of the account balance of the individual participant to the aggregate of all account balances of all participants in the fund within the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN - Continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 20% vested after two years of service and increases 20% per year thereafter and then becomes 100% vested upon completing six years of credited service.

Payment of Benefits

Upon retirement, a participant may elect to receive either a lump sum amount equal to the total value of the participant's account or periodic installments over a period not to exceed the participant's life expectancy. On termination of service, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

Forfeited nonvested accounts may be used to reduce administrative expenses and/or to reduce future employers' contributions. Forfeited nonvested accounts available for use at December 31, 2024 and 2023 totaled \$78,196 and \$58,277, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of the financial statements.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Shares of mutual funds are valued at quoted market prices which represent the net asset values of shares held by the Plan at year end. Fair value of the common trust fund is determined by the fund trustee based on the fair value of the underlying securities within the fund, which represent the net asset value of the shares held by the Plan at year end. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the custodians. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment Valuation and Income Recognition - Continued

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation or depreciation in fair value of investments includes gains and losses in investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds and common trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Excess Contributions Payable

Amounts payable to participants totaling \$28,961 and \$56,692 for 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions of the following year. The Plan distributes the excess contributions prior to March 15 of the following year.

Administration of Plan Assets

The Plan's assets are held in trust by Alerus Financial, N.A., a federally chartered bank (Alerus), the custodian of the Plan. The contributions are held and managed by Alerus who invests the Plan's assets and pays benefits to the participants. Custodian and investment management fees are paid from the assets of the Plan. Certain administrative expenses have been paid by the Corporation.

Benefits Payable

Distributions to participants are recorded in the year paid.

Net assets available for benefits included \$0 and \$46,692 for 2024 and 2023 for distributions to participants who have requested a distribution from the Plan prior to the end of the Plan year.

Date of Management's Review

Subsequent events were evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE OF INVESTMENTS

The Plan's mutual fund investments are reported at fair value. GAAP has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of observable inputs other than quoted prices for identical assets.
- Level 3 inputs consist of unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumption.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methods used for investments measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Following is a description of the valuation methodologies used for assets that are measured at Net Asset Value (NAV) as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy.

Common Trust Fund - Valued at the NAV of units of a bank common trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's policy is to recognize transfers between levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

4. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a common/collective trust sponsored by Alerus Financial, N.A., the Plan's Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan has a cash account held by the Trustee. The transactions within this account also qualify as party-in-interest transactions; however, these cash transactions are exempt from the prohibited transaction rules under ERISA. The balance in the cash account at December 31, 2024 and 2023 was \$80,574 and \$4,978, respectively.

5. PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the net assets of the Plan must be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

6. INCOME TAX STATUS

The Plan has adopted a non-standardized prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the prototype document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements. Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and the plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Future qualification of the Plan will depend on operation of the Plan in compliance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and has concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such elections, Alerus, as custodian of the Plan, has certified the completeness and accuracy of all of the cash and investments in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets held for investment purposes as of December 31, 2024, and the net investment income in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Accordingly, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures on these accounts.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
