### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the NetBase Solutions, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters we identified during the audits.

### 1. Description of the Plan

NetBase Solutions, Inc. (the Company) established the NetBase Solutions, Inc. 401(k) Plan (the Plan), effective January 1, 2006 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

On April 14, 2023, the Plan was amended to add Rival IQ Corporation (Rival IQ) as a participating employer.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a committee, composed of Company employees, responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests and reinvests trust assets in the interest and at the direction of participants and their beneficiaries.

#### *Eligible Participants:*

Eligible employees, as defined by the Plan agreement, aged 21 or older may participate in the Plan the first day of the month following their date of hire.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax and after-tax Roth salary deferral contributions of up to 80% of eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 can elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

---

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Company may make discretionary matching contributions to the Plan at the discretion of the Board of Directors. In 2024, the Company made discretionary matching contributions to employees equal to 50% of participant contributions, up to a maximum of 4% of eligible compensation, as defined by the Plan agreement. Additionally, in 2024, the Company made discretionary matching contributions to Rival IQ employees equal to the sum of 100% of the amount of participant elective deferrals that do not exceed 3% of participant compensation, plus 50% of the amount of deferrals that exceed 3% but do not exceed 5% of participant compensation, as defined by the Plan agreement. Company matching contributions were \$388,691 in 2024, of which \$43,790 relates to annual true-up contributions receivable as of December 31, 2024.

The Company may also make discretionary nonelective contributions to the Plan at the discretion of the Company's Board of Directors. The Company has not made any discretionary nonelective contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts are credited with the participant contributions and rollovers, an allocation of Company contributions, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

In addition, participants can choose to invest in and manage a broader range of investments through participant-managed Fidelity self-directed brokerage accounts. Investment choices offered to participants in these participant-managed retirement accounts include most equity securities listed on major stock exchanges in the United States of America (U.S.), additional mutual funds, over-the-counter stocks, bonds and other fixed-income securities.

#### *Vesting:*

Participants are fully vested (100%) in their participant accounts.

### 1. Description of the Plan (continued)

#### *In-Plan Roth Conversions:*

The Plan allows participants who are active employees of the Company to convert any portion of their contributions and Company contributions to Roth designated contributions. In 2024, \$1,164 of non-Roth balances were converted to Roth balances.

#### *Forfeitures:*

Any forfeited account balances would be forfeited upon distribution of the vested account balance. Forfeitures would be retained in the Plan and used to pay Plan administrative expense or reduce Company contributions. Prior to September 1, 2022, Company contributions were subject to vesting resulting in forfeited non-vested accounts of \$16,210 and \$2,028 as of December 31, 2024 and 2023, respectively.

#### *Notes Receivable from Participants:*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a term of up to 30 years may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the balance in the participant account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator under the note policy. The interest rates on the notes outstanding as of December 31, 2024 ranged from 9.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

#### *Payment of Benefits:*

Upon termination of service, participants may elect to leave their balance in the Plan or receive their benefits in a lump sum amount equal to the balance of their accounts. Accounts with balances between \$1,001 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts with a balance of \$1,000 or less may be distributed directly to participants without participant approval. The Plan agreement also allows for in-service and hardship distributions to current employees. Benefits are recorded when paid.

#### *Administrative Expenses:*

Plan investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain expenses may be charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the financial statements.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants, as described in the Plan agreement.

### 2. Summary of Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the U.S. (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### 2. Summary of Accounting Policies (continued)

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

#### *Investments:*

The Plan's investments, consisting of mutual funds, equity securities, a money market fund, cash accounts, and a collective investment trust, are accounted for as follows:

*Mutual Funds and Money Market Fund:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in active markets.

*Participant-Managed Retirement Accounts (PMR Accounts):* Fidelity self-directed brokerage accounts consist of shares of various equity securities, valued based on quoted prices in active markets, and cash accounts.

*Collective Investment Trust:* The Plan invests in a fully benefit-responsive investment contract through the Morley Stable Value Fund (the CIT). The CIT is valued using the NAV practical expedient for the CIT as reported by the CIT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CIT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of the CIT is calculated based on a compilation of primarily observable market information.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner.

### 2. Summary of Accounting Policies (continued)

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- **Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- **Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- **Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds, money market fund, and participant-managed retirement accounts are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The collective trust is valued based on the NAV practical expedient and is excluded from the fair value hierarchy under GAAP.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Plan investments include investments managed by Fidelity. As Fidelity is the Plan's trustee, purchases and sales of these investments qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Nonexempt Prohibited Transactions

In 2022, the Company did not remit participant contributions and note repayments totaling \$2,629 in a timely manner as required by the Department of Labor (DOL). The DOL considers these delinquent remittances to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status. The Company remitted estimated lost earnings related to the delinquent remittances to the Plan in 2024.
