We have performed audits of the accompanying financial statements of Generac Power Systems, Inc. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Generac Power Systems, Inc. Employees' 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined-contribution plan sponsored by Generac Power Systems, Inc. and participating employers (the "Company" or "Sponsor"). Fidelity Management Trust Company (Fidelity), State Street Bank and Trust Company (State Street), and Transamerica Life Insurance Company (TLIC) were the custodians of the Plan from the period January 4, 2024 through December 31, 2024. State Street and TLIC were the custodians of the Plan from the period January 1, 2023 through January 3, 2024.

Effective January 1, 2024, the Deep Sea Electronics, Inc. 401(k) Plan was merged into the Plan as a result of an acquisition by the Company. Approximately \$777,000 of net assets of Deep Sea Electronics, Inc. 401(k) Plan were transferred to the Plan.

Effective July 17, 2024, the Ecobee LTD Retirement Plan was merged into the Plan as a result of an acquisition by the Company. Approximately \$952,000 of net assets of Ecobee LTD Retirement Plan were transferred to the Plan.

Eligibility and Participation

All full-time employees of the Company are eligible to participate on the first day of the month following the date the employee completes 28 days of service. As of January 1, 2024, long-term part-time employees who worked more than 500 hours in three consecutive years may enter the Plan on January 1st or July 1st subsequent to satisfying their eligibility requirements. Prior to January 1, 2024, part-time employees were eligible to participate on January 1st or July 1st after completing 12 months of consecutive service, starting with the employee's hire date, and accumulated over 1,000 hours. Eligibility requirements are the same for the discretionary matching contribution.

Participants are eligible to receive a discretionary Company non-elective contribution if they satisfied the eligibility requirements based on years of service as of December 31, 2008, and are employed by the Company on the last payroll date of the Plan year.

Contributions

Each year participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the limits of the Internal Revenue Service (IRS), or the Plan, as defined. Eligible employees that do not make a deferral election are automatically enrolled to contribute 3% of compensation, which is automatically increased by 1% every January 1st, up to 6%, unless they elect not to participate in the plan. Participants may also contribute distributions from other qualified plans (rollovers).

Note 1: Description of Plan (Continued)

Contributions (Continued)

In 2024, the Company made a discretionary matching contribution equal to 50% of a participant's contributions to the Plan, up to 8% of compensation, as defined.

On a discretionary basis, the Company may make non-elective contributions that are allocated to eligible participants based on the number of years of service a participant completed as of December 31, 2008. For the year ended December 31, 2024, the Company made a non-elective contribution of \$280,526, which was fully funded through forfeitures.

Funding

The Sponsor remits participant elective contributions and Company matching contributions to the Plan as soon as practical after amounts are withheld from participants' wages. Company non-elective contributions, if any, are remitted to the Plan annually, generally in the first quarter of the following year.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching and non-elective contributions, and allocations of Plan net earnings (losses) thereon. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions, plus actual earnings (losses) thereon.

Vesting in the Company matching and non-elective contributions, plus actual earnings (losses) thereon, is based on years of service and vest according to the following schedule.

Forfeitures

Forfeitures are portions of participant account balances that are surrendered by terminating participants prior to becoming fully vested. Forfeitures are used to offset Plan expenses or reduce Company matching or non-elective contributions. At December 31, 2024 and 2023, unallocated forfeitures were \$529,022 and \$693,558, respectively. During 2024, \$1,443,554 of forfeitures were used to reduce Company matching and non-elective contributions and \$216,251 of forfeitures were used to pay Plan expenses.

Investment Options

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Notes Receivable from Participants

Participants may borrow from their account balance the lesser of \$50,000 or one-half of the participant's vested account balance, with a minimum of \$1,000. Notes to participants are treated as a separate investment of the participant and all principal and interest payments on note balances are credited to the participant account from which the note was made. Notes are secured by the balance in the participant's account and bear interest between 3.25% and 8.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. Benefit payments are made in the form of a lump-sum. Under certain circumstances, participants may qualify for hardship withdrawals. If a terminated participant's vested account balance does not exceed \$5,000, the Plan will distribute the benefit in a lump-sum as soon as administratively practical.

Account balances between \$1,000 and \$5,000 are rolled over into an IRA account in the participant's name if they have not provided direction for distribution. Vested account balances exceeding \$5,000 are paid at the participant's discretion or can be left in the Plan until such time the participant reaches age 73.

Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amounts participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on an accrual basis. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan and are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. Certain administrative expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment-related expenses are included in net appreciation in fair value of investments. All other administrative expenses are paid by the Company and are excluded from these financial statements.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision(s) to elect in the future.

Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

On April 1, 2025, the GMT 401(k) Plan was merged into the Plan. Participants of the merged plan are eligible to participate in the Plan as of April 1, 2025.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

Common/collective trust funds: Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. These funds are stable funds and their NAVs are based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Guaranteed Investment Account

The Plan maintains a fully benefit responsive investment in a guaranteed investment account with TLIC. TLIC maintains the contributions in a general account. The account is credited with earnings on investments and charged for participant withdrawals and administration expenses. The fund is stated at contract value, which approximates fair value. As such, no adjustment from fair value to contract value is presented on the Statements of Net Assets Available for Benefits for the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, however, there is no guarantee of a certain interest rate. The interest rate for 2024 was 3.25%. Such interest rate are reviewed for resetting.

Note 5: Information Prepared and Certified by the Custodians

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, interest and dividends, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Fidelity as of December 31, 2024 and for the period from January 4, 2024 to December 31, 2024, and State Street and TLIC as of December 31, 2024 and 2023 and the period from January 1, 2023 to December 31, 2024.

Note 6: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 7: Tax Status

The IRS has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8: Party-In-Interest Transactions

The Plan holds investments which are managed by Fidelity. As noted in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various services providers. These transactions and notes receivable from participants qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 9: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.
