### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Veolia WTS 401(K) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## *Notes to Financial Statements*

### 1. Description of the Plan

The following description of the Veolia WTS 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan was established on October 1, 2017. The Plan is a defined contribution plan covering substantially all employees of Veolia WTS USA, Inc. and its affiliated companies (collectively, “Veolia” or the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”) and is administered by the Retirement Committee of Veolia.

#### **Eligibility**

Employees of the Company are eligible to participate in the Plan and receive a matching contribution immediately upon being hired.

#### **Contributions**

The Plan provides each participant with an opportunity to make pre-tax, Roth or after-tax contributions to the Plan up to 50% of a participant’s compensation, subject to the limitations of the Internal Revenue Code. Employees are automatically enrolled in the Plan at a 3% pre-tax deferral percentage. Employees may elect not to participate in the Plan. Employees who are automatically enrolled in the Plan will have their deferral percentage escalated by 1% each January 1, unless the employee makes a contrary election. The automatic escalation cannot increase an employee’s pre-tax deferral percentage higher than a maximum rate of 6%.

The Company is required to make safe harbor matching contributions equal to 100% of the first 2% of a participant’s salary deferral contributions plus 50% of the next 4% of a participant’s salary deferral contributions calculated on a pay period basis. The Company is also required to make a non-elective contribution to all eligible employees equal to 3% of eligible compensation calculated on a pay period basis.

#### **Participant Accounts**

Each participant’s account is credited with their contributions, the Company’s contributions and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provision of the Plan. Plan earnings are allocated based on participant balances in each fund. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

All participants are immediately and fully vested in their own contributions plus the Company’s safe harbor matching contributions, plus actual earnings thereon. Participants become fully vested in the Company’s non-elective contributions after three years of service.

#### **Forfeitures**

The Plan provides for terminated employees who resume employment within five years to have any forfeited amounts reinstated (“reinstatement period”), if the employee repays the full amount of the distribution attributable to vested employer contributions prior to the end of the reinstatement period. Plan participants’ forfeitures may be used to pay Plan expenses or reduce the Company contributions for the year and, if applicable, any remaining amounts shall be applied toward succeeding plan years until fully utilized. Plan forfeitures of \$1,005,975 and \$350,860 were applied in conjunction with the payment of the plan expenses and Company contributions for the years ended December 31, 2024 and 2023, respectively. Forfeitures from employees for the years ended December 31, 2024 and 2023 were \$888,105 and \$506,626, respectively. Forfeitures transferred from the Suez Treatment Solutions Inc. Employees 401(k) Investment Plan amounted to \$2,166 and \$1,600 during the years ended December 31, 2024 and 2023, respectively. The available balance of forfeitures for the years ended December 31, 2024 and 2023 were \$366,418 and \$466,547, respectively.

## **Benefits**

A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to the specific guidelines as set forth in the plan document.

## **Notes Receivable from Participants**

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of a loan is five years; or fifteen years, if the loan is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Notes receivable from participants are repaid through payroll deductions and monitored by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Cost of securities sold is determined by the specific identification method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are classified as distributions based upon the terms of the Plan Document.

### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan document.

### 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies during 2024 and 2023.

- *Mutual funds*: valued at quoted prices reported in an active market at the year end.
- *Money market fund*: valued at cost plus accrued interest, which approximates fair value.
- *Common Collective Trust Funds (CCT)*: The fair value of the common collective trust funds is determined by the custodian of the fund based on the underlying assets, which represent the net asset value of units held by the Plan. The common collective trust funds do not have any unfunded commitments relating to its investment in the common collective trust fund, or any significant restrictions on redemptions. Participant directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, amounts credited to the participants' accounts as of the date of termination will be fully vested.

### 6. Tax Status

The Plan operates under a non-standardized Pre-Approved Profit-Sharing Plan with CODA adoption agreement in connection with a volume submitter retirement plan and trust/custodial document sponsored by Fidelity. This volume submitter plan document has been filed with the appropriate agency and is accurate. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee (or custodian) as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company directly pays any other fees related to the Plan's operations.

Fidelity Management Trust Company ("Fidelity") is the record keeper for the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity for record keeping and administrative services amounted to \$266,231 and \$411,216 for the years ended December 31, 2024 and 2023, respectively.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Such securities are subject to various risks such as interest rate, market and credit risks, which determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
