Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Goodwill Industries Employee Savings Plan (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Goodwill Industries Employee Savings Plan (the Plan), provides only general information. Participants should refer to the official plan document for important details not included in these notes.

- a. **General** – The Goodwill Industries Employee Savings Plan, a defined contribution 401(k) plan, became effective January 1, 1997. The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), was created for the benefit of all eligible employees of Goodwill Industries of the Inland Northwest (the Organization). Employees may enter the Plan on the first entry date immediately following the completion of one year of service and attaining 21 years of age. Entry dates occur on January 1 and July 1. Effective January 1, 2023, the age requirement for participant entry to the plan was reduced to 18 years of age.
- b. **Contributions** – Participants make voluntary tax-deferred and/or after tax (Roth) contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum allowable contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Upon enrollment in the Plan, a participant may direct contributions to any of the available investment options offered by the Plan. Employer match contributions are made every pay period. Such contributions are allocated to all eligible employees who have completed at least 1,000 hours of service during the plan year and who are still employed as of the end of the plan year. From January 1, 2023 through June 30, 2023, the employer made matching contributions of the greater of 5% or \$5,000 per participant and from July 1, 2023 through December 31, 2024, the employer made matching contributions of the lesser of 5% or \$5,000 per participant. A participant who receives a distribution from another qualified plan may make a rollover contribution to the Plan provided that certain conditions are met, including the approval of the plan administrator.
- c. **Participant accounts** – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Organization’s contributions, if any, and (b) plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.
- d. **Vesting** – Effective January 1, 2023, participants were immediately 100% vested in employer matching contributions.
- e. **Payment of benefits** – Normal retirement under the Plan occurs at age 65. Upon retirement or termination of employment, participation in the Plan will cease and benefits will be distributed according to provisions set forth in the plan document. All vested account balances less than \$5,000 shall be distributed in a lump-sum payment or rolled over into another qualified plan. If the participant’s vested account balance exceeds \$5,000, distribution shall be in a lump-sum payment or installment payments over a specified period of time. The method of distribution is elected by the participant. Participants with vested account balances exceeding \$5,000 that have retired or terminated employment before reaching normal retirement age may elect to defer distribution to a later date (but not beyond normal retirement age).

Note 1 – Description of the Plan (Continued)

- f. **Administration of the Plan** – The Plan is administered by the Organization in the form of a Board of Trustees consisting of Organization officers. No such officer or employee receives compensation from the Plan. Plan assets are held by the Plan’s investment advisor and trustee, Capital Bank and Trust Company (Capital Bank). Records of participant account activity are processed and maintained by Hunter Benefits Consulting Group, Inc., which also performs other administrative support services for the Plan. Administrative expenses are paid by either the Plan or the Plan’s sponsor as provided by the plan document.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accounting records of the Plan are maintained on the accrual method of accounting.
- b. **Investment valuation and income recognition** – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- c. **Forfeited accounts** – Forfeitures can be allocated to remaining plan participants or used to reduce future employer contributions. Forfeitures can be used to reduce employer contributions or to pay reasonable plan expenses to the extent specified in the adoption agreement. The forfeiture balances as of December 31, 2024 and 2023, were \$138 and \$132, respectively. Forfeitures of \$-0- and \$2,329 were allocated to remaining plan participants for the years ended December 31, 2024 and 2023, respectively.
- d. **Payments of benefits** – Benefits are recorded when paid.
- e. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.
- f. **Subsequent events** – The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Plan Trustee

As permitted by Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by Capital Bank not be subject to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedule. The following information has been certified by Capital Bank as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

Note 4 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 – Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Level 1 – The fair value of short-term funds and mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 – The Plan had no investments that are classified as Level 2 for the years ended December 31, 2024 or 2023.

Level 3 – The Plan had no investments that are classified as Level 3 for the years ended December 31, 2024 or 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-party and Party-in-interest Transactions

The Plan’s advisory committee consists of employees of the plan sponsor. There are no transactions between the parties other than contributions to the Plan, if eligible. Certain plan investments were managed by Capital Bank in 2024 and 2023. Capital Bank is the Plan’s investment advisor and trustee and, therefore, these transactions qualify as party-in-interest transactions.

Note 5 – Related-party and Party-in-interest Transactions (Continued)

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participant accounts become fully vested.

Note 7 – Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable determination letter from the IRS but has since been amended. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.
