## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### Note 1: Description of the Plan

The following description of the PKM Steel Service, Inc. Profit Sharing Retirement/401(k) Plan and Trust (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees of PKM Steel Service, Inc. (the Company). Employees are eligible to begin deferring contributions the beginning of the first calendar quarter after their hire date. Automatic enrollment (3%) also begins at that time for employees not yet enrolled in the Plan. Employees are eligible for company matching contributions beginning the calendar quarter after completing six months of service. Employees are eligible for any discretionary contributions after one year of employment and 1,000 hours of service in the Plan year. Age 21 must be attained to be eligible for any type of employee or employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Employee Contributions

Participating employees may elect to contribute a flat amount per payroll check or a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis or after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and one money market fund to Plan participants as core investment options or they can select mutual funds outside of the core funds.

#### Employer Contributions

The Company has the discretion to make a matching contribution at year end. The current matching contribution is equal to 100% of the participant deferral, up to \$3,000 annually. The employee is only match eligible if employed on the last day of the Plan year. Total Company contributions were \$132,004 and \$131,461, for the years December 31, 2024 and 2023, respectively.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company elected to not provide a discretionary contribution for 2024 or 2023. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

#### Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan provides vesting in the employer's profit sharing contributions of 20% after two years of service, 40% after three years of service 60% after four years of service, 80% after five years of service, and 100% after six years of service. The Plan provides vesting in the employer's matching contributions of 100% after three years of service. An employee who becomes disabled, dies, or reaches age 65 will become 100% vested in employer's contributions.

**Participant Loans**

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their cumulative employee deferrals (except for Roth deferrals) plus rollover contributions, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions no less frequently than on a quarterly basis. Generally, the loan term may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term. For the years ending December 31, 2024 and 2023 interest rates on outstanding loans were 5.25% to 10.5%, respectively.

For the year ended December 31, 2024, no loans were defaulted. For the year ended December 31, 2023, one loan for the amount of \$2,713 defaulted and was considered a distribution to the participant.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants accounts are charged directly to the participants' account. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, the participant may receive an automatic, lump-sum amount equal to the value of the participant's vested interest in his or her account if the balance is less than \$5,000. For an account balance greater than \$5,000, the participant must authorize the benefit payment distribution and then the value of the participant's vested interest is distributed as soon as administratively feasible. An in-service distribution may be made to a participant who has attained age 65.

**Forfeitures**

Forfeitures of company matching funds are first used to pay Plan expenses and can then be used to offset the employer match. Then forfeitures from profit sharing are reallocated to participants based on compensation. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$14,132 and \$3,594, respectively. Forfeitures were used to reduce fee expenses by \$3,300 and \$3,050 for the years ending December 31, 2024 and 2023, respectively. For the year ending December 31, 2024, \$10,000 of forfeitures were allocated to the participants. The forfeiture account balances at December 31, 2024 and 2023 were \$4,073 and \$2,948, respectively.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024, there were no pending distributions. As of December 31, 2023, the Plan had eight pending distributions totaling \$5,642.

**Investment Valuation and Income Recognition**

The Plan's investments are presented at fair value, as determined and certified by Alerus Financial N.A. (the Custodian) as of the Plan's year-end. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

**Participant Loans**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions upon a distributable event, as defined in the Plan document.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds and Exchange Traded Funds**

Valued at the daily closing price as reported by the fund. Mutual funds and Exchange traded funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds and exchange traded funds held by the Plan are deemed to be actively traded.

**Note 4: Related Parties and Parties in Interest**

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Certain Plan investments are shares of proprietary funds managed by the Custodian, Alerus Financial, N.A. Investment related expenses are included in the net appreciation of fair value of investments. These transactions qualify as exempt party-in-interest transactions.

Additional party-in-interest transactions include audit fees to Varney & Associates, CPAs, LLC and Keating & Associates for investment services and third party administration.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6: Tax Status**

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Reconciliation of Financial Statements to Form 5500**

The statements of net assets available for benefits and the statements of changes in net assets available for benefits reconciles to Schedule H of Form 5500 for the years ended December 31, 2024 and 2023.

**Note 9: Information Prepared and Certified by Custodian (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Plan investments were in the custody of the Custodian. These assets consist primarily of shares in various mutual funds.

**Note 10: Subsequent Events**

Management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued.

**Note 11: Reclassification of Cash and Cash Equivalents from Investments at Fair Value**

Certain cash balances previously reported within "Investments at fair value" have been reclassified to "Cash and Cash Equivalents" on the Statement of Net Assets Available for Benefits. This change was made to more accurately reflect their valuation at cost and to differentiate them from investments valued at fair market or other valuation methods. Prior year amounts have been reclassified to conform to the current year's presentation.
