Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of B. L. Harbert International, LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - PLAN DESCRIPTION

The following description of the B.L. Harbert International, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan provides retirement and other plan benefits to eligible employees of B.L. Harbert International, LLC and its wholly-owned subsidiaries ("Company" or "Employer"). The Plan was established effective July 1, 1992 and has since been amended and restated.

Eligibility: The Plan is open to Salaried (excluding Officers of the Company), Office Hourly, Field Hourly 1, and U.S. Contract employees, unless they are represented by a bargaining unit or are a nonresident alien with no U.S. income. Eligible employees may participate in the Plan on the first day of the month following completion of 30 days of service and attaining age 21.

Contributions: Contributions to the Plan may consist of participant elective deferral contributions, employer matching contributions, and rollover contributions. Participants may elect to contribute up to 100% of their eligible compensation, subject to certain Internal Revenue Code ("IRC") limitations as pre-tax contributions or after-tax Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect to participate in the Principal Step Ahead Retirement Option ("Step Ahead"). This allows participants to automatically increase their deferral elections on the first of each year by a designated percent for a designated period or to a maximum percent. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows for employer contributions in the form of matching contributions, qualified non-elective contributions, or discretionary contributions. Employer matching contributions shall equal a percentage of the employee deferral contributions. The percentage is determined by the employer each year. During the year ended December 31, 2024, the employer matched 50% of the participant deferral, not to exceed 6% of a participant's eligible compensation. These contributions are calculated and paid into the Plan every payroll date.

The Plan also allows the Company to make qualified non-elective contributions and discretionary contributions which are allocated to eligible participants' accounts based on their pro rata portion of total compensation. Participants must be active in the Plan on December 31 to be eligible for these contributions. There were no qualified non-elective nor discretionary contributions during the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings (losses), and (c) forfeitures of employer contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participant contributions, rollover contributions, and employer qualified non-elective contributions become fully vested upon receipt. Each participant's employer matching contributions become fully vested upon normal retirement, early retirement as defined by the Plan, disability, death, or upon completion of three years of service as a Plan participant. The employer's discretionary contribution becomes fully vested to participants on a three-year cliff vesting schedule.

Payment of Benefits: Upon termination of employment, a participant or the participant's designated beneficiary may elect various payment options. These options include, but are not limited to, a lump-sum distribution of vested benefits, fixed period installment payments, and rollover of vested benefits into another qualified plan. Participants with less than \$5,000 in vested benefits upon termination of employment are required to either take a lump-sum distribution or rollover of vested benefits into another qualified plan. In certain circumstances, participants may make hardship withdrawals, as defined by the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeitures: Participant forfeitures of unvested employer contributions are used to offset future employer matching contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, there were no unallocated forfeitures. The Plan used \$148,211 of forfeitures to offset employer contributions for the year ended December 31, 2024.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, as further discussed in Note 3. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair Value Measurements: Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trusts other than the Stable Value Fund: The fair values of participation units held in the collective trusts, other than the stable value fund, are based on the net asset values reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Stable Value Fund: The fair values of participation units in the stable value collective trust are based upon the net asset value of such fund, reflecting all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund. The fund invests in a variety of high quality stable value investment contracts, with a minimum weighted average credit quality rating of A or better, as well as cash and cash equivalents. The primary objective is to provide preservation of capital, relative stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments.

Withdrawals from the fund for benefit payments and participant transfers to noncompeting options to be paid to Plan participants shall be made within 30 days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the fund's trustee approval. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, are made one year after notification is received from the participating plan. However, the trustee of the fund reserves the right to grant a withdrawal earlier than that mentioned above if there are sufficient cash assets to satisfy the withdrawal and it is not detrimental to the best interest of the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the trustee of the Plan).

NOTE 5 – PARTIES-IN-INTEREST

Certain Plan investments are units of pooled separate accounts issued by Principal Life Insurance Company, an affiliate of Principal Trust Company, and collective trust funds managed by Principal Trust Company. Principal Trust Company is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan pays certain fees to the trustee associated with operating the Plan. The Plan uses CapTrust Financial Advisors as the investment advisor and Crowe LLP as the external auditor; therefore, investment advisory and audit fees paid by the plan qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated March 31, 2014 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
