Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

1. Description of Plan

The following description of Gifford Health Care, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Gifford Health Care, Inc. (GHC) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF) (the custodian) are the recordkeeper and custodian of the Plan.

Vesting

Participants are immediately vested in their voluntary contributions and GHC's discretionary matching and nonelective contributions plus earnings thereon.

Contributions

The Plan permits eligible employees through a salary deferral election to have GHC make annual contributions of up to the maximum allowed by the Internal Revenue Code (IRC). Employee rollovers are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service. Contributions are subject to certain limitations.

GHC makes matching contributions equal to 100% of participants' deferrals to the Plan excluding employee catch-up contributions, up to a maximum of 1% of compensation, calculated each pay period. Employees who normally work less than twenty hours a week are not eligible for the matching contribution. An employee must be over the age of 21 and complete one year of service to receive matching contributions.

GHC may make discretionary contributions which are determined annually and allocated to each participant on a prorated allocation basis or as an equal dollar amount for each participant. In order to receive the employer discretionary contributions, the participant must work more than 1,000 service hours during a plan year or be employed on the last plan day of the year, be over the age of 21, and complete one year of service. For 2024, GHC made a fixed contribution of 4% of each participant's plan compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. The Plan also includes an automatic deferral increase provision, which will automatically increase participant deferrals by 1% each year, not to exceed 10% of the participants' eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and GHC's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the excess, if any, of the highest total outstanding balance of all such notes for the one-year period ending on the day before the date the note is made, over the outstanding balance of loans from all such qualified employer plans on the date the note is made. The notes are secured by the balance in the participant's account. All notes are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of principal residence). The loan interest rate will be based on reasonable rates charged by persons in the business of lending money for loans under similar circumstances.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Payment of Benefits

On termination of employment due to death, disability, or retirement a participant may elect to receive a lump-sum amount, systematic withdrawals (installments) or an annuity equal to the vested value of their account. If the account balance is less than \$1,000, the entire vested account balance will be payable to the participant or their beneficiaries in a single lump sum payment. Balances greater than \$1,000 but less than \$5,000 are to be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$5,000 can remain in the Plan until such time the participant elects to receive a distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the nonbenefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by GHC or the Plan, at GHC's discretion.

Subsequent Events

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by Custodian

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by TIAA and CREF, the custodian, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Note 5 in the Notes to Financial Statements
- Schedule H, line 4i – Schedule of Assets (Held at End of Year)

4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing based on quoted prices for similar assets in active markets.

All of the Plan's investments, at fair value, are held in mutual funds and are Level 1 investments with fair values of \$66,320,747 and \$57,314,356 as of December 31, 2024 and 2023, respectively.

5. Guaranteed Annuity Accounts

Investments in the TIAA Traditional Annuity and TIAA Stable Value are in guaranteed annuity accounts. Contributions to these investments buy contractual or guaranteed amounts of future benefits for the participant. Interest credited to the investments includes a guaranteed rate plus additional amounts established on a year-by-year basis. The contracts are included in the financial statements at contract value as reported to the Plan by the custodian. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

The investments provide for nonbenefit-responsive contracts. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The nonbenefit-responsive contracts do not allow for lump sum withdrawals. In addition, participant initiated transfers may only be made in ten annual installments. Due to these liquidity restrictions, the contracts are non-benefit responsive.

6. Party-in-Interest Transactions

Certain Plan investments are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions. The administration fees paid by the Plan for 2024 were \$48,982 and qualify as party-in-interest transactions as they are related to recordkeeper and custodian fees incurred by the Plan.

The plan sponsor pays certain accounting and auditing fees relating to the Plan and provides certain administrative services at no cost to the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, GHC has the right under the Plan to no longer allow contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. Income Tax Status

The Company has adopted the TIAA Volume Submitter 403(b) Plan, which received a favorable advisory letter dated August 7, 2017, from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the the IRC. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.
