Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Trachte, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter-Plan Merger

As discussed in Note 7 to the financial statements, pursuant to the sale transaction between the Plan Sponsor and nVent Electric PLC, the Plan was merged into nVent Management Company Retirement Savings and Investment Plan effective December 31, 2024. All plan assets were transferred to the nVent Management Company Retirement Savings and Investment Plan on January 16, 2025. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The following description of Trachte, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Trachte, LLC and Trachte Southeast, LLC (the Company). Employees over the age of 18 who have completed 60 days of continuous employment are eligible to participate in the Plan. Leased employees are not eligible to participate in the Plan. The Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute up to the maximum allowed by current Internal Revenue Service (IRS) guidelines for approved plans. In addition, participants age 50 or over are eligible to make catch-up contributions. Roth elective deferrals are permitted under the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 4% of eligible compensation with annual increases of 1% up to a maximum of 8%. The automatic deferral is a pretax 401(k) deferral.

The Company may make discretionary matching contributions and nonelective discretionary contributions. For 2024, the discretionary matching contribution was 50% of the first 6% of compensation contributed by the employee. A nonelective discretionary contribution was not made in 2024 or 2023.

Participant accounts: Each participant's account is credited with (a) the participant's contributions, (b) rollover contributions, (c) the Company's matching contribution, (d) the Company's nonelective contribution and (e) an allocation of the Plan's investment earnings and losses. Each participant's account is charged with an allocation of (a) administrative expenses, (b) Plan investment losses and (c) any distributions requested by the individual participant. Allocations are based on the participant's eligible compensation, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Participants who leave the Plan because of death, normal retirement, or disability, as defined in the Plan, are considered 100% vested in their account balance related to Company contributions. If a participant terminates employment for any other reason other than the aforementioned, his or her discretionary Company contribution balance vests in accordance with provisions of the Plan as follows:

Investment options: Upon enrollment in the Plan, a participant may direct their contributions in their accounts in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Payment of benefits: Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. Vested account balances less than \$5,000 are distributed in a lump-sum payment as soon as administratively feasible following termination of employment. Vested account balances greater than \$5,000 may be distributed in a single lump sum, ad hoc distributions or as installment distributions.

Upon a participant's death, the participant's beneficiary will be paid the balance of the account through a lump-sum payment or ad hoc distributions sufficient to satisfy the required minimum distribution.

In-service distributions are available to all participants who have reached age 59½ and are still employed by the Company. In-service distributions can be all or a portion of the participants' vested account balance. Participants experiencing financial hardship may withdraw a portion or all of the vested balance of their account.

Forfeited accounts: Forfeitures of nonvested participant balances may be used to reduce Company matching and nonelective discretionary contributions or to pay Plan expenses, as stated in the Plan document. As of December 31, 2024 and 2023, unallocated forfeited balances were approximately \$3,300 and \$21,800, respectively. In 2024, \$69,652 of forfeitures were used to reduce Company contributions.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms can range from one to five years, or up to 15 years for the purchase of a primary residence. Each participant can have one loan outstanding from the Plan at a time. The loans are collateralized by the participant's vested benefits and bear interest at prime plus 1%. Distributions from the Plan will be reduced by the amount of outstanding loans, if any. Principal and interest are paid ratably in at least quarterly payments through payroll deductions or an automated clearing house (ACH) agreement.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan investments are stated at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by an investment advisor and a trustee. See Note 4 for further discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation/appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan documents.

Payment of benefits: Benefits paid to participants are recorded when paid.

Administrative expenses: Administrative expenses are paid by the Plan, as provided in the Plan document, and by the Company. Administrative expenses paid by the Plan for the year ended December 31, 2024, were approximately \$72,000.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is earned.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Empower Trust Company, LLC, the Plan Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements that was prepared by or derived from information provided by Empower Trust Company, LLC, the trustee, and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies (RICs) are valued at the daily closing price as reported by the fund. RICs held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

Units of collective investment trusts: Collective investment trusts are valued based on the NAV of units of the collective investment trust. The NAV, as provided by the trustee, is issued as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5. Related-Party and Party-In-Interest Transactions

Empower Trust Company, LLC (Empower) performs administrative and record-keeping services for the Plan. Empower is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower were approximately \$40,000 for the year ended December 31, 2024.

Note 5. Related-Party and Party-In-Interest Transactions (Continued)

The Plan has arrangements with service providers to provide investment advisory and investment management services. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan to the investment advisor were approximately \$22,000 for the year ended December 31, 2024.

The Plan has arrangements with service providers to provide contract administrative services. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan to the service providers for contract administrative services were approximately \$13,000 for the year ended December 31, 2024.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays outside administrative expenses of the Plan, which are excluded from these financial statements.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Plan Merger

Pursuant to the sale transaction between the Plan Sponsor and nVent Electric PLC, the Plan merged into nVent Management Company Retirement Savings and Investment Plan effective December 31, 2024. All plan assets were transferred to nVent Management Company Retirement Savings and Investment Plan on January 16, 2025.

Note 8. Tax Status

The Plan has adopted a preapproved plan document that has been received as an opinion letter from the IRS dated June 30, 2020, stating that the form of preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that is more likely than not to occur upon examination by the IRS. Management evaluated the Plan's tax positions and concluded that no uncertain tax positions exist. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any period in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
