Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Total Military Management, Inc. Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report.

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

Notes to Financial Statements

1. Description of Plan:

The following is a brief description of the Total Military Management, Inc. Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 2010, is a defined contribution plan covering all employees of Total Military Management, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”).

Eligibility

Employees who have completed one year of service and 1,000 hours and are age twenty-one (21) or older are eligible to participate in the Plan, except leased employees. Eligible employees may enroll on the first day of January or July following the date the employee satisfies the Plan’s eligibility requirements.

Contributions

Each year participants may elect to contribute up to 100% of their eligible compensation, subject to the maximum of their pretax annual compensation as determined by the Internal Revenue Service (“IRS”) and as defined by the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

If the participant makes eligible contributions during the year, the Company will contribute a safe harbor matching contribution amount equal to 100% of the eligible contributions not in excess of 3% of the participant’s compensation, plus 50% of the amount of the eligible contributions that exceed 3% of the participant’s compensation not to exceed 5% of that compensation. The Company may also make non-elective discretionary contributions to the Plan. The Company did not contribute any non-elective discretionary contributions for the Plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, the Company’s non-elective discretionary contribution, if any, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan offers a selection of pooled separate accounts and a guaranteed investment contract as investment options for participants.

1. Description of Plan (Continued):

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. Participants may have a maximum of 2 outstanding loans at a time. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time up to 15 years. The loans bear interest at the prime rate as published by the Wall Street Journal plus one percentage point.

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. The Plan generally pays expenses associated with the administration of the Plan, except for certain distribution fees, and loan fees which are deducted directly from the applicable participant's account.

Management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Vesting

Participants are vested immediately in their contributions and the Company safe harbor contributions required to satisfy compliance requirements plus actual earnings thereon. Vesting in the Company's non-elective discretionary contributions, and related earnings is based on years of continuous service with 1,000 hours for a year of crediting service. Once the participant completes two years of service, he or she becomes 20% vested. Participants then earn 20% per year thereafter and are 100% vested after 6 years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. Participants may elect to receive an in-service distribution from the participant's rollover source account balance at any time.

Account balances that are under \$1,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Forfeited Accounts

Forfeitures of non-vested participant balances are generally used to pay Plan expenses and reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$30,333 and \$28,205, respectively. The Plan used forfeited nonvested accounts totaling \$18,205 to reduce employer contributions during the Plan year 2024.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for fully benefit-responsive contracts.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as a distribution to the participant based upon the terms of the Plan document. The loans are secured by the balance in the participants’ accounts.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

Financial Accounting Standards Board Statement of Accounting Standards Codification Topic 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

The following table sets forth by level within the fair value hierarchy the Plan investment assets at fair value as of December 31, 2024 and 2023:

(a) In accordance with ASC 820, investments that were measured at net asset value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line item, Investments at fair value, in the Statements of Net Assets Available for Benefits.

4. Fully Benefit-Responsive Guaranteed Investment Contract:

The Plan offers the option to invest in a guaranteed annuity contract with Voya who maintains the contributions in a general account. The guaranteed investment contract is fully benefit-responsive, and as such contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value of the guaranteed investment contract was \$328,750 and \$294,772 at December 31, 2024 and 2023, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed minimum interest rate credited to the contract is not less than 1%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

4. Fully Benefit-Responsive Guaranteed Investment Contract (Continued):

Certain events might limit the ability of the Plan to transact at contract value with Voya. These events may be different under each contract. Examples of such events include the following: 1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC, 2) premature termination of the contract, 3) plan termination or merger, 4) changes to the Plan's prohibition on competing investment options, and 5) bankruptcy of the Bank or other events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events may include the following: 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, and 4) an amendment to the agreement without the consent of Voya.

5. Information Certified by the Plan's Custodian:

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the interest and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, custodian of the Plan, in accordance with 29 CFR 2520.103-5(c) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

6. Party-in-Interest Transactions:

Certain Plan investments are in holdings managed by Voya Retirement Insurance and Annuity Company, the custodian of the Plan's assets and recordkeeper. Accordingly, transactions with Voya qualify as party-in transactions permitted under provisions of ERISA. Fees paid to Voya by the Plan for administrative expenses amounted to \$7,028 for the year ended December 31, 2024.

Economic Group Pension Services ("EGPS") is the recordkeeper for the Plan, therefore transactions involving RSS qualify as party-in-interest transactions permitted under provisions of ERISA. Fees paid to EGPS by the Plan for recordkeeper services amounted to \$5,488 for the year ended December 31, 2024.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$191,141 and \$130,304, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$11,278. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

7. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

8. Tax Status:

The Plan obtained a determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for years before 2021.

9. Non-Exempt Transactions:

The Company determined that during the 2022 Plan year, it failed to remit certain employee deferrals to the Plan. The failed remittances were \$2,127 in aggregate and are pending remittance and corrections of lost earnings. Late or delinquent deferrals and loan repayments constitute prohibited transactions as defined by ERISA and are included in the accompanying Schedule H, Line 4a – Schedule of Delinquent Participant Contributions.

10. Subsequent Events:

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be filed, and has determined, that there were no material events requiring recognition or disclosure
